### Strategic Intent:

1. Support ongoing large fires, maintain IA capability across the geographic area, and reallocate resources as needed to backfill behind those resources timing out on long duration incidents.

2	Dollar Lake	OR MHF	Pendleton	Bull Run Watershed and private lands threat
3	Monastery Complex	WA SES	LaFave	Highway 97 still impacted; structure protection and evacuations still in place
4	Skookum Complex	OR UPF	Walker	Mixed ownership; multiple fires in rugged terrain
5	Cactus Mountain	OR WWF	West	Limited access and rugged terrain; fuel & terrain make control objectives difficult; high recreation use area
6	Shadow Lake	OR DEF	Bennett	Active fire behavior; high public exposure along Hwy 126
7	High Cascades Complex	OR WSA	Goff	Tribal timber assets still a concern
8	Chicken Hill	OR WWF	Reed	Heavy mop up
9	Big Hump	WA OLF	Johnson	Wilderness fire within its strategic plan
10	Mother Lode	OR MHF	Suwyn	Wilderness fire with strategic plan being developed
11	Lone Mountain	OR RSF	Fillis	Containment at EOS today
