3	Snag Canyon	WA-SES	B. Johnson	Level II and III evacuations in place; major power lines threatened
4	Duncan (Chiwaukum)	WA-NES	M. Dueitt	Level II evacuations; active fire behavior; critical burn out mission
5	Hansel (Chiwaukum Complex)	WA-NES	M. Dueitt	Level II and III evacuation; active fire behavior
6	Little Bridge Creek	WA-OWF	D. Leitch	Level I evacuations; structure protection; pursuing indirect strategy
7	Upper Falls (Carlton)	WA-NES	P. Blume	Level I evacuations; active fire behavior; multiple suppression strategies
8	South Fork Complex	OR-PRD	B. Watts	Level I evacuations around entire fire; active fire behavior
9	5 Mile	OR-974S	D. Johnson	Level I evacuations; major power transmission lines; active fire behavior on Somers fire
