### Strategic Intent:

- Prioritize incidents based on Firefighter/Public Safety and Threats to Communities and Infrastructure, as well as considering Cultural and Natural Resource value, and Ability to Meet Incident Objectives.**
- Maintain a Theater of Operations concept to enhance response time and capability to initial attack, emerging and established larger fires.**

### PNW Incident Priorities (*set once per day*):

1	Initial Attack			Initial Attack always first priority.
2	Canyon Creek Complex	OR-MAF	B. Lund	Level 2 and 3 evacuations in place; Fire active on east flank; OSFM in place.
3	Carpenter Road	WA-NES	J. Esperance	Level 2 and 3 evacuations in place;
4	North Star	WA-COA	E. Lewis	Level 2 and 3 evacuations in place; Highway 21 remains closed; Structure protection along Highway 21; Highway 155 has a partial closure.
5	Tunk Block	WA-NES	E. Lewis	Level 3 evacuations in place and evaluating; Highways 20 and 155 are closed to public; Structure protection in place.
6	Kettle Complex	WA-COF	C. Schulte	Level 1 and 2 evacuations in place.
7	Wolverine	WA-OWF	C. Templin	Level 1 and 2 evacuations in effect; Minimal fire growth; Improving indirect and direct line.

13	First Creek	WA-OWF	C. Templin	Level 1 evacuations in place; Heavy mop-up.
14	County Line 2	OR-WSA	S. Sheldon	Level 1 evacuations in place; Mopping up in all divisions; TOC back to local unit on 9/3.
