5	Whitewater	OR-WIF	E. Knerr	Impacts to timber sales; trail and area closure in effect. Potential for westward fire spread. Planning transition to Type 1 IMT. Anticipating impacts from the public due to Eclipse event.
6	Spruce Lake	OR-CLP	B. Gales	Level 1 evacuation notice for Crater Lake Park. Impact to park resources.
7	Bear Butte	OR-WWF	B. Goff	Level 1 evacuation notice still in place. Plumbing line and mop-up continues.
