Strategic Intent:

- 1. Maintain the investments made on long-term incidents when the reallocation of resources occurs.
- 2. Coordinate initial attack between incidents and units, maximizing lend-lease and the sharing of resources.
- 3. Manage IMTs to effectively respond to complex fires across the Geographic Area by:
 - a. Utilizing surge resources for critical missions that maximize opportunities to safely meet incident objectives.
 - b. Planning and making deliberate decisions on limited replacement or reallocation of shared resources from NMAC.
