**PNW Incident Priorities (*set daily*):**

<u>Priority</u>	<u>Fire</u>	<u>Unit</u>	<u>IC</u>	<u>Rationale</u>
1	Initial Attack			Initial attack is always the first priority.
2	Riverside	OR-MHF	Sinclair	30,000 at level 3. 100,000 at level 2. Current focus is populated areas. Constructing line near Estacada.
3	Beachie Creek	OR-WIF	Gales	Damage assessment. Expanding anchor points. Making progress on direct line westside.
4	S. Obenchain	OR-711S	Johnson	Level 2 and 3 evacuations. Point protection east and northeast on fire spread, predicted wind event.
5	Archie Creek	OR-UPF	Goff	Level 2 and 3 for Glide and Idleyld Park. Focus is structure protection south and north flanks.
6	Holiday Farm	OR-WIF	Smith	Establishing multiple anchor points on east and west sides. Mopping up around structures.
7	Lionshead	OR-WSA	Livingston	Active fire spread northeast corner. Still actively engaged in structure protection northeast flank.
8	Brattain	OR-FWF	-	IMT mobilizing, awaiting IPW.
9	Inchelium Complex	WA-COA	Knerr	Fire spread on the northeast flank. Focus on Kewa Field.

10	Two Four Two	OR-FWF	Hunt	Continued progress on holding line. Prepping for predicted weather event.
11	Thielsen	OR-UPF	-	IMT mobilizing, awaiting IPW.
12	Echo Mountain	OR-553S	Dolan	Level 2 and 3 evacuations. Perimeter containment almost complete, moving towards mop-up.
13	Big Hollow	WA-GPF	Dimke	Southern fire movement into Wind River drainage.
14	Whitney/Babb/Manning	WA-NES/ WA-WFS	Lawson	Making good progress on all fires.
15	Almeda Drive	OR-711S	Magers	Reducing evacuation levels. Transitioning to mop-up.
16	Apple Acres/ Pearl Hill	WA-SES/ WA-WFS	Sheldon	Mop-up and patrol. Downsizing as appropriate. TOC to local unit 9/15.
17	White River	OR-MHF	Livingston	Patrol Status. TOC to local unit 9/14.
