- Work with IMTs to adjust strategy and tactics to align with existing resources and the likelihood of few additional resources coming into the Geographic Area.

<b>Priority</b>	<u>Fire</u>	<u>Unit</u>	<u>IC</u>	Rationale
1	Initial Attack			Initial attack is always the first priority.
2	Cedar Creek/Delancy/ Cub Creek 2	WA-OWF	Stock	Level 1, 2, and 3 evacuations (more structures added). Fire growth east into Methow Valley.
3	Bootleg/Log	OR-FWF	Allen/ Hessel	Level 1, 2, and 3 evacuations. Log and Bootleg merged. Significant growth N, NE.
4	Summit Trail	WA-COA	Dalrymple	Level 1 evacuations. High value timber threatened. Important cultural sites threatened.
5	Elbow Creek	OR-UMF	Smith	Level 3 evacuations. Movement is primarily SW in high value timber.
6	Chuweah Creek Fire	WA-COA	Dimke	Level 1, 2 and 3 evacuations. Fire is backing down toward Highway 21. Drone intrusion in TFR.
7	Jack Fire	OR-UPF	Goff	Level 1 evacuations. Highway 138 safety concerns (speed). Critical area on SE flank.
8	Lick Creek/ Green Ridge	OR-UMF	Johnson	Level 1 and 2 evacuations. Combined TFRs for Lick Creek and Green Ridge.
