PNW Incident Priorities (set daily):

Priority	<u>Fire</u>	<u>Unit</u>	<u>IC</u>	Rationale
1	Initial Attack			Initial attack is always the first priority.
2	Cedar Creek/Delancy	WA-OWF	Kuo	Level 1, 2 and 3 evacuations. Critical firing operations in SE corner to contain movement toward Winthrop.
3	Cub Creek 2	WA-NES	McGowan	Level 1, 2 and 3 evacuations. Critical area in Pebble and Boulder Creek to secure eastern flank.
4	Sherwood	WA-SPA	Sheldon	Level 2 and 3 evacuations (re-evaluating to potentially lower). Working critical areas on south flank.
5	Summit Trail	WA-COA	Dalrymple	Level 1 evacuations. Important cultural sites threatened. Significant growth to the north. Working critical area in Beaver Dam drainage.
6	Bootleg	OR-FWF	McDonald	Level 2 and 3 evacuations (reduction in number of structures). Working on control lines in NW corner and N flank. Strengthening lines on NE flank.
7	Lick Creek/Green Ridge	OR-UMF	Nobles	Level 1 evacuations. Firing operations continue to hold control line on west flank. Reached MAP for utilizing north flank indirect containment strategies.
8	Jack Fire	OR-UPF	Lawson	Level 1 evacuations. Firing operations in SE corner continue to hold control lines. Scouting options for direct control lines continue.
