- Keep existing incidents staffed by replacing timed out resources as needed.
- Allocate critical resources to augment crucial missions and expedite incident objectives.

<u>Priority</u>	<u>Fire</u>	<u>Unit</u>	<u>IC</u>	Rationale
1	Initial Attack			Initial attack is always the first priority.
2	Whitmore	WA-COA	Schindelar	Level 2 evacuations. Area closures.
3	Devils Knob Complex	OR-UPF	Stock	Level 1, 2, and 3 evacuations. Transitioning small fires to mop-up and patrol. Focus is Big Hamlin cluster.
4	Walker Creek	WA-NES	Winfield	Level 2 and 3 evacuations. Direct and indirect line construction. Area closures. Primary incident is Spur fire.
5	Middle Fork Complex	OR-WIF	Johnson	Level 1 and 3 evacuations. Kwis is the priority fire.
6	Summit Trail/ Chuweah Creek	WA-COA	Loomis	Level 1 and 2 evacuations. NW Team 10 (Lawson) in-brief today at 1830.
7	Rough Patch Complex/Jack Fire	OR-UPF	Gales	Direct and indirect line construction continues. 25 incidents contained.

8	Skyline Ridge Complex	OR-732S	Hessel	Level 1 evacuations. No growth on any fires, except Poole Creek. 9 of 19 incidents in patrol status
9	Schneider Springs/Windy Pass	WA-OWF	L. Minton	Level 2 evacuations. Area closures. Assume command of Windy Pass.
10	Cub Creek 2	WA-NES	Bales	Level 1 and 3 evacuations (Muckamuck). Direct line construction on Muckamuck Fire. Shadow 8/12 CA Team 2 (M. Minton).
11	Black Butte	OR-MAF	Goff	Area closure, no evacuations levels.
12	Lick Creek/ Green Ridge	OR-UMF	Hagan	Level 1, 2, and 3 evacuations. Building and securing line.
13	Cedar Creek/ Delancy	WA-OWF	Kuo	Level 1 and 2 evacuations. Shadow 8/12 CA Team 2 (M. Minton).
14	Bootleg	OR-FWF	Allen	Heavy demob.
