5	Middle Fork Complex	OR-WIF	Johnson	Level 1, 2, and 3 evacuations. Kwis priority fire.
6	Skyline Ridge Complex	OR-732S	Hessel	Level 1 evacuations. Focus is Poole fire. Making good progress. 16 of 19 fires contained.
7	Cub Creek 2/ Muckamuck/ Cedar Creek/Delancy	WA-NES	M. Minton	Level 1, 2, and 3 evacuations. Muckamuck priority fire.

12	Rough Patch Complex/Jack	OR-UPF	Gales	Direct and indirect line construction continues. TOC 8/15 to Great Basin Team 2 (DeMasters).
13	Black Butte	OR-MAF	Goff	No evacuation levels. Support from local RFPA. Continuing to make good progress. TOC 8/15 to NW Team 6 (Sheldon).
