- Allocate critical resources to augment crucial mission requests, while providing incident staffing requirements for resources . timing out on all large fires.
- Message and encourage the word about active fatigue management. •

PNW Incident Priorities (*set daily*):

<u>Priority</u>	<u>Fire</u>	<u>Unit</u>	IC	Rationale
1	Initial Attack			Initial attack is always the first priority.
2	Cougar Peak	OR-FWF	Stock	Level 1, 2, and 3 evacuations. Direct line construction where conditions and topography allow.
3	Devils Knob Complex	OR-UPF	Dallas	Level 2 evacuations. Securing spots on north end of Smith fire
4	Rough Patch Complex/Jack Fire	OR-UPF	DeMasters	Continue to work slop-over on north end of Chaos.
5	Middle Fork Complex	OR-WIF	Sheldon	Level 2 evacuations. Mop-up and securing lines.
6	Schneider Springs	WA-OWF	Lawson	Level 1, 2, and 3 evacuations. Direct and indirect line construction on north flank.
7	Twentyfive Mile	WA-OWF	Johnson	Level 1 evacuations. Securing line and continue firing operations where conditions allow.
