Strategic Intent

- Provide support to Initial Attack and emerging incidents.
- Allocate critical resources to augment crucial mission requests, while providing incident staffing requirements for resources timing out on all large fires.
- Message and encourage the word about active fatigue management.

PNW Incident Priorities (*set daily*):

<u>Priority</u>	<u>Fire</u>	<u>Unit</u>	<u>IC</u>	Rationale
1	Initial Attack			Initial attack is always the first priority.
2	Cougar Peak	OR-FWF	Stock	Level 1, 2, and 3 evacuations. Focus is southwest flank.
3	Schneider Springs	WA-OWF	Lawson	Level 1 and 2 evacuations. Direct and indirect line construction on north flank.
4	Devils Knob Complex	OR-UPF	Dallas	Level 2 evacuations. Securing spots on north end of Smith fire.
5	Middle Fork Complex	OR-WIF	Sheldon	Level 2 evacuations. Mop-up and securing lines.
6	Rough Patch Complex/Jack Fire	OR-UPF	DeMasters	Continue to work slop-over on north end of Chaos.
7	Bull Complex	OR-MHF	Connell	Continuing to work indirect control lines.

9	Summit Trail	WA-COA	Schwope	TOC 9/15/2021 at 0700 to IMT3.
