Strategic Intent:

- Continue to support IA/emerging incidents and new IMT deployments.
- Keep existing incidents staffed by replacing timed out resources as needed.
- Allocate critical resources to augment crucial missions and expedite incident objectives.

| 1 | Initial Attack | | | Initial attack is always the first priority. |
| 2 | Cedar Creek | OR-WIF | Sheldon / McDonald | Level 1, 2, and 3 evacuations in place. Firing operations on west flank. Prepping to protect values along 46 road. West zone TOC at 0600 to PNW3 on 9/13. |
| 3 | Double Creek/ Sturgill/Nebo/Goat Mountain Two | OR-WWF | Loomis | Level 1, 2, and 3 evacuations in place. Continue to support spot fire west of Imnaha River. |
| 4 | Bolt Creek | WA-NWS | Stock | Level 3 evacuations in place. NW Team 8 shadowing today. Limited information received. |
| 5 | Goat Rocks | WA-GPF | Lawson | Level 1 and 2 evacuations in place. Working around structures. NW Team 10 assumed command. |
| 6 | Boulder Mountain | WA-NES | Johnston | Level 1 evacuations in place. Working to secure west flank around communication site. |
| 7 | Rum Creek | OR-MED | Winfield | Level 1, 2, and 3 evacuations in place. Lines holding, containment increasing. |
| 8 | Van Meter | OR-LAD | McCarty | All evacuation levels removed. Mopping up and securing lines. |
