Strategic Intent:

- Continue to support IA/emerging incidents and new IMT deployments.
- Keep existing incidents staffed by replacing timed out resources as needed.
- Allocate critical resources to augment crucial missions and expedite incident objectives.
- Coordinate with incidents to allocate resources between zones within the Incident Priority ranking.

PNW Incident Priorities (set daily):

Priority	<u>Fire</u>	<u>Unit</u>	<u>IC</u>	Rationale
1	Initial Attack			Initial attack is always the first priority.
2	Cedar Creek	OR-WIF	Johnson / McDonald	Level 1 and 2 evacuations in place. Firing operations as conditions allow. Prepping to protect values along 46 road.
3	Double Creek/ Sturgill/Nebo/Goat Mountain Two	OR-WWF	Loomis	Level 1, 2, and 3 evacuations in place. Constructing control lines on north and south flanks. TOC to IMT1 on 9/17.
4	Bolt Creek	WA-NWS	Stock	Level 3 evacuations in place. Prepping control lines on east and west flanks.
5	Goat Rocks	WA-GPF	Lawson	Level 1 and 2 evacuations in place. Prepping indirect lines. No opportunities for direct line.
6	Boulder Mountain	WA-NES	Johnston	Working to secure southwest flank. TOC to NW Team 13 on 9/18.
7	Rum Creek	OR-MED	Winfield	Patrol and suppression repair.
8	Chilliwack/NW Pasayten	WA-NCP/ WA-OWF	Watts	Developing long-term strategies. Point protection in progress. Planning transition to local units on 9/19.
