4	4

Strategic Intent:

- Continue to support IA/emerging incidents and new IMT deployments.
- Keep existing incidents staffed by replacing timed out resources as needed.
- Allocate critical resources to augment crucial missions and expedite incident objectives.
- Coordinate with incidents to allocate resources between zones within the Incident Priority ranking.

PNW Incident Priorities (*set daily*):

<u>Priority</u>	<u>Fire</u>	<u>Unit</u>	<u>IC</u>	<u>Rationale</u>
1	Initial Attack			Initial attack is always the first priority.
2	Cedar Creek	OR-WIF	Johnson / McDonald	Level 1 and 2 evacuations in place. Firing operations as conditions allow. Coordinating resource needs between zones. OSFM last shift today.
3	Double Creek/ Sturgill/Nebo/Goat Mountain Two	OR-WWF	Loomis	Mop and secure west flank. Monitoring wilderness fires by air. TOC to IMT1 on 9/17.
4	Bolt Creek	WA-NWS	Stock	Level 3 evacuations in place. Prepping control lines on east and west flanks.
5	Goat Rocks	WA-GPF	Lawson	Level 1 and 2 evacuations in place. Prepping indirect lines.
6	Boulder Mountain	WA-NES	Johnston	Suppression repair and mop-up. TOC to NW Team 13 on 9/18.
7	Rum Creek	OR-MED	Winfield	Patrol and suppression repair. TOC to local unit on 9/19.
