## **Strategic Intent:**

- Continue to support initial attack, emerging incidents, and new IMT deployments.
- Utilize surge resources for critical missions that maximizes opportunities to safely meet incident objectives and to augment local unit initial attack resources where needed.
- Keep existing incidents adequately staffed by replacing timed out resources as needed.

## **PNW Incident Priorities (set daily):**

<b>Priority</b>	<u>Fire</u>	<u>Unit</u>	<u>IC</u>	Rationale
1	Initial Attack			Initial attack is always the first priority.
2	Lookout	OR-WIF	Albrecht	Level 1, 2, and 3 evacuations. Portion of Highway 242 closed, potential closure of Highway 126. TOC to PNW2 at 1800 today.
3	Oregon Road	WA-NES	Lewis	Level 1 and 2 evacuations. Structure assessments completed. Limited demobilization continues.
4	Bedrock	OR-WIF	Loomis	Level 1 and 2 evacuations; one property in Level 3. Mop-up and secure north, east, and south flanks. Assisted with five initial attack fires.
5	Gray	WA-NES	LeFevre	Level 1 and 2 evacuations. All state mobilization resources have been released. Secure and mop-up around structures and I-90 corridor.
6	Sourdough	WA-NCP	Stock	Suppression objectives have been met. Tentative TOC to local unit on 8/29 at 1800.
