Strategic Intent:

- Continue to support initial attack, emerging incidents, and new IMT deployments.
- Utilize surge resources for critical missions that maximizes opportunities to safely meet incident objectives and to augment local unit initial attack resources where needed.
- Keep existing incidents adequately staffed by replacing timed out resources as needed.

PNW Incident Priorities (set daily):

Priority	<u>Fire</u>	<u>Unit</u>	<u>IC</u>	Rationale
1	Initial Attack			Initial attack is always the first priority.
2	Tyee Ridge Complex	OR-730S	Hessel	Level 2 and 3 evacuations. Unified command with OSFM. Supporting 19 fires. Significant number of dispersed residences.
3	Camp Creek	OR-MHF	Kuo	Bull Run Municipal watershed. Protecting infrastructure for the watershed.
4	Lookout	OR-WIF	Loomis	Level 1, 2, and 3 evacuations. Portion of Highway 242 closed. Incorporating Horse Creek incident as a division. Supporting four additional IA incidents.
5	Oregon Road	WA-NES	Lewis	Level 1 and 2 evacuations. Structure assessments completed. Limited demobilization continues.
6	Gray	WA-NES	LeFevre	Level 1 and 2 evacuations. Three WA State Taskforces remain. Secure and mop-up around structures and I-90 corridor.

8	Sourdough	WA-NCP	Stock	Suppression objectives have been met. Tentative TOC to local unit on 8/29 at 1800.
9	Flat	OR-RSF	Elmore	Minimal fire behavior. Providing support to multiple initial attack incidents. Tentative TOC to CIMT on 8/30.
