### Strategic Intent:

- Continue to support initial attack, emerging incidents, and new IMT deployments.
- Utilize surge resources for critical missions that maximizes opportunities to safely meet incident objectives and to augment local unit initial attack resources where needed.
- Keep existing incidents adequately staffed by replacing timed out resources as needed.

### PNW Incident Priorities (set daily):

<u>Priority</u>	<u>Fire</u>	<u>Unit</u>	<u>IC</u>	<u>Rationale</u>
1	Initial Attack			Initial attack is always the first priority.
2	Tyee Ridge Complex	OR-730S	Hessel	Level 1, 2, and 3 evacuations. Unified command with OSFM. Supporting 11 fires, 8 are 20 acres or less. Significant number of dispersed residences.
3	Camp Creek	OR-MHF	Kuo	Bull Run municipal watershed. Protecting infrastructure for the watershed.
4	Lookout	OR-WIF	Loomis	Level 1, 2, and 3 evacuations. Portion of Highway 242 closed. Incorporating Horse Creek incident as a division. Supporting Pothole.
5	Chilcoot	OR-UPF	Aragon	Incident includes Ridge Fire. Area closures in place, securing Chilcoot repeater, establishing anchor points.
6	Gray	WA-NES	LeFevre	Level 1 and 2 evacuations. Three WA State Taskforces remain. Secure and mop-up around structures and I-90 corridor.

7	Oregon Road	WA-NES	Lewis	Level 1 evacuations. Structure assessments completed. High interest from local community. TOC to local T3 organization 8/30 at 0600.
8	Bedrock	OR-WIF	Loomis	Level 1 and 2 evacuations. Mop-up, patrol, and repair.
9	Flat	OR-RSF	Elmore	Minimal fire behavior. Incident includes Anvil Fire.
10	Sourdough	WA-NCP	Stock	Suppression objectives have been met. TOC to local unit on 8/29 at 1800.
