Strategic Intent:

- Continue to support initial attack, emerging incidents, and new IMT deployments.
- Prioritize critical missions that maximize opportunities to safely meet incident objectives and to augment local unit initial attack resources where needed.
- Keep existing incidents adequately staffed by replacing timed out resources as needed.

PNW Incident Priorities (set daily):

<u>Priority</u>	<u>Fire</u>	<u>Unit</u>	<u>IC</u>	Rationale
1	Initial Attack			Initial attack is always the first priority.
2	Camp Creek	OR-MHF	Kuo	Protecting resources and infrastructure within the Bull Run municipal watershed.
3	Tyee Ridge Complex	OR-730S	Hessel	Level 1 and 2 evacuations. Continued firing operations on Cougar.
4	Lookout	OR-WIF	DeMasters	Level 1, 2, and 3 evacuations. Portion of Highway 242 closed. Includes Horse Creek and Pothole.
5	Chilcoot	OR-UPF	Dimke	Area closures in place. Incident includes Ridge.
6	Cowlitz Complex	WA-GPF	Hohn	ISAP for Grassy Mountain, Spencer Quartz and Snag Tooth, full suppression on remaining fires.

7	Dinner	OR-UPF	Dimke	Level 2 evacuations on Grizzly (Bohemia mining area). Area closures in effect. Includes Brice Creek and Grizzly.
8	Flat	OR-RSF	Behrens	Level 1 and 2 evacuations. Planning direct strategies on portions of Anvil. BAER efforts have begun.
9	Bedrock	OR-WIF	DeMasters	Level 1 evacuations. Mop-up, patrol, and repair.
10	Petes Lake	OR-WIF	Lawson	Area closures including the Pacific Crest Trail. Implementing point protection and confinement strategy. TOC to IMT3 on Friday 9/8.
