Strategic Intent:

- Continue to support initial attack, emerging incidents, and new IMT deployments.
- Prioritize critical missions that maximize opportunities to safely meet incident objectives and to augment local unit initial attack resources where needed.
- Keep existing incidents adequately staffed by replacing timed out resources as needed.

PNW Incident Priorities (set daily):

<u>Priority</u>	<u>Fire</u>	<u>Unit</u>	<u>IC</u>	Rationale
1	Initial Attack			Initial attack is always the first priority.
2	Camp Creek	OR-MHF	Kuo	Protecting resources and infrastructure within the Bull Run municipal watershed. Planning firing operations as conditions allow. TOC to PNW Team 3 tonight.
3	Lookout	OR-WIF	DeMasters	Level 1, 2, and 3 evacuations in place. Portion of Highway 242 closed. Planning firing operations on Lookout as conditions allow. Includes Horse Creek and Pothole.
4	Anvil	OR-RSF	Behrens	Level 2 evacuations in place. Implementing indirect strategies.
5	Tyee Ridge Complex	OR-730S	Cline	Level 1 and 2 evacuations in place with continued evaluation.
6	Chilcoot	OR-UPF	Dimke	Area closures in place. Planning firing operations on Chilcoot as conditions allow. Incident includes Ridge. TOC to NW Team 6 tomorrow.

7	Cowlitz Complex	WA-GPF	Hohn	Road and trail closures in place. Point protection, long-term strategies for Grassy Mountain, Spencer Quartz and Snagtooth. TOC to CA Team 13 tonight.
8	Dinner	OR-UPF	Dimke	Level 2 evacuations in place. Incident includes Grizzly and Brice Creek. Planning firing operations on Brice Creek as conditions allow. Longterm strategies for Grizzly.
9	Flat	OR-RSF	Behrens	Level 1 evacuations in place. BAER and suppression repair efforts continue.
10	Bedrock	OR-WIF	DeMasters	Level 1 evacuations in place. Mop-up, patrol, and suppression repair.
