#### **Strategic Intent**

- Continue to support initial attack, emerging incidents, and new IMT deployments.
- Work with Agencies/IMT's to adjust strategy and tactics to align with existing resources and the likelihood of few additional resources coming into the Geographic Area.
- Planning and making deliberate decisions on limited replacement or reallocation of shared resources from NMAC.

7	Falls	OR-MAF	Stock	Level 3, 2, 1 evacuations. Threats to Burns and Hines communities and infrastructure along Highway 395 corridor.
8	Pioneer/Easy	WA-SES	Click	Level 3, 2, 1 evacuations. Community of Stehekin threatened. Primary Focus north line. Easy fire concerns for highway 20.
9	Diamond Complex	OR-UPF	LeFevre	Level 3, 2, 1 evacuations. Threats to utility infrastucture. Primary focus is Trail and Lemolo fires.
10	Ore	OR-WIF	Orr	Focus of concern is Highway 126.
11	Pyramid	OR-WIF	Mueller	Level 3 evacuation. Primary focus keeping fire north of private timber.
