- Work with Agencies/IMT's to adjust strategy and tactics to align with existing resources and the likelihood of few additional resources coming into the Geographic Area.
- Planning and making deliberate decisions on limited replacement or reallocation of shared resources from NMAC.

4	0404 RV Lone Rock	OR-PRD	Loomis	Level 3, 2, 1 evacuations. Threats to community of Spray. Primary focus on southern line.
5	Boneyard/Courtrock	OR-953S	Hessel	Level 3, 2, 1 evacuations. Threats to community of Monument.
6	Falls/Telephone	OR-MAF	Stock	Level 3, 2, 1 evacuations. Falls fire primary focus is north half. Telephone fire primary focus is south half.

8	Pioneer/Easy	WA-SES	Click	Level 3, 2, 1 evacuations. Community of Stehekin threatened. Primary focus north line. Easy fire, highway 20 closure in affect.
9	Diamond Complex	OR-UPF	LeFevre	Level 3, 2, 1 evacuations. Threats to utility infrastructure. Primary focus is Pine Bench fire. Twenty-three fires in the complex.
10	Swawilla 1/Bridge Creek	WA-COA	Cowger	Level 2 and 1 evacuations. Threats to residence and infrastructure.
11	Ore	OR-WIF	Orr	Continued road prep for indirect line.
12	Homestead Complex	OR-UPF	Ingram	Evaluating fires in the complex.
13	Cottage Grove Complex	OR-771S	Cheek	Level 1 evacuations. Evaluating fires in the complex. Lane 1 staffed.
14	Chalk/Moss Mountain	OR-WIF	Dallas	Level 1 evacuation. Priority fire is Chalk.
15	Pyramid	OR-WIF	Mueller	Level 3 evacuation (evaluating). Primary focus keeping fire north of private timber.
