Strategic Intent

- Continue to support initial attack, emerging incidents, and new IMT deployments.
- Work with Agencies/IMTs to adjust strategy and tactics to align with existing resources and the likelihood of few additional resources coming into the Geographic Area.
- Work with partner agencies to ensure requested incident management organization is commensurate with complexity.
- Planning and making deliberate decisions on limited replacement or reallocation of shared resources from NMAC.

	Town Gulch	OR-WWF		Emerging incident, IMT3/OSFM Blue Team unified command. CIMT SA #2 is mobilizing today.
	Williams Mine	WA-GPF		Emerging incident, CIMT NW Team 13 is mobilizing today.
	Warner Peak	OR-SHR		Emerging incident, ICT3.
2	Pioneer/Easy	WA-SES	Clemo	Level 3, 2, 1 evacuations. Community of Stehekin threatened. Primary focus is northern line. Closure of Highway 20.
3	Crazy Creek	OR-OCF	Gessler	Level 3, 2, 1 evacuations. Threats to private land and historical sites. Close to meeting containment objectives on the NE side.

4	Diamond Complex/Middle Fork	OR-UPF	Behrens	Level 3, 2, 1 evacuations. Threats to utility infrastructure and access to Crater Lake via Highway 230.
5	Cottage Grove	OR-771S	Cheek	Level 2 and 1 evacuation notices around Bohemia Mining District. Potential for Level 3 evacuations.
6	Falls/Telephone/Ritter	OR-MAF	McDonald	Some evacuation levels reduced. Threats to communities and infrastructure. Focus on Sand Fire.
7	Willamette Complex	OR-WIF	Boehm (north)/Dallas (south)	Level 1 evacuations. North Zone: Ore, Pyramid and Slate. South Zone: 208, 217, Chalk Mountain, Coffeepot, Moss Mountain, Tire, McKinley.
8	Whisky Creek/Sandstone	OR-954S	Schuster	Microwave TOC to local unit 8/9. Assumed command of Sandstone Fire 8/8. Threats to infrastructure and private lands.
9	Retreat	WA-SES	Olson	Level 3, 2, 1 evacuations. Threats to Highway 12 and private residences.
10	Homestead Complex	OR-UPF	Stock	Protecting timber values. No Man Fire is the priority.
11	Battle Mountain Complex	OR-973S	Rau	Reduction in some evacuation notices across the fire perimeter. No significant growth.
12	Cougar Creek	WA-SES	Dimke	Level 3, 2, 1 evacuations. Primary focus west line. Reducing threats to communities of Anatone, Grouse Flats and Troy.
13	0404 RV Lone Rock/Courtrock	OR-PRD	Truett	Level 2 and 1 evacuation notices. Good progress, no needs. Assisting with initial attack.
