Strategic Intent

- Continue to support initial attack, emerging incidents, and new IMT deployments.
- Work with Agencies/IMTs to adjust strategy and tactics to align with existing resources and the likelihood of few additional resources coming into the Geographic Area.
- Work with partner agencies to ensure requested incident management organization is commensurate with complexity.
- Planning and making deliberate decisions on limited replacement or reallocation of shared resources from NMAC.

PNW Incident Priorities (set daily):

Priority	<u>Fire</u>	<u>Unit</u>	<u>IC</u>	Rationale
1.	Initial Attack			Initial attack is always the first priority.
2.	Diamond Complex/ Middle Fork	OR-UPF	Oplinger	Level 1 evacuation notices. Threats to utility infrastructure. North entrance to Crater Lake National Park closed.
3.	Willamette Complex North	OR-WIF	Boehm	Level 3 and 1 evacuations. Focus is on the Ore Fire.
4.	Pioneer/Easy	WA-SES	Click	Level 2 and 1 evacuation notices. Level 3 evacuation in Stehekin dropped to level 2. Mudslide on Highway 20 hindering resource movement.
5.	Whisky Creek/ Sandstone	OR-954S	Schuster	Threats to infrastructure and private lands.
6.	Williams Mine	WA-GPF	Gales	Level 2 and 1 evacuation notices. Threats to Trout Lake, WA; Tribal timber and cultural values threatened.
7.	Cottage Grove/Lane 1	OR-771S	Hessel	Level 3 evacuations around Bohemia Mining District.
8.	Dixon	OR-UPF	Howard	Level 2 and 1 evacuation notices. Communities of Tiller and Drew threatened. TOC 8/21 @ 1800 back to local unit.

10.	Homestead Complex	OR-UPF	Stock	Protecting timber values. No Man and Horse Heaven priority fires.
11.	Crazy Creek	OR-OCF	Goss	Level 3, 2, 1 evacuations. Threats to private lands and historical sites. TOC 8/22 @ 0600 to IMT3.
12.	Retreat/Lodgepole	WA-SES	Snow	TOC back to local unit today @ 1800.
13.	Battle Mountain Complex	OR-973S	Rau	Level 2 and 1 evacuation notices. TOC to IMT3 8/20 @ 2000.
14.	Warner Peak	OR-SHR	Schwope	Critical sage grouse habitat threatened. TOC 8/21 @ 0600 to local unit.
15.	Falls/Telephone	OR-MAF	Loomis	Level 3, 2, 1 evacuations. Threats to communities and infrastructure. TOC 8/23 @ 0600 to IMT3.
