Strategic Intent

- Continue to support initial attack, emerging incidents, and new IMT deployments.
- Work with Agencies/IMTs to adjust strategy and tactics to align with existing resources and the likelihood of few additional resources coming into the Geographic Area.
- Work with partner agencies to ensure requested incident management organization is commensurate with complexity.
- Planning and making deliberate decisions on limited replacement or reallocation of shared resources from NMAC.

PNW Incident Priorities (set daily):

Priority	<u>Fire</u>	<u>Unit</u>	<u>IC</u>	Rationale
1.	Initial Attack			Initial attack is always the first priority.
2.	Diamond Complex/ Middle Fork	OR-UPF	Oplinger	Level 1 evacuation notices. Threats to utility infrastructure. North entrance to Crater Lake National Park closed.
3.	Willamette Complex North	OR-WIF	Orr	Level 1 evacuation notices. Increased area closures. Focus is on the Ore Fire.
4.	Pioneer/Easy	WA-SES	Click	Level 2 and 1 evacuation notices. Assume command of the Stayman fire.
5.	Williams Mine	WA-GPF	Gales	Level 2 and 1 evacuation notices. Threats to Trout Lake, WA; Tribal timber and cultural values threatened.
6.	Whisky Creek/ Sandstone	OR-954S	North	Threats to infrastructure and private lands.
7.	Willamette Complex South	OR-WIF	Butteri	Level 1 evacuation notices dropped. Focus is on Moss Mountain.
8.	Cottage Grove/Lane 1	OR-771S	Hessel	Level 3 evacuations around Bohemia Mining District.
9.	Homestead Complex	OR-UPF	Pyrah	Protecting timber values. No Man and Horse Heaven priority fires.

12.	Falls/Telephone	OR-MAF	Loomis	Level 3 evacuations around fire area. TOC 8/23 @ 0700 to IMT3.
