- PIO1 (T) Public Information Officer Type 1, Trainee
- PIO2 (T) Public Information Officer Type 2, Trainee

Actual team composition will be determined by the team leader and the ordering unit on a case-by-case basis dependent upon the needs of the assignment.

FPET Criteria

Candidates for team assignment must meet all prerequisites of training, experience, and physical requirements. The basic requirements are set forth in the National Wildfire Coordinating Group's publication "Wildland Fire Qualification System Guide, PMS 310-1."

Candidates also will need to commit their availability to the NFPET On-Call Schedule in the NFPET Program Plan which is part of the National Mobilization Guide.

- Team Leaders (PETL) must have at least one season of prior experience as a trainee
- Applicants on other Geographic Area Teams must have permission from the effected Geographic Area FPET Coordinators to participate on multiple teams

Trainees

We are encouraging everyone in the fire community in need of on-the-job training to apply and be identified as a trainee. Applicants may apply for trainee positions in which they have been issued a task-book. Trainees assigned to a team will be expected to be available to respond whenever the team is assigned. Upon successful completion of their training, the trainee will be recommended for certification by their agency, and a new trainee will be selected for the team. When certified, the individual is encouraged to submit an application to support the FPET program.
