2014 Issues

Fire Restriction Initiative

- USFS is working to standardize fire restrictions for R2
- Eventually, USFS would like to move to a consistent interagency approach
- USFS will be submitting an issue paper on the topic

Fire Adapted Communities

- There seems to be challenges getting information about FAC out to those who need it. Further, some felt there is a lack of consistent messaging.
- Develop FAC talking points to share with this committee (and partners), as well as other PIO groups

Cohesive Strategy

- Similar discussion as "issue" above.
- Working group is currently in Phase III of the process and will be working to get out some communication tools/talking points about CS and FAC in the near future.

Other

Prevention Teams

- Typically, the process for solicitation includes:
 - 1. a call for applicants within the RMA
 - 2. review of applicants / recommendation to Ops Committee
 - 3. Approve Roster (RMCG \rightarrow NICC)
- Currently this process is behind schedule. With Shannon leaving, Jason will need assistance with the process.
- It has been challenging in filling a Roster for a Prevention Team (lack of interest)
- There was a suggestion to combine with Great Basin to fill one Prevention Team to cover both areas
- Sheryl will check on pursuing a joint Prevention Team
- Sheryl will confirm time slots for the 2014 fire season Prevention Team rotation

South Dakota – beginning to work on a wildfire prevention program, planning for a wildfire awareness week [in tandem with national preparedness day (mentioned above)], education for safe pile burning for landowners, Great Plains Fire Safe Council, and PSAs (4/yr) including social media
