TODAY'S CREW ASSIGNMENTS:

TNTNC MA#1 and KICC MA assigned to Payette NF Hell's Canyon fire near Weiser, ID. Crews are constructing line in a rapidly moving fire in rough country. Type 2 Overhead Team ordered for this and the nearby Raft fire. Crews are spending the night in Ontario, OR. Crew will be released from the fire, demobed and enroute to Boise from Weiser at approximately 1200 tomorrow.

FLST#1, NCNCS MA#1 and GASC#2 still assigned to Beaver Creek fire, Ketchum, ID
FL, GA, and NC have all been moved to Beaver Cr Base Camp. They assisted in the breakdown of the base camp and went through demob today. All three crews will be released from the incident and be free to travel at 06:00 Saturday morning. Should be at the Demob Center in Boise no later than 11:00 Saturday morning.
