The Eastern Area Incident Business Working Team (EA-IBWT) is recruiting for the Eastern Area National Buying Team for the 2025-2026 fire seasons. Recruitment is open for all Buying Team positions: Buying Team Members and trainees, Buying Team Leaders and trainees, Spreadsheet Specialists and Alternates for all positions. Recruitment is open to both Federally Warranted Contracting Officers and Contracting Specialists and Mirco-purchasers. *Current EA BUYT members will need to reapply.* 

The application period will open March 31, 2025, and close April 21, 2025. This will be a 2-year commitment. Persons must have approval from their immediate supervisor, be in good standing and current with reconciliation of recent purchases. A Buying Team supports incident acquisition, procuring a wide range of services and supplies, as well as renting land and equipment. Each National Interagency Buying Team has seven people consisting of a leader, and team members. One member may be assigned as an assistant or deputy leader. One member must be a Contracting Officer.

Candidates must complete the mandatory required training to qualify for a position as a Buying Team Member or Buying Team Leader or Alternate Member/Leader.
