#### **COURSE INSTRUCTIONS**

This section contains information to help the course coordinator and instructors present a course that meets NWCG guidelines and student needs. All instructors must be thoroughly familiar with this section and all other course material prior to presenting the course.

#### I. COURSE INTRODUCTION

#### A. History

The Expanded Dispatch Recorder (EDRC) course was developed in response to an identified need for more trained individuals to assist in dispatch offices when support and coordination of incidents become more complex than normal and expanded dispatch organizations are required.

#### B. Overview

Expanded Dispatch Recorder, D-110, is a 24-hour course designed to meet the training needs of an EDRC as outlined in the Wildland Fire Qualification System Guide, PMS 310-1, and the Position Task Book (PTB) developed for the specific position.

The Wildland Fire Qualification System Guide, PMS 310-1 provides guidance and a national wildland standard for establishing minimum training, skills, knowledge, experience, and physical fitness requirements for the participating agencies of the NWCG.

This course is designed to train potential EDRCs. It begins by providing an overview of the dispatch organization and the qualities of a successful dispatcher. The remainder of the course provides hands-on electronic resource tracking system experience introducing customary dispatch concepts.

## C. Course Length

The course will require 24 hours for instruction and effective hands- on exercises. More time will be required if agency or unit specific material is added.

#### II. COURSE OBJECTIVES

The course objectives are stated in broad terms that define what the student will be able to accomplish after completing the course.

At the successful completion of this course students will:

- A. Describe the purpose and structure of Expanded Dispatch.
- B. Describe the roles and responsibilities of the Expanded Dispatch Recorder (EDRC).
- C. Demonstrate how to mobilize and demobilize incident resources, using established dispatch ordering channels, through resource order forms and electronic resource tracking systems.
- D. Describe how to communicate effectively and foster positive interpersonal working relationships.

NOTE: As of April 2021, the current electronic resource tracking systems is IROC (Interagency Resource Ordering Capability). This course was written to accommodate future resource tracking systems.

#### III. INSTRUCTOR PREREQUISITES

#### IV. INSTRUCTOR PREPARATION

The NWCG Course Coordinator's Guide, PMS 907, contains the general information necessary for presentation of NWCG courses.

To adequately deliver this course, instructors and coaches must be thoroughly familiar with the content of this Instructor Guide and agree on any changes before the class is resented. The following ser up instructions may change when a new electronic resource tracking system is implemented.

#### **Instructors must prepare ahead of time for the following:**

- During the course, students will be referred to a list of websites. It is recommended that these be provided as links imbedded in the Student Guide so each student can easily access them during class and for future use.
- All students will need to have an iNAP account set up prior to the beginning of class. They must then coordinate with their local dispatch center to receive an IROC User ID, password and appropriate IROC roles (See Sample Acceptance Letter).
- Instructor will need to add students to their IROC Practice User Account.
- All students will need a computer or laptop with internet and printer access (when in-person) with IROC Practice preloaded.
- Prior to the course, incidents and resources will need to be created in IROC Practice for the exercises to work properly (See Appendix A). Currently, IROC is reset each Saturday.

#### V. COURSE MATERIALS

For Course Ordering and Support Information, see Appendix A.

#### A. Instructor Guide

The Instructor Guide contains all the information, electronic presentations, handouts, and references necessary for the course coordinator, instructors, and students.

Each instruction unit has a "Detailed Lesson Outline" that contains information the instructor needs to teach the unit. The technical content for each unit is written in outline format. This column also contains notes to the instructor (directions for conducting exercises, questions to ask students, etc.) which are in **BOLD**.

The "Aids & Cues" reference slide numbers and handout numbers that remind instructors to refer to specific material. These are designated in **BOLD** at their appropriate use points in the IG.

SW - Student Workbook page

#### B. Student Workbook and Reference Guide

The Student Workbook contains the same content outline that is in the Instructor Guide; however, in some places the outline is intentionally left blank. These are areas where the instructor will direct students to complete the outline.

#### VI. STUDENT TARGET GROUP

This course is designed for individuals who have no previous training or experience in dispatch. The course is specifically targeted for personnel desiring to be qualified as an EDRC but can be used for others interested in learning what is involved in the dispatch organization and electronic resource tracking system.

#### IX. EXAMINATIONS AND CERTIFICATION

This course contains a final exam and a final scenario. Students must attain 70% or higher on the final exam to receive a certificate of completion for this course.

#### X. CADRE MEETINGS

Cadre meetings are an opportunity for instructor(s) and coaches to meet, review the materials, and discuss concerns with the course coordinator or lead instructor. These meetings are most critical for instructors/coaches who do not have previous experience with this course.

Coaches are a main component of this class. Coaches should meet with the course coordinator or lead instructor prior to the beginning of class to understand their role. At the end of each day of the course, a cadre meeting should be held to discuss concerns and progress. This is also an opportunity for coaches to update student evaluations and position task books. Upon course conclusion, a final cadre meeting should be conducted to evaluate instructor performance and suggest modifications for future courses.

#### XI. RECOMMENDED CLASS SIZE

Recommended class size is 16. To facilitate exercises, it is recommended that each coach oversee a maximum of 4 students.

## XII. SPACE AND CLASSROOM REQUIREMENTS

The characteristics of the classroom and supportive facilities have a great impact on the learning environment. The classroom should be chosen and viewed well in advance of the presentation.

Characteristics to look for in a classroom:

- Adequate area for students and materials. Tables should be set up so that students can work in a group consisting of 4 students and one coach.
- Limited outside interruptions and interferences.
- Controllable lighting, good acoustics, and good ventilation.
- Adequate internet to support your platform is necessary.

#### UNIT 1 DISPATCH ORGANIZATION PRESENTATION

**Course** Expanded Dispatch Recorder, D-110

I. DISPATCH ORGANIZATION

There are two types of dispatch organizations: Established and Expanded

- A. Established dispatch organization (**Slide 1-4**): primary mission is to provide timely, cost-effective coordination of emergency response within its specific geographic area. Three levels of established dispatch: (**Slide 1-5**)
  - 1. Local dispatch center: commonly referred to as "initial attack" (or IA). Responsibilities include, but are not limited to: (SW p. 1.2)
    - a. Daily duties (i.e. weather forecasts, tracking non-fire resources, any other local duties)
    - b. Aircraft flight following
    - c. Intelligence gathering and dissemination (i.e. WIMS, IQCS, weather forecasts, tweeting, etc.)
    - d. Responding to initial fire reports
    - e. Resource mobilization and tracking
    - f. Telephone and radio traffic
  - 2. Geographic Area Coordination Centers (GACC) (Slide 1-6)
    - a. There are 10 GACCs in the United States.
    - b. Process requests that are not filled at the local level.

- c. Provide intelligence, predictive services and related products designed to be used by geographic area fire community for incident management decision making.
- 3. National Interagency Coordination Center (NICC) (Slide 1-7)
  - a. Processes requests that are not filled at the geographic level.
  - b. Provide intelligence, predictive services, and related products, which are designed to be used by the national wildland fire community for incident management decision making.
- B. Expanded Dispatch Organization (**Slide 1-8**) is initiated when a high volume of activity indicates that increased dispatch and coordination capability is required to relieve the Established Dispatch of the support function of one or more large incidents or multiple smaller incidents.
  - 1. When is Expanded Dispatch Initiated? What are some trigger points?
    - a. Multiple incidents wildland fire, earthquake, floods, hurricanes etc.
    - b. Incident Management Team is ordered
    - c. There is an incident within an incident (IWI)
    - d. Large, complex, or politically sensitive incidents
    - e. Local factors (i.e. short staffed, increased workload, etc.)
- C. Expanded Dispatch Environment: can be chaotic and unorganized, especially in the beginning. It can go from extremely busy to extremely slow. You will work with dispatchers from across the nation. Priorities will constantly change. Remember, you represent the local host unit and your home unit.
  - 1. Skills that will help you: (SW p. 1.3)
    - a. Being flexible

- c. Ability to multi-task
- d. Being a good team player
- e. Good communication skills
- f. Knowing your own strengths and weaknesses
- g. Being proactive
- h. Always be professional and courteous
- 2. Expanded dispatch positions

There are four expanded dispatch positions:

- a. EDRC = Expanded Dispatch Recorder (**Slide 1-9**)
  - Receives initial briefing from Expanded Dispatch Supervisory Dispatcher (EDSP).
  - Processes resource requests using established procedures and ordering channels.
  - Relays pertinent information through established dispatch channels.
  - Tracks resources and document in accordance with established procedures.
  - Participates in briefings and utilize shift/dispatch log when appropriate.
  - Relays any issues to EDSP

- b. EDSD = Expanded Dispatch Support Dispatcher (**Slide 1-10**)
  - Processes orders for one or more functional area: crews, overhead, equipment and supplies.
  - Follows established procedures associated with the electronic resource tracking system (IROC).
  - Provides guidance to EDRCs.
  - Relays issues to EDSP.
- c. EDSP = Expanded Dispatch Supervisory Dispatcher (Slide 1-11)
  - Provides supervision to EDSDs and EDRCs
  - Orders additional dispatchers as needed for present and future needs.
  - Ensures compliance with dispatch protocols.
  - Provides training
  - Ensures coordination between functional areas.
  - Schedules and conducts briefings.
  - Acts as liaison between Expanded Dispatch and other incident support organizations.
- d. CORD = Expanded Dispatch Coordinator (**Slide 1-12**)
  - Usually assigned in complex situations involving MAC groups or multiple expanded dispatch organizations.
  - Acts as liaison between Expanded Dispatch and other incident support organizations.

• Schedules and attends briefings.

I. WHAT IS IROC? (Slide 3-3)

The National Interagency Resource Ordering Capability (IROC) is utilized in an estimated 300 interagency dispatch and coordination centers throughout the nation. IROC tracks all tactical, logistical, service and support resources mobilized by the incident dispatch community.

### A. IROC security (Slide 3-4)

- 1. IROC is accessible to anyone with Internet access and an IROC User Account.
- 2. If someone has both an IROC User and IROC Web Status account, they use the same username and password for both. Security rules for IROC User Accounts also apply to Web Status Accounts.
- 3. The dispatcher must always work in IROC under their username and password. Never allow another individual to use your IROC username. All documentation in IROC is stamped with date/time and username. The dispatcher is responsible for all activity tied to their username.
  - a. Auto-doc vs. User-doc: There are several actions in IROC that will be automatically documented, i.e. creating an order, or cancelling an order; and that will be stamped with the dispatcher's name and the time it occurred. You can also manually add documentation to include additional information, i.e. who you received the order from, why an order was cancelled, etc.

  - Grey Water is all wastewater except toilet waste and food waste.
- Catalog Category: Medical
- Catalog Category: Potable Water Truck
  - Potable water is safe and suitable for drinking.
- Catalog Category: Shower, Mobile

- NICC dispatches all National Mobile Shower Units. These requests are placed to the GACC and subsequently placed to NICC.
- Orders for showers are handled by EDSDs or EDSPs.
- Discuss local protocol.
- Catalog Category: Task Force
  - Task force requests are filled with resources of different types. Support overhead will be ordered as needed.
- Catalog Category: Tender, Water (Support)
  - Information on typing can be found in the Interagency Standards for Fire & Fire Aviation Operations (Red Book).
- Catalog Category: Tender, Water (Tactical)
  - Information on typing can be found in the Interagency Standards for Fire & Fire Aviation Operations (Red Book).
- Catalog Category: Tractor Plow
- Catalog Category: Trailer
  - Scroll through the items.
- Catalog Category: Transportation
  - Scroll through the items.
- 5. Set Catalog to Overhead
  - Catalog Category: Groups
    - Scroll through the items.
    - Identify that Incident Management Teams are listed here.

- Discuss modules and squad.
- Catalog Category: Positions
  - Catalog items are in alphabetical order and show the 4-letter position code.

  - Type the requested time in the Needed by Time field, using military time.
  - Needed by Time Zone will be automatically selected.

  - This indicates that the incident does not want EFF/ AD in this position. EFF/AD = Emergency Firefighters & Administratively Determined employees
- Contractor not acceptable.
- Portal to portal acceptable.

### 11. Overhead Details

- Trainee: No trainee vs. trainee acceptable vs. trainee required.
  - **04-02-HO** states trainee okay, so have students select Trainee Acceptable.
- Named request
  - Refer to policy in National Mobilization Guide

- Explain the use of Name Requests, giving examples of when appropriate.
- Demonstrate the use of the search field by searching for a local individual.
- Special Approval Check boxes
  - Rental Vehicle Approved
  - Cell Phone Approved
  - Laptop Approved

- Catalog Item column search for catalog item.
- Requested Resource column search for catalog item.
- Resource Current Dispatch column once a request is filled, search for current dispatch unit ID.

- Special Needs column search for special needs.
- Item Description column search for item description.
- Quantity R/A column search for quantity requested and quantity assigned.
- Previous column indicates the last action that was taken on a request.
- Current column indicates the current dispatch center
- Trainee column indicates is a request have trainee acceptable, trainee required or no trainee.
- Claimed column indicates if a request is claimed or no
- Claimed by column indicates who has claimed the request.
- Nav Instructions column indicates the navigation instructions.
- Created by column indicates who created the request.
- 6. Have students claim their FFT1 request from **04-02 HO**, using Claim action button.
  - Important to claim when multiple dispatchers are working in the same functional area to avoid duplication of effort and confusion.
  - Navigate the columns to the far right to display that their name is now listed in the CLAIM column.
- B. Click on Manage Request icon for their FFT1 request.
  - 1. This will open a new tab with the Manage Request screen

- The top portion of the Manage Request screen displays the request's current location, current status and incident information. (**Slide 4-9**)

    - Travel to be Arranged (IROC will default to this)
  - 3. Discuss local process on inputting commercial travel or multi-leg travel into IROC.

  - Cell service, satellite phones, voice/data lines.
- 5. Service, Delivery
  - Ice, newspaper, potable water delivery.
  - Use this option for ongoing services.
- 6. Service, Facility-Land Rental
  - Conference room, land use, refrigeration and shower facility rental.
- 7. Service, Fuel Delivery
  - Diesel/Gas, Other, Propane, Aviation.
- 8. Service, Meals, Food, Lodging
  - Food catering (when the # of incident personnel has not met the threshold of ordering a caterer off the National Contract or a National Contract Caterer is not available).
  - Demonstrate the difference between number of requests and quantity of meals.
  - Lodging, Meals, Groceries/Sundries (see documentation).
- 9. Service, Miscellaneous

• Dust abatement, equipment inspection, excavation, laundry, medical, mobile mechanic, mobilization center, road grading.

### 10. Service, Office Support

 Fax rental, audio visual equipment rental, computer rental, copy machine rental, other office equipment rental, office machine repair.

#### 11. Service, Sanitation

- Grey water removal, handwashing stations (portable), porta-potties, recycling, garbage/container removal, other sanitation.
- Instructor Note: From this point, move to the top right of the New Request screen
- I. Have students select Category > NFES Supplies
  - 1. Demonstrate how to search by item name.
  - 2. Demonstrate how to enter the NFES number
  - 3. Identify "Standard Pack". Refer students back to NFES catalog and point out that Standard Pack can be different than Unit of Issue.
  - 4. "Quantity". Supplies are the only functional area that can have multiple identical items per request.
- J. "Default Number Block". Explain blocks of numbers can be issued to others outside of expanded for tracking purposes (established dispatch, buying teams, incident management teams, etc.).
  - 1. Refer to local protocols.

    - Select one of three options:

  - 3. Discuss Servicing Cache
  - 4. Shipping Contact: Name and phone number should be selected from the pick menu. Emphasize that students can add a name and phone number; however, they should always check with the supervisory dispatcher prior to doing so.

I. SUPPLEMENTAL FORMS

Supplemental forms are used to provide additional information so that requests can be processed efficiently. Some forms may vary by area, but the information will be similar. An EDRC does not typically complete or process these forms independently, but it is important to be familiar with them.

- A. Students will follow along on their hard copy forms while instructor projects forms on the screen.
  - 1. Resource Extension Request Form (08-01 HO)
    - Used to extend resources on incident. (Slide 8-3)
    - EDRC will notify EDSD or EDSP when an Extension Form is received.
    - National resources require NICC approval to extend.
    - Discuss local protocol.
  - 2. Aircraft Flight Request Form (08-02 HO) (Slide 8-4)
    - Used to request aircraft to transport personnel and/or supplies.
    - Shows aircraft used, personnel/supply transported and is used for payment information.
    - Provides ETD/ETA information.

- 3. Passenger and Cargo Manifest (08-03 HO) (Slide 8-5)
  - Identifies personnel and/or cargo being transported.
  - Generally used for crews and engines.
- 4. Preparedness/Detail Request (08-04 HO) (Slide 8-6)
  - Used to request individual resource for extended or prearranged assignments.
  - Can be used for overhead, equipment, and crews.
  - Follow local protocol, does not use fire codes.
- 5. Mobile Food and Shower Service Request Form (08-05 HO) (Slide 8-7)
  - Provides the information required by NICC to fill the request.
  - Useful as a checklist to ensure everything is ordered prior to arrival.
  - Required to order a national caterer or shower.
    - EDRC would only fill out this form with the help of an EDSD or EDSP. Discuss where and how you might get some of the information required for the form (example: number of meals).

#### II. HARDCOPY RESOURCE ORDER

- A. Introduction (Slide 8-8)
  - 1. The hardcopy resource order form is used to manually document resource requests when the electronic resource tracking system (IROC) is unavailable.

### B. Legal Documents

- 1. Resource order forms and all supplemental forms are legal documents that can be subpoenaed and used in lawsuits.
- 2. What does an EDRC need to consider when completing any form electronic or hard copy?
  - Possible answers: Be professional, state facts, be accurate and thorough, try to be legible, etc.
- 3. Completed Resource Order forms are part of the final financial package.
- C. Description of the Form (08-06 HO)
  - 1. Each functional area has its own form. On original cardstock, each functional area has its own color: Crews/Green; Overhead/White; Equipment/Goldenrod; and Supplies/Brown.
  - 2. Hardcopy resource orders are no longer being produced. They are available for printing online. Discuss local protocol.
  - 3. There are three main sections on the form:
    - Header information (Blocks 1- 11)
    - Resource information (Block 12)
    - Receive request
    - Place request
    - Assign resource and relay information
    - Release resource
    - Documentation (Block 13)

- Documentation block is continued on the back of the form.
- D. Examples of Completed Forms
  - 1. Display each completed Resource Order form and describe to students each of the three sections described above.
    - Equipment (Slide 8-9)
    - Crews (**Slide 8-10**)
    - Supplies (Slide 8-11)
    - Overhead (Slide 8-12)
  - 2. Refer students to the EDRC Reference Guide where they can find the "Block by Block Instructions".
