Central Nevada Interagency Dispatch Center Summary

The Central Nevada Interagency Dispatch Center (CNIDC) encompasses the Battle Mountain and Winnemucca Districts of the Bureau of Land Management (BLM), the Santa Rosa, and Austin-Tonopah Ranger Districts of the Humboldt-Toiyabe National Forest (USFS), the Bureau of Indian Affairs (BIA), Nevada Department of Forestry (NDF) and several counties, for over 29 million combined acres in the state of Nevada.

A full staff at CNIDC is 1 center manager, 2 assistant center mangers, 2 permanent lead dispatchers, 5 career-seasonals, and 5 temporary seasonals, for total of 15 positions. For 2019, CNIDC had a staffed of 11 employees, 3 permanent, 4 careerseasonals, and 4 seasonals. We had 5 vacant positions during the fire season, 2 assistant center managers, 1 career-seasonal and 2 temp seasonal positions.



Even with a busy fire season, we were able to send employees on off-district fire assignments. We were able to complete and work on multiple taskbooks for dispatch qualifications during the year.

2019 Fire Statistics Summary

CNIDC had 154 fires for 27,868.13 acres, total. The number of fires and acres were both below the 5 year and 10-year average. The table below shows the breakdown of fires and acres by fire ownership.

WildCAD Incident Summary

WildCAD is the dispatch program CNIDC uses to document incidents and communications that happen in the center. The number of incidents and type of incidents show the overall workload of the center. While wildland fire dispatching is one of many roles of CNIDC, our other role is dealing with MLR individuals going out into the field and events they hold.

Outside of the tactical aircraft CNIDC dealt with during the fire season, there were also project flights. Most of the project flights are dealing with wild horse and burro surveys.

CNIDC Logistics Summary

CNIDC dealt with 154 local incidents and 190 non-local incidents in Resource Ordering and Status System (ROSS). Comparing these numbers to 2018, which were 176 local incidents and 217 non-local incidents, CNIDC dealt with fewer incidents in 2019 than in 2018.
