Subject: Recission of Outdated/Irrelevant NRCG Memorandums and Guidance

As part of our ongoing efforts to ensure that guidance and direction provided by the NRCG remains current, relevant, and aligned with national policy and operational needs, we have conducted a review of previously issued memorandums.

Based on this review, eighteen past NRCG memos and/or guidance are no longer applicable due to changes in policy, organizational structure, or procedural updates. This memo serves to formally outline the specific memorandums recommended for rescission and the rationale behind each action.

A detailed list of the memos proposed for rescission is provided in Attachment 1, including title, reference number, original issue date, and a brief justification.

These rescissions will ensure our shared direction reflects current practices and avoids conflicting or outdated guidance.
