Subject: Approval of 2026 Northern Rockies IMT Rosters and Leadership Expectations

The Northern Rockies Coordinating Group (NRCG) has approved the 2026 Incident Management Team (IMT) rosters as submitted on February 17, 2026. Minor adjustments remain in progress; however, the rosters are formally approved. The 2026 approved roster will remain in effect through the 2028 fire season, with an open IMT member recruitment period occurring annually in December/January to allow for IMTs to continue to build capacity.

During review and approval discussions, NRCG emphasized the mindful use of AD personnel, reinforcing that administratively determined (AD) assignments should not displace qualified agency employees. This expectation will continue to be communicated and upheld. The approved rosters reflect approximately 800 personnel across teams and align with long-term development goals to strengthen Command and General Staff depth over the next three years.

Incident Commanders are expected to actively cultivate the next generation of leadership within the Northern Rockies Geographic Area. This includes providing meaningful and progressive training opportunities for qualified deputies, trainees, and emerging leaders; identifying individuals with leadership potential; and fostering an environment that promotes professional growth and confidence. Effective succession planning strengthens organizational resilience, ensures operational continuity, and enhances overall IMT capacity. ICs are accountable for integrating succession planning into team operations and intentionally mentoring to pass forward knowledge, experience, and leadership.

NRCG extends its sincere appreciation to the IMT community for your continued willingness to serve. The Northern Rockies and the nation rely on your professionalism, expertise, and volunteer spirit to support complex incident management. Your commitment—often in addition to primary agency responsibilities—demonstrates extraordinary dedication to interagency cooperation and public service.
