NWCG/NMAC Update: (Aitor Bidaburu)

- CGAC is meeting this week. Two-day joint meeting with CGAC and NMAC starting tomorrow. There will be robust discussion about the future of Area Command teams. Covid will also be a topic, with an MPHAT presentation. Believe may trend back to Covid protocols of 2020.
 - Note: Rich Cowger and Aaron Thompson will also try to attend this meeting. Darron Williams will be listening also on Wednesday.
- IMT Coordination will look and feel like last year.
- Crew Coordination – T2 and T2IA contract crews will be national resources, regardless of host GACC.
- Last week at NMAC, had an eye-opening briefing from predictive services staff. Reviewed list of single point of failures for many products that are produced.
- Messaging effort needed around Complex Incident Management memo. Expect discussions and decisions around those efforts.
- Leadership Update – incoming NMAC Chair is Chair Ken Schmit; Shane McDonald is the incoming NWCG chair.

Northern Rockies GACC and Operational Updates:

NRCG Operations (Corey Buhl)

- Attending CGAC and NMAC joint meetings this week. On Wednesday, will be looking for feedback regarding problems or issues that would be better handled at the National Level.
- Working on the Heavy Equipment Task group addressing several issues, with the intent to produce a proposal for NRCG review.
- Working on trying to fill predictive services position and are experiencing PD challenges.

NRCC Update (Kathy Pipkin)

- No fire activity since January 5th.
- Do have resources are out of GACC providing support for both prescribed fire and suppression.
- As of right now, only the T2 National Contract crews will be moved to NICC for dispatching. Still several details to work out with this change.
- David Lee out of Miles City received a coordinator position at NICC. Multiple dispatch vacancies within the GACC. A new Chair for the Dispatch Committee will be voted on in the future.

Old Business

Streamlining NR MAC Fire Prioritization Process – Informational Topic – Corey Buhl

- Are moving forward with this effort. Intelligence Coordinator will be reaching out to Rick Stratton to identify if his product is scalable and feasible for the Northern Rockies.

Tasking – IC Committee – IMT Future Organization – Decisional Topic – Josh Harvey and Joe Sampson

- NRCG memo attached from December at the end says "The specific tasking for the IC group will be developed in early 2022"
- (See reference documents in pre-reading materials)
- IC Committee is meeting tomorrow. Are looking for clarity of intent since distribution of Complex Incident Management national memo. Would like clarity on configuration summary and if it should be in line with that memo.
- Craig Glazier – Agree; Northern Rockies configuration should be in line with the new national direction.
- Aitor Bidaburu – Memo has been fully supported and signed off on; can take it at face value in terms of intent.
- Aaron Thompson – Some GACCs are looking to go to Complex Incident Management in 2022. Can now order a Complex Incident Management team in IROC. Do feel this is on par to implement in 2023. Do feel Northern Rockies IMTs should be in alignment with memo.
- Rick Cowger – Need exists for a reality check for what will be attainable this season. Also agree that the need exists to strive to meet those timelines set forth in the memo.
- Joe Sampson – Tasking will, in part, come down to capacity. Do have some concerns with the FEC memo. NMAC will have much more control of the teams, regardless of planning level.
- Aaron Thompson – Do feel there is a need to assess if there is capacity to stand up a few T3 IMTs in the GACC. Do not share above concern regarding control, as feel good coordination and communication with NMAC will be functional and assist with taking care of the well being of resources.
- Joe Sampson – Are rolling into the second year of the GYA T3 IMT and have had good success. Worth having on paper that the Northern Rockies will follow the intent of the FEC memo.
- **Action Item: Rich Cowger will draft a tasking memo for Chair's signature.**

Support for Northern Rockies Operations Officer – Informational Topic – Craig Glazier / Aaron Thompson

- Critical support for this position is needed.
- Proposal is to formalize that process a bit more.
- Would like to offer up Jordan McKnight as a primary back-up to Corey Buhl.
- Aaron Thompson – Do feel that should formalize pre-season and update the Delegation of Authority. Would also like to include additional names as further depth.
- **Action Item: Craig Glazier will update the DoA; including input from Jordan McKnight and Corey Buhl regarding adding roles and responsibilities verbiage.**

RIST Update – Informational Topic – Craig Glazier

RIST Support for 2022 – Decisional Topic – Craig Glazier

- USFS can come up with two detailers that will get through eight months of the year. This should get the Northern Rockies through 2022. Do need group support that the Forest Service can pick up the shoulder season dollars; however, if during season these individuals are not on a P-Code, that they be placed on the Northern Rockies Cost Share.
- Intent would be to bring individuals on in March.
- Funding for the first and last month would be picked up by the Forest Service and the rest would be covered by the cost share. Last fiscal meeting it was proposed that RISK was not needed on the NR Financial Plan, so could replace that with the RIST position.
- Tate Fischer – During the agreement call, did take out the RISK or not – and proposed to replace with RIST?
 - Craig Glazier – That was a discussed proposal for moving forward.
 - Sarah Lee – This change is being discussed for FY23. This funding being discussed for a vote would be coming off the Suppression Cost Share?
 - Craig Glazier – Correct.
- Matt Hall – Confirming that individuals will charge to active incidents being supported as much as possible?
 - Craig Glazier – Correct.
- Vote to approve FY22 proposal for detailers (Fiscal Vote):

- Equipment changes – no fish strainers will be attached to the pump kits; have not changed fuel mixture ratio as of yet; discussions are ongoing around this issue. Fire shelters are also being discussed. Nationally, are committed to change over to rechargeable repeater batteries at some point.

IMT Selections – Decisional Topic – Jay McAllister

- ICs met last week; roster were completed late last night. All that applied were placed on a roster.
- Rosters will be disseminated. There are holes on every roster and some rosters have excess individuals.
- Tate Fisher – How many individuals are on more than one team?
 - Josh Harvey – Would need the rosters to verify.
 - Sarah Lee – Last year, from a spreadsheet view, there were only four. That may not reflect reality. BLM does have some concerns around multiple job shares and open positions. As a Board need to ensure are setting teams up for success.
- Rich Cowger – Sat in on IC meeting reviewing the rosters. There were a few individuals represented on multiple teams between primaries and alternates. The ICs did work that out to where they were comfortable. Emphasized the need to have confidence in the IC's decisions regarding rosters.
- Paul Cerda – Same thoughts on supporting ICs.

- Aaron Thompson – What are the potential failure points and how can those be address in advance?
 - Calvin Miller – Communicating and working with the field to increase understanding. May see a gap in the 7-day product; however, hopefully this component will be addressed prior to fire season.
- Craig Glazier – Appreciate knowing about any assistance needed.
 - Calvin Miller – Fire Anayslsist positions are critical to the long-term product success. This would be a new position in the Northern Rockies.

Supporting NR Operations Officer – Decisional Topic – Corey Buhl

- List has recently changed and needs updating.
- Request feedback regarding qualified and available individuals. Please send these names direct to Corey Buhl.
- Action Item: Corey Buhl will update the list and it will be voted upon at the spring meeting.

NR Dispatch Complexity Analysis Results – Informational Topic – Kat Sorenson and David Lee

- (See briefing paper in pre-reading materials)
- Reviewed history of the topic including tasking and methodology.
- Developed a complexity matrix that best represented the Northern Rockies.
- All center managers have had an opportunity to review and comment.
- Aaron Thompson – What was the reaction from the different dispatch centers?
 - David Lee – For the most part responses were positive; however, some centers did disagree with their center's rating. Some advised that the criteria utilized did not best capture their

center. These centers were encouraged to share their business practices, so that the criteria may be updated moving into the future.

- Craig Glazier – Appreciate this work and effort. Regarding staffing challenges, were there any discussions around any potential consolidations?
 - Kat Sorenson – One consolidation is occurring now; Bozeman is combining into Billings Dispatch by mid-April. No other talks in the committee currently. However, analysis has shown some logical options that could be reviewed moving in the future. Analysis also highlighted the “other” duties – including training officer workload.
 - David Lee – Truly highlights how staffing and organization is still configured for fighting fire 20 years ago. Needs to be larger discussion around appropriate staffing levels for current situation.
- Aaron Thompson – What are the next steps of this process?
 - David Lee – Next steps are to develop some recommended Table of Organization (TOs) and bring some center managers into any potential consolidation discussions.
 - Kat Sorenson – Can make a recommended staffing plan and move possibly towards the next steps of consolidation. Can have the staffing plans back to NRCG BOD for review by mid-summer. Center Managers did have some good suggestions regarding addressing staffing.
- Ryan Melin – Emphasized the need to address recruitment and retention as well as sustainability under current staffing levels.
- Craig Glazier – How difficult is it to determine adequate staffing levels?
 - Kat Sorenson – Do have the advantage that other GACCs have previously and are currently going through this process and can learn from those experiences.

Update for National Committees – Complex Incident Management – Informational Topic – Aaron Thompson

- Nationally is being supported; question now is how to get there and what does it look like.
- Several proposals on the table currently.
- Rocky Mountain area was proposing piloting this year per their Coordinating Group; however, there has now been a decision that they couldn't go outside the GACC for the summer. If were to go outside the GACC, would need to go as a T1 or T2 IMT.
- Will be giving an update to executives at the end of March.
- Continue to see on the ground administrators not aware of or not understanding complex incident management. Encourage all to do what they can to further this understanding and share information.
- Implementation is set for 2024.

IMT Roster Status – – Informational Topic – Aaron Thompson

- Aaron Thompson – Request clarification regarding IMT roster approval and who will be taking over the Team Coordinator role in Kathy Pipkin's absence?
 - Josh Harvey – All rosters were approved at the last meeting.
- Craig Glazier – The number of holes further highlights that moving forward with seven (7) teams is not sustainable.
- Aaron Thompson – Concern over giving approval; specifically, around setting the teams up for success. Concerns over expectations and continuing to provide the IMTs with key support.
- Craig Glazier – Need to identify a good communication strategy to the WFAAs regarding this topic.

Monday April 18, 2022 – General Session

Welcome and Introductions – Josh Harvey

- Appreciate all the work that has been accomplished this winter.
- Acknowledged the change that has occurred over the last few years, including the business changes that came about from Covid.

National Update and Report – Aitor Bidaburu

- Nationally PL2; receiving resource orders supporting Southern Area and the Southwest.
- Conditions are beginning to creep into the southern Great Basin.
- NMAC – approximately 40 T2IA crews on the National contract this year; will be dispatched at the GACC level. T2 Crews are still in the contracting process. Expecting approximately 200 crews; will be dispatched out of NICC.
- Complex Incident Management (CIM) – IMRR calls have been occurring; facilitated by NIMO. Putting some structure in to provided for governance protocols and vetting ideas through NWCG standards. NMAC will be the focal point to task out items to committees. CIM effort continues to move forward. NWCG standards committee is actively involved and has been tasked with identifying pathways. Short turnaround for a draft that will then be reviewed. 2023 will be a transition year with full implementation in 2024. Rocky Mountain Geographic Area will pilot this year. Looking for feedback on areas that would accept a CIM team.
- NMAC will continue prioritizing teams per the protocols listed in the National Mobilization Guide. This assists with managing team welfare and fatigue.
- Corey Buhl – Need to identify if any teams want to be part of the pilot and need to decide if this GACC will accept CIM teams by June 1st.

Northern Rockies Operations Spring Report – Corey Buhl

- Action Item: Need to identify if any teams want to be part of the CIM pilot and need to decide if this GACC will accept CIM by June 1st.
- Crews – all IHC intend to stand up as T1.
- Smokejumper refreshers and rookie training occurring. Minimal turnover this year.
- 20 Airtankers on contract this year; with CWNs, up to 30.
- Do expect some shortages if multiple areas become busy concurrently. Will experience supply chain shortages. Cache experiencing some staffing shortages as well. Shipping will also be challenging due to truck availability.
- Dispatch centers are also experiencing staffing struggles.
- Aviation Updates:
 - Region 1 pilot staffing will be at 30%.
 - Will struggle to provide 7-day staffing for two Sherpas.
 - One lead plane trainee within Region 1, expect him to be fully qualified early in fire season.
 - Down two Rappel crews nationally due to contracting.
 - At least two helicopter vendors are not fully staffing available helicopters due to contracting.

- Light Fixed Wing contract still in process with the Washington Office (WO). Hope modified CWN will be temporary fix.
- Fortress 200 will be tested out of Ronan in the seats.
- Should have Fixed Wing Program Manager position filled prior to fire season.
- UAS – Standard ordering for NRM projects is on the NRCC webpage; fire will be updated with flow chart guidance soon. It is currently being looked at to facilitate as much standardization with the National Office as possible.

NRCC Spring Report – Kathy Pipkin

- Crew coordinator position is now vacant. DNRC is working on filling behind.
- Meteorologist position also now vacant. Short term plan to utilize retired meteorologist; BLM and FWS are working on filling positions.
- Outreached for two 120 details for Overhead desk; were only able to fill one. Individual is slated to come on in May.
- Working on hiring front desk position.
- Calving Miller's detail ends at the end of June and working on a second detailer.
- Staffing will be challenging; will be relying on AD workforce for support during the season.
- Working on transitioning the mobilization guide to be a supplement to the National Mobilization Guide. Hope to publish at the end of May.
- Website modernization project in the works.
- NRDRSv4 transition in WIMS is still on track for archiving by the end of May. Energy Release Component (ERC) graphs on web page do have broken links due to this process. Seven-day significant fire potential analysis is complete and are waiting for implementation approval.
- RIST detailer, Billy Philips, is slated to begin Monday.

Incident Prioritization – Fires Comparison Spreadsheet – Kate Holsapple and Rick Stratton

- Need exists to leverage new science and technology into prioritization process.
- ([Fires Comparison Matrix PowerPoint](#) – please note, must have FireNet NR_Coordinating Group Team access.)
- Proposal – Looking to replace Incident Prioritization Worksheet (IPW) and Criterium Decision Plus with this Fire Comparison Matrix. Criterium Decision Plus is no longer supported on the USFS network. Other drivers towards this proposal are that it significantly streamlines and increases efficiency.
- Intelligence function would bring the matrix, along with the radar charts, in addition to information gathered on calls, and would compile a recommendation. Would also be prepared to discuss the limiting factors that are not represented by the matrix. Intelligence function would then document any adjustments and the corresponding rationale.
- Corey Buhl – For prioritization this year at NRCC, this could be appropriate at the zone level.

NRTC Update and Trainee Priorities – Melissa Wegner

- Staff update – filled vacant BIA position; appreciate all efforts from everyone that went into that process. Billy Philips will be detailed into a temporary promotion into the RIST coordinator position. Billy is also a key part of IMRR. Matt Gibson continues to be instrumental in distributing the El Dorado case study out to the field. He is also a key link in innovative learning and training. Lydia Faller continues to perform essential duties and responsibilities, including providing MAC documentation support last year.
- 1,078 nominations processed; with two courses yet to go. 569 selected students.
- Cadre participation was increased to meet student to lead ratio. 206 unique individuals participating.
- Looking towards the future, anticipate that will have more in person training. Will also be remaining flexible.
- Priority Trainee Program – as approved in February, all trainees in the Northern Rockies will be considered priority trainees, as long as they are in the qualifications within the priority trainee program.
- Only item that changed is that there is now no application period. All else remains the same. Encouraged all to reach out with individuals with known limited availability periods.

Northern Rockies Contracting Update – Ryan Patrick

- Working through technical evaluations for heavy equipment with water and water handling.
- Weed Washing under VIPER this year, conducting technical evaluations as well.
- Process has evolved much from the past. Information is also gathered from pictures obtained during the winter. This comes with certain challenges. Coordinating with multiple Contracting Officers (CO) is more challenging from coordination with the historical, two COs.
- Looking for assistance with coordination of inspector workshop. Need exists and capacity is low.
- Brian Weber will be detailed into this position. (Ryan Patrick taking a detail.)
- Regarding workload, if nothing changes pertaining to assistance, then will need to prioritize the contract workforce that do have currently. Workload has increased significantly from historical perspective. Prioritization will be needed.

Northern Rockies Cache Update – Jordan McKnight

- Personnel
 - NRK currently at 40% staffing, 1 person in front office.
 - 100% vacancy in front office projected. Will not have anyone in an administrative capacity at the cache any time soon.
 - Potential of new, untrained hires late spring
 - Not currently staffed to allow for 7 day a week coverage

- No depth to cover staff absences.
 - Loss of experience will lead to less production.
- Equipment Issue
 - Probable shortages: shelters, pump parts, oil, chaps, gloves, hose, fittings, medical kits, hot food. Additionally, containers, flight helmets, hose rollers, pyro, batteries, and other items we have not considered.
- Potential Operational Issues
 - Cache to Incident trucking in question.
 - Trucking contracts and medical have been moved to the national contracting level.
 - National Medical Contract unknown status.
 - Lack of temp laborers (pay, fuel costs).
 - Temporary labor – are finding that the pay is not competitive; AD drivers are citing pay and fuel cost.
 - Detailers are also in critical shortage.
 - Trucking will be a large issue. Now is going through a brokerage in Florida; where used to utilize ones that were familiar with the area.
- Be prepared
- Some incidents may need to pick up supplies; will prioritize deliveries to smaller incidents.
- Discussed communication and what it will look like this year regarding prioritization.

SW MT Zone Prevention Team – Chris Johnson

2021 Summary

- Seated for the equivalent amount of time for “six rolls” for this team.
- Anticipate meeting virtually for another 92 days for 2022.
- Benefit to having a team working remotely is increased team member availability.
- Will most likely continue the “Treasure Our State” campaign and promote the [Montana Wildland Fire Information website](#). Website will be utilized as both a fire information and restrictions platform.
- Are recruiting individuals to build bench strength and expand the capacity of the support area.
- Team assists with ensuring consistent messaging.
- No ask of this board for funding; however, efforts are underway to obtain funding through individual agencies.

2022 Campaigns and Recruitment

- Team will be seated again for the upcoming season.
- Spreadsheet and survey went out to gather interest and recruit interested individuals.

NRCG Restrictions and Closures Guide - 2022 Update

- [Montana Wildland Fire Information website](#) – intended to be a “one stop shop” for public and users.
- Last year only had one single POC for all orders and updates throughout the summer. Workload necessitates changes for 2022. Are now moving that to the area restrictions coordinators.
- Idaho and the other states have their own platforms.

- [NRCG Restrictions and Closures Guidelines](#) document is updated, 508 compliant, and on the NRCG webpage. Provided some template language with the goal of avoiding conflicting language.

Heavy Equipment Task Force Updates – Jordan McKnight

- Emphasized that all recognized the importance and value of this resource in the Northern Rockies.
- Are somewhat restrained in how can utilize regarding supervision.

- Concerns from incident business and finance side regarding incorrect and incomplete shift tickets and how this affects the payment processing.
- Agreements expire at the end of next year.

Thursday April 21, 2022 – Morning – General Session

IT Update – Tara Dana

- Received funding and were able to purchase equipment for multiple IMTs.
- Currently are distributing that equipment; form has been distributed to the IMTs and closes closes on April 28th. Will be open to dispatch centers afterwards.
- BPA for rental IT equipment in place. Are able to change licensing and there will be return labels provided. Will now use an online ordering portal. Do still have the ability to utilize local vendors.

Dispatch Complexity Update – Craig Glazier, Gaylen Yeates and Kat Sorenson

- Reviewed the previously released complexity analysis.
- ([Dispatch Complexity Update PowerPoint](#) – please note, must have FireNet NR_Coordinating Group Team access.)
- Identified items with which agency leaders and managers can assist:
 - 90 fire requirement is a hinderance.
 - Lack of cross-walk from operations to dispatch.
 - Support of work environment.
- Sarah Lee – important to message potential next steps regarding consolidation appropriately, emphasizing the benefits of increased coverage and improved work/life balance.
- Important to note that consolidation is a tool and will not fix recruitment or retention.

- Rich Cowger – issues seem similar to other emergency response dispatch centers. Wonder if there are opportunities to co-locate or co-join with local 911 dispatch centers.
- Gaylen Yeates – next Monday will have the Northern Rockies Dispatcher’s workshop and will be recruiting for individuals to replace departing member of the dispatch steering committee. Will continue work on the next steps of this tasking.

Rapid Extraction Module Support (REMS) – Cost, Rate and Intent Discussion – Sarah Lee

- The Business Committee added REMS configuration information to the NR Chapter 20 (Acquisition) supplement for incident-only contracting in 2019 after a NRCG task group developed the basic configuration. Rapid Extraction Module Support (REMS) is an extraction team that provides technical expertise in the use of Low Angle Rescue Operations, High Angle Rope Rescue Operations, and advanced terrain extraction techniques. The Business Committee has not added a rate suggestion to the NR Supplement, as the NRCG BOD previously agreed that local/county resources have legal authority and should be the first source to provide rapid extraction support - refer to [NRCG 2018 Memo on REMS](#).
- In 2021, we saw an increased reliance on REMS as a long-term (14 day or longer assignments) solution to a lack of EMS resources in the system, such as EMTs and ambulances. The use occurred more frequently with out of area IMTs. This deviation from the NRCG original intent in the 2018 memo (estimated that only 5% of NR fire operations occur in environments requiring REMS and that IMTs are expected to release REMS units when no longer needed) raised concerns within the incident business community regarding appropriateness and cost. We currently don’t have established rates in Chapter 20 for REMS; however, contract vendor pricing last year averaged \$7000/day. Additionally, there are multi-state licensing concerns.
- The Business Committee is asking the current Board to review the [2018 NRCG BOD guidance](#) for REMS and provide the Business Committee additional direction:
 - If NRCG BOD wishes to retain the specifications in Chapter 20, do rates need to be established? (If so, establishment of a rate will need to be tasked to Ryan Patrick’s staff, as the Business Committee does not establish contract rates or specifications.)
 - The Business Committee suggests removing the detailed information on REMS from Chapter 20 (Acquisition), and instead directing readers to Chapter 50 (Cooperative Relations) which outlines local government capabilities and rates for local government resources.
 - The Business Committee asks BOD members to refresh their Agency Administrators on the 2018 NRCG Memo, especially to reiterate, “Agency Administrators and IMTs also should look seriously at tactical plans that put resources at high risk in high-angle situations where there are limited values at risk, or where operational risk management would lead to another tactic.”
- Rich Cowger – have experienced multiple times when REMS have sat idle for fourteen-day assignments. Agree with Corey Buhl that the 2018 guidance is still valid.
- Patrick Lonergan – support recommendation to remove from chapter 20 and support the 2018 memo.
- Sarah Lee – suggestion to add verbiage to the out of GACC letter that would highlight this topic.
- Bryce Rogers – support the removal from Chapter 20 and agree that the 2018 memo is valid.

- Paul Cerda – may need look at requiring justifications for REMS ordering. Support editing the verbiage to “technical rescue”.
 - Vote on Proposal to remove language from chapter 20, revise the 2018 REMS Guidance and add appropriate verbiage to the Out of GACC letter.

- Recommendation to have dispatch centers continue the coordination of pre-use inspections.
 - Acknowledged this is unpopular with dispatch centers; however, all alternatives have capacity issues.
- Kathy Pipkin – centers do not have inspectors.
- Corey Buhl – centers don't have the personnel or capacity for this workload either.
- Jordan McKnight – recommendation protects both the contractors and the agency administrators to some degree. Acknowledged that there is not a surplus of individuals to accomplish this work. Determining the route will help prioritize the workload. Desired end state would be a memo from the Board outlining expectations and process.
- Kathy Pipkin – this is not a dispatch issue; is a shortage issue. Inspectors are an ordered resource, just like any other resource. Agency issue to get individuals trained. Dispatch does not have this capacity. Historically have better success filling inspector positions on incidents.
- Corey Buhl – other GACCs do not always accomplish pre-use inspection and when that occurs, it is listed in documentation.
- Chad Pickering – for the greater Missoula area, have built an inspection site at the AFD. Does come down to who operates. Do need that capacity. Will be a nice site, if can staff.
- Aaron Thompson – would like more information regarding what other GACCs are doing and clarification on the minimum that must be done.
- Ryan Patrick – Changes occurred to the process when IBPAs when to a national level. Important to note associated Lessons Learned that noted a better inspection process was needed. Need exists to do more than the minimum acceptance. Recommendation to have dispatch centers coordinate and work together as a group to build capacity. Desire is for direction from the board as to where the GACC wants to be moving forward.
- Jordan McKnight – if BOD would like to see any follow up, or changes, or more information added to the briefing papers, that would help to fine tune those documents. Ryan Patrick has accepted a new position and his current position will be vacant.
- **Action Item - Re-distribute briefing papers for BOD review and place on the October agenda for more focused discussion.**

Tuesday November 08, 2022 – General Session**National Report / Update Aitor**

- Significant Investments at the National Level:
 - AAR Performed on CIM in October
 - Training Systems Improvement Project – utilizes some of the BIL funding and is moving forward. Taking existing competences and taking a deeper dive into how those are identified and supported in the future. More will come on how competencies and training are evaluated in the future. Currently SME groups are breaking down by functional areas. Multiple products will result from this effort. Goal is less duplication and efficiency increase.
 - Stepped up investment in Learning Management System
 - Emergency Medical Committee is actively engaging in multiple aspects as well.
 - Fuels Committee is working on Escape Fire Commonalities. Analytics are being compiled.
- Multiple Leadership Changes are also occurring.
- NMAC memo issued regarding evolution of Area Command.

Northern Rockies Operational Updates – Corey Buhl

- Tasking Update – List of Critical Support Positions for IMTs - Reviewed survey results regarding challenging positions to fill. White Paper will be distributed for full BOD review.
 - Josh Harvey will present this information to the WFAA group later this week.
 - Aaron Thompson – noted that the need exists to explore different ways of conducting business moving forward, particularly given the national lack of some qualification capacity.
- Tasking Update – T3 SOPs – any created should not vary a great deal from other types of team SOPs. Will present at next months meeting.

NRCC Fall Report – Kathy Pipkin

- Both experienced and were challenged by multiple traumatic events this year. (Health, loss of family members to natural disaster/event, loss of staff to medical, and an active shooter) Staff commended for performing exceptionally.
- Had detailers in the Center Manager position for most months.
- Fire Analyst position assisted greatly as well.
- Appreciated detailed meteorologist as well. BLM meteorologist position now filled.
- Administrative position is now filled as well.
- Working with HR to fill permanent Coordinator position.
- USFS is working on a permanent Fire Analyst position that would also assist NRCC.
- Working to fill the FWS meteorologist position still.
- Reviewed Volume of Business report.
- Would like feedback from NRCG regarding new prioritization process.
- Taking forward several issues to agency leadership:
 - Lack of consistency across agencies with dispatch PDs.
 - Technology does not allow for what business needs require.

- Consolidated Dispatch training will occur at the end of March. Will include aviation dispatcher training and WildCad-e. (New WildCad will be coming online soon after that time.)
- Aaron Thompson – noted that the BLM is standing up a National Dispatch Committee.
- Craig Glazier – WFAA group working on a proposal to continue Dispatch Review work.

Northern Rockies Contracting Update – Brian Webber and Jordan McKnight

- (Reviewed [Contracting Updates PowerPoint](#))
- Worked through the summer with two detailers.
- With changes in the contracting group, were unable to have the CO inspectors look over the water handling inspections.
- Changes in process may soon allow for pick up of new equipment during the season. More to come on that later.
- Contracting positions are still working through the hiring process. Hoping for certs in November.
- Noted shortage of inspectors and ICPIs. Inspector workshops are greatly needed.

NRCG Financial Plan Review – Jeni Jeresek

- Reviewed a [draft plan](#) compiled with historical formulas.
- Ask moving forward is to schedule a meeting for early February to vote on final plan.
- Will distribute the cost by agency for individual BOD review and verification.
- AFD Operating Plan (Agreement) expires at the end of May and requires updating. Will distribute this for BOD review as we.
 - Kathy Pipkin has begun editing the agreement regarding positions. Discussions needed around included positions.
- Draft does list \$2,000 for IMTs.

Complex Incident Management (CIM) Efforts Update – [Jesse Bender](#), IWDG Manager

- Committee is finalizing positions and task books regarding CIM.
- January [PMS 310-1](#) update will include these positions.
- Field Evaluation will continue to be an option through 2023. Will also provide more guidance and best management practices on how to complete those evaluations. Inclusion of this was based upon received feedback.
- Working on revised [PMS 236](#) as well. Emphasis on drilled down complexities.
- WFDSS for 2023 will remain the same.
- Also working on recommendation for National CIM rotation and guidance on when to order. Rationale is to increase work/life and IMT/day job needs.
 - NMAC will be drafting a memo on this shortly.
 - Full rotation process will be implemented in 2024.
- Also working on a recommendation around team configuration and incident scaling needs. Will come out in correspondence with implementation in 2024.
- NMAC is discussing all CIM IMTs being offered a place on the rotation.
- Implementation for 2024 for all CIM teams.

- Recognized that there are many questions remaining and acknowledge everyone's efforts.
- Will be critical moving forward to speak with a unified voice.
- Noted the interest and collaboration with FEMA regarding these teams.
- Vision is slimmer core teams with additional positions pulled from the pool. One benefit would be standardized operations across the areas. Requires agreed upon, standardized way of doing business and products produced. This would lead to more efficient and more seamless transitions.
- IWG will eventually recommend every area add IMT Coordinator Positions.
- Kathy Pipkin – Northern Rockies does have two full teams CIM qualified.
- Aaron Thompson – important to socialize this concept with Agency Administrators that soon may be utilizing out of area teams more frequently.

NRTC Update / Trainee Priorities - Melissa Wegner

- Two vacancies throughout the summer. Filled one and do have approval to fill another training specialist. Not a new position; rather one that has been on the organization chart for some time without filling.
- BIA filled a position with a temporary promotion.
- Priority Trainees – previous decisions by BOD worked well throughout the season. Did receive pushback from other GATRs. Are looking for national feedback on future of this program.
- Worked with IMTs on field evaluations with CIM.
- Two 520 sessions are being hosted by NAFRI and were able to get five individuals into each session. In addition, were able to get two finance sections chiefs into these sessions.
- Will have more courses on the next schedule. Did extend the nomination deadline.
- Are about a 50/50 ratio for in person and virtual courses.

NRK Fall Update - Anthony Krause

- 107 separate incidents worked this season. End of Year report will be forthcoming.
- Supply Chain issues seem to have eased just a bit.
- Have had some success with hiring; however, vacancies do still exist.
- Were unable to utilize contract worker assistance this season.
- Did lose one vehicle to an accident this year.
- Fell back on a diminished AD driver pool for the majority of shipments.
- Success with weekly logistics chiefs' call; helpful to maximizing resources and associated transportation issues.

NRCG Operating Plan / Handbook – Kathy Pipkin

- Reviewed the two separate pre-reading documents.
- Template version may be more suited to a handbook.
- Suggestion to concentrate effort on template version.
- NRCG Recognition Awards – do have FWS listed twice. Is inclusive of all agencies on the Board, rather than just those on the cost share.
- Include IMT Meeting Facility Payment Rotation.
- May need to add in representatives and liaisons.
- Aaron Thompson – Moved to adopt template as a living document.
