#### **Guest Presentations / Discussions**

- **DECISION | Montana Master Cooperative Fire Agreement Proposed Updates** – CJ Johnson  
CJ presented the proposed amendments to the Montana Master Cooperative Fire Agreement - Statewide Operating Plan, which include updates to streamline interagency coordination and clarify cost-sharing and resource mobilization procedures. Notable changes include removing Great Falls Dispatch due to consolidation with Helena, updating administrative references, and reinforcing the role of Local Government Fire Forces (LGFF) under DNRC agreements. Mutual Aid guidance was revised to remove the hour requirement as well as increased the minimum billing threshold between DNRC and federal agencies increased to \$10,000. DNRC also proposed clarifications on state aircraft use, allowing deployment on federally protected lands under emergency conditions with federal line officer approval. CJ emphasized that if approved, these updates need to be socialized. Additionally, the proposed updates will be reviewed by the USFS Washington Office before formal adoption. *[Attachment 1 is included for specific reference of proposed changes]*
  - DECISION: The six agencies party to the Montana Master Cooperative Fire Protection Agreement were all in support of the proposed revisions (BIA, BLM, FWS, MT DNRC, NPS, USFS).
- **INFORMATIONAL | Contracted Medical Direction – Status Update & Impacts** – Dave Williams
  - o The Northern Rockies Incident Medical Specialist (IMS) Program is currently without a medical direction contract for the 2025 fire season following the expiration of Dr. Southard's agreement, which impacts all agency-affiliated medical personnel (MEDLs, EMTs, Paramedics) operating under this program. Since Montana requires medical direction for providers above basic EMT, the absence of a new contract limits the use of these trained resources, increasing reliance on contracted providers who bring their own medical oversight. The IMS Program, which supports approximately 150 personnel across multiple agencies and includes a significant number of AD and EFF staff, was built to standardize medical support and training. Local medical oversight from jurisdictions like rural fire districts may offer a temporary solution. Two \$25K contracts have been submitted to re-establish medical direction, and NRCG has requested continued updates and collaboration on potential solutions, with Rich Cowger planning to follow up with Dave Williams offline.

## **Standing Reports**

- **NWCG/NMAC Update:** Aitor Bidaburu provided an NWCG/NMAC update noting that the team request form will be posted on the NICC website. Key topics included ongoing interagency coordination around fatigue management and BUYT situations, as well as international IMT coordination. The Incident Workforce Development Group (IWDG) will now report solely to NMAC due to its significant progress. Jesse Bender's position will not be backfilled; a collateral duty replacement will be sought. On the NWCG side, REMS standards for Type 1, 2, and 3 incidents are expected to be approved this week.
- **CGAC Report Out:** Dennis Strange shared a CGAC update highlighting several national coordination efforts. He committed to sharing meeting notes more promptly. NMAC is working to improve the timeliness of its updates as well. Key topics included impacts to buying teams and the development of a DOI AIMS plan, continued focus on fatigue mitigation practices across IMTs, and readiness efforts at Fort Carson for military support. Changes were noted in the CIMT request process—narratives are no longer required, and standardized situational awareness inputs will be expected, especially at Preparedness Levels 4/5 or when requesting replacement teams. NRCG will need to determine how to implement this new process. Increased catering contract thresholds may become an issue this season (200-person threshold) and IWDG will now report solely to NMAC.
- **NRCC Operations Updates:** Corey Buhl provided an NRCC Operations update, noting that while recent fire activity in Idaho, North Dakota, and Montana was generally well-managed, some units lacked full staffing and required resources from outside the NRGA. Communication with affected units was effective, offering a good test of existing processes. However, some resources were tied up with prescribed fire and unavailable for wildfire response. Early and frequent support from outside the GACC is expected this season.
- **NRCC Update:** Kate Holsapple shared that recent rain has freed up resources, allowing support to the Southwest and Eastern Areas. NRCC is wrapping up pre-season projects and workshops, including the Aircraft Dispatcher workshop this week and recent RIST sessions. The crew desk is onboarding new staff, with Dani Goodson joining from the Lolo Hotshots. Kate will be out for June, with Jay serving as acting center manager starting June 5.
- **NRCG Committee Updates:**
  - Dispatch Committee (Craig Glazier): No updates since last meeting.
  - Operations Committee (Tate Fischer) – *notes submitted via email*
    - The committee continues to ebb and flow between accomplishing taskings to being informational only, currently in a lull,
      - Discussion around needing more Operation Section Chiefs on the committee (added one late last year), if the group is going to complete tasking versus being operational,
      - Numerous opinions and discussion points that tie back to *our face-to-face discussion regarding Operations vs ICs committees*.
    - Zones: Anywhere from fully staffed to 70% vacancy, Lacking mid-level leadership.
    - Agencies: All down in staffing. 25-30% vacancy, down by 5-6 engine captains, “functional but not optimal”; Need to “keep expectations in alignment with reality”.
    - Approval of BLM’s Woodhawk WFM
  - Training Committee (Dennis Strange) – Committee is working on drafting comments on operating plan and will share when available.

## **Old Business**

- **UPDATE | IMT SOP/SOG Status** – Beau Richardson reported that the IMT SOP/SOG update is nearly complete, with most revisions focused on IC and IMT member recruitment and selection, updated CIM and Type 3 configurations, and refreshed links and references. The draft will be sent to the IC Committee and is intended to be integrated into the NRCG Operations Plan.
- **UPDATE | Status with WFAAs** – Agency Representative Report Outs
  - BLM supports renaming the Fire Executives Group to WFAA and is open to the group meeting. A request was made to organize a meeting.
- **DISCUSSION | Health of IMT Roster Status**
  - Aaron Thompson reported minimal changes to Team 8’s roster, though uncertainty remains about agency employees’ availability.
  - DNRC’s intake process currently includes only five names, all tied to Team 2, but the list will remain

open.

- Josh Harvey sent IDL's intake process letter – Karly will share with NRCG.
- BIA noted impact from DRP, as a few fire personnel opted in.
- **UPDATE | NRCG Operating Guide** - Karly has finalized the document and included all edits - will route for signature.
- **TABLE ACTION | DCAT Reports** – A recommendation was made to table the DCAT Reports discussion until the fall meeting and requested an official tasking to define the task, purpose, and end state. A future NRCG meeting in September is proposed to receive a briefing from Kate on the reports and their potential. Kate also noted a national effort to roll out a related tool.

#### **New Business**

- **DECISION | Review & Approval of NR Mobilization Guide** - Kate Holsapple outlined the errata prereading document [*Attachment 2 is included for reference*]. One key update not included in the errata letter is the reclassification of Chief Mountain from a Type 1 IHC to a Type 2 crew.
  - **DECISION:** All agencies in attendance supported the NR Mobilization Guide updates unanimously (IDL and NDFS were not in attendance).
- Round Robin
  - MT Governor's Fire Briefing will take place on June 2 in Helena, MT.

SUBJECT: 2025 Northern Rockies Interagency Standards for Resource Mobilization

Attached is the 2025 Northern Rockies Interagency Standards for Resource Mobilization. These standards are written to reflect the interagency needs of the user and are referenced as 'NR Supplements' in blue italicized font throughout the document. This publication will be an online version only; agencies and/or individuals may print as needed locally.

The Northern Rockies Interagency Standards for Resource Mobilization states, references, or supplements policy and for Bureau of Land Management, U.S. Forest Service, U.S. Fish and Wildlife Service, National Park Service, Bureau of Indian Affairs, Idaho Department of Lands, Montana Department of Natural Resources and Conservation and North Dakota Forest Service.

The signatory agencies have directed the Northern Rockies Coordination Center (NRCC) with review and oversight from the Northern Rockies Coordinating Group (NRCG) to annually revise, publish, and distribute the Northern Rockies Interagency Standards for Resource Mobilization by June 1, and issue errata to this document.

The Northern Rockies Interagency Standards for Resource Mobilization establishes the standards for mobilization and demobilization of resources in response to wildland fire and all-hazard events. It is tiered off the National Interagency Standards for Resource Mobilization which is the foundational document instituting overarching processes for total mobility of resources.

Suggestions for modification of the publication can be submitted at any time during the calendar year. The Northern Rockies Coordination Center will accept suggestions for changes either through your signatory agency, through your Local Dispatch Center, or through established interagency organizations such as NRCG Committees. April 1 will be the cut off for changes to be considered for current publication year.

Northern Rockies Coordination Center will present all recommended changes to NRCG for their final acceptance and approval. The [change request form](#) can be found on the [NRCC website](#).
