1 STATE CLAIMS FILING

2 **State of Montana Claims.** Claims arising under the jurisdiction of the State of Montana are negotiated by
3 the responsible line officer or his or her designee, who must be on the DNRC Approved Signers List. For
4 information on handling claims against the DNRC, see the 300-Incident Business Management Manual,
5 Chapter 370, Claims Against the State of Montana, found at:

9 **State of Idaho Claims.** Settlements arising under the jurisdiction of the State of Idaho must be submitted
10 in writing to the IDL host agency. The IDL host agency will submit the claim documentation to the Fire
11 Business Program Manager, Bureau of Fire Management, who may settle the claim or forward it to Risk
12 Management for final determination. Claims may also be submitted in writing to the Fire Business
13 Program Manager, Bureau of Fire Management, 3284 West Industrial Loop, Coeur d'Alene, ID, 83815-

16 **State of North Dakota Claims.** Claims against the state must be presented in writing to the Director of
17 Office of Management and Budget. The claim must be filed within 180 days of when the alleged injury or
18 property damage was discovered. Claim forms may be requested from the Office of Management and

21 **State of South Dakota Claims.** Although a small portion of South Dakota is in the Northern Rockies
