Strategic Intent:

1. Continue to emphasize public and firefighter safety while stabilizing incidents so that communities can return to normal activities.
2. Utilize resources efficiently so that we enhance initial attack response and capability to manage emerging and large incidents.

2	North Star	WA-COA	E. Lewis	Level 1, 2 and 3 evacuations in place; Highway 21 remains closed; Structure protection along Highway 21; Highway 155 has a partial closure.
3	Tunk Block	WA-NES	E. Lewis	Level 1, 2 and 3 evacuations in place; Highways 20 and 155 are closed to public; Structure protection in place
4	Carpenter Road	WA-NES	D. Johnson	Level 1 evacuations in place; implementing direct operations
5	Okanogan Complex	WA-NES	M. Minton	Level 1 evacuations in place; looking for opportunities to go direct
6	Canyon Creek Complex	OR-MAF	B. Goff	Level 1 evacuations in place; assessing indirect strategy

9	Kettle Complex	WA-COF	C. Schulte	Level 1 evacuations in place; implementing direct strategy
10	Cougar Creek	WA-YAA	M. Wakoski	Implementing direct strategy on north flank; TOC to IMT3 on 9/9
11	Kaniksu Complex	WA-COF	T. Kurth	Beginning action on lower priority fires in the complex
12	First Creek	WA-OWF	C. Templin	Level 1 evacuations in place; mopping up
