

# TEMPORARY CAMPFIRE PROHIBITION

DESCHUTES NATIONAL FOREST

Order#: 06-01-01-24-02

Pursuant to 16 U.S.C. 551, 36 C.F.R. § 261.50(a), the following acts are prohibited on National Forest System lands in the Bend-Fort Rock Ranger District of the Deschutes National Forest, described further below and shown on the attached map incorporated into this Order as Exhibit A (Temporary Campfire Prohibition). This Order is effective June 1, 2024, through November 30, 2024, or until rescinded.

## **PROHIBITION:**

Building, maintaining, attending or using a fire, campfire or stove fire, including a charcoal fire.  
**36 C.F.R. § 261.52(a).**

**AFFECTED AREA/ CLOSURE AREA:** All legal descriptions are located within the Bend-Fort Rock Ranger District and described as follows:

### **Point of Beginning -**

Starting in T. 18 S., R. 12 E., section 29 at the northern border of the Deschutes National Forest (DNF) boundary, following the northern boundary east through T. 18 S., R. 12 E., sections 29, 28, 27, and 26. At the section line between section 26 and 25, following the DNF boundary south and then east to the junction of the DNF boundary and National Forest System Road (NFSR) 1815 in T. 18 S., R. 12 E., section 36. Following NFSR 1815 south through section 36, T 19 S., R. 12 E., section 1 and 2 to junction of NFSR 1815 and NFSR 18 in section 2. Follow NFSR 18 east to junction with NFSR 18 and 300 spur in section 12. Following 300 spur south to junction with 210 spur in section 13. Follow 210 spur to junction with 200 spur in section 13. Follow 200 spur to north to junction with 100 spur in section 13. Follow 100 spur west to junction with NFSR 1810 in section 14. Follow NFSR 1810 to junction with NFSR 18 in section 2. Following NFSR 18 northwest to the junction of NFSR 9701 in T. 19 S., R. 12 E., section 3. Following NFSR 9701 to the junction with NFSR 9701600 in T. 19 S., R. 12 E., section 5. Following NFSR 9701600 to northwest to junction of Highway US 97 in T. 19 S, R 11 E, Section 1. Following US 97 to section line dividing T. 19 S, R 12 E, section 6 and T. 18 S, R 12 E, section 31. Following East on the section 31 line before turning north following the east side of section 31 and 30 to the starting point in section 29.

## **EXEMPTIONS:**

Pursuant to 36 C.F.R. § 261.50(e), the following are exempt from this order:

1. Persons with Forest Service Permit No. FS-7700-48 (Permit for Use of Roads, Trails, or Areas Restricted by Regulation or Order) specifically authorizing the otherwise prohibited act or omission.
2. Any Federal, State or Local Officer or member of an organized firefighting force in the performance of an official duty.
3. Petroleum-fueled stoves, lanterns or heating devices, provided such devices meet the fire underwriter's specifications for safety.

This prohibition is in addition to the general prohibitions in 36 C.F.R. Part 261, Subpart A.

Violation of this prohibition is punishable by a fine of not more than \$5,000 for an individual or \$10,000 for an organization, or imprisonment for not more than 6 months, or both (16 USC§ 551; 18 USC§§ 3551, 3559, 3571, and 3581).
