Equipment

All equipment and supply orders will follow established ordering procedures (Type 1, 2, 3 incidents), except for the redistribution of supplies within the National Fire Equipment System (NFES).

Redistribution of excess supply items will be coordinated by the designated NFES Cache Manager(s).

Federal Engine Rotation

The engine rotation is set by the FMOs and the Forest Fire Staff each spring and typically resumes where the rotation ended the previous fall. The rotation is posted on the CWICC webpage under "USFS Engine Rotation."

The rotation is designed to give engines an equal opportunity to mobilize to large fires. The Forest Duty Officer will approve whether or not an engine is available when fire danger is high and/or extreme. Otherwise, CWICC personnel will follow the rotation to the best of their ability when filling engine orders. If a district turns down an assignment, the next district on the rotation will be called, and so forth.

Federal Contract/Agreement Equipment

The Forest Service has a menagerie of competitive preseason Incident Blanket Purchase Agreements (I-BPAs) for firefighting equipment. IBPAs are awarded through a best value process and are requested by utilizing a Dispatch Priority List (DPL). The following IBPAs, also known as VIPR equipment, are hosted by CWICC:

- Water handling (Engines & Tenders)
- Fallers, Single and Modules
- Mechanics with Service Trucks
- Potable Water, Gray Water, and Hand Washing Trailers
- Refrigerated Trailers
- Weed Washing Units
- Heavy Equipment with Water (Skidgine, Pumpercat, Soft Track)
- Heavy Equipment (Dozer with transport and Excavator with transport)
- Misc. Equipment (Feller Bunchers, Masticators/Mulchers, Skidders, Road Graders)

- Fuel Tenders
- Busses
- Chippers
- Vehicles with Drivers

NOTE: Check VIPR regularly for updated/added types of equipment.

DPLs for these agreements can be found at: http://www.fs.fed.us/business/incident/dispatch.php. Dispatchers at CWICC will follow DPLs to the best of their ability when ordering resources for federal fires.

Demobilization: The Incident Commander will determine the priority of demobilization. Contractors awarded IBPAs should be given priority to remain on the incident over resources with incident-only EERAs. Incident Only Agreements are only valid for the duration of the incident and will be terminated at the end of the incident.

State Contract/Agreement Equipment

As of 2017, the Washington DNR will now honor the rates found in federal VIPR agreements, however, the Department does not honor the Dispatch Priority Lists (DPLs) found in those agreements. CWICC will now utilize VIPR source lists when mobilizing equipment to DNR fires. Dispatchers are allowed to contact vendors closest to the incident before contacting other vendors on the DPL.

The Wildfire Division of the Washington DNR, located in Olympia, has sole responsibility for creating and maintaining preseason agreements with vendors throughout Washington. CWICC will no longer maintain preseason agreements for vendors located in Central Washington. Preseason agreements will be stored in ITEAM.

ITEAM (Incident Training Equipment and Agreement Management)

ITEAM is a web based program that serves as a source list for equipment and services not found in VIPR. The Washington State DNR will start utilizing ITEAM in 2017. This program has historically been used by federal agencies. The ITEAM source list is not a binding agreement and a warranted procurement official will need to issue an Incident Only Emergency Equipment Rental Agreement (EERA) when ITEAM vendors are utilized.

Supplies

CWICC can place orders for NFES items to either the Regional Interagency Cache located in East Wenatchee or the DNR Cache located in Olympia. All orders for NFES items will be placed with one of the two caches, depending on location and jurisdiction.

Items that cannot be supplied through the cache system will be purchased locally by individuals with valid purchase cards.

All supply orders will have a valid supply order number (S#) issued by CWICC.

Type 3/4/5 Incident Ordering

All supply orders will be placed with CWICC through regular ordering channels. Requests for non-cache items will be given an (S#) and purchased locally by an individual with a valid purchase card. Requests for cache items will be placed with either the cache in East Wenatchee or Olympia. Generally, cache personnel will deliver supplies directly to the incident. If cache drivers are not available, CWICC personnel will work with the duty officer to find agency drivers from the district to deliver supplies. In a multiple fire situation, one or two drivers may be stationed at CWICC to serve as "supply runners."

Incident Replacement

Federal Incidents

All requests will be submitted to CWICC on a completed OF-315 (Incident Replacement) form. Cache and local purchase items will be properly identified. Current NFES numbers for cache items are required, as well as the name of the individual making any local purchases. It is also the responsibility of the individual making the local purchases to notify CWICC where the items were purchased. CWICC will not process any OF-315 without a legible duty officer/FMO signature.

If an item was damaged, lost, or stolen on an incident, an OF-289 form will be completed and submitted to CWICC before an (S#) is created. The OF-289 also requires a legible duty officer signature. If the item was damaged during an "accident," a valid and signed accident report is also required. All "questionable" items will need to be approved by the Agency Incident Business Advisor before the order is processed.
