WYOFIRE (Wyoming Fire Incident Readiness Exercise)

We will offer your Fire organizations a variety of training opportunities;

The 3 General Areas of Training for the weekend are;

Structure Protection

Fire Suppression and Mop Up

Water Handling

The Special Single Resource Areas of Operational Training are;

Initial Attack ICT4

Dozer Boss

Fire Prevention Team Member

Fire Investigator

This is an Interagency, hands-on training exercise with a focus on Task Books in all aspects of ICS, Incident Management and Fire Suppression and Prevention.

Participation at WYOFIRE will be covered 100% by a grant that will cover your meals, housing and fuel that is supplied at the camp for your resources.

WYOFIRE 2012

- Training will be conducted as a wildfire incident with various exercises. The various training exercises will be divided up into Divisions and Groups.
- Each exercise will last approximately 4-5 hours each. Your training day may be up to 12 hours on Saturday and conclude the afternoon on Sunday to allow for travel time home.
- The exercise will be managed utilizing the Incident Command System and Operated at a Type 3 level with Type 2 supervision and oversight.
- **Send in your Registration form No Later than May 11, 2012.**
- We are planning on 20-30 engines, 2-3 dozers, 1-2 helicopters and a SEAT. Total attendees are expected to be around 250.
- You will not have any advanced notice of your training or assignments for the exercise. You will be assigned at the Operational Briefing with an IAP.
- You will receive your Training Resource Order by the 23rd of May.
- **You MUST have this Resource Order to check-in** to the Exercise.
- **Check-In will be from about 13:00 to 20:00 hours on Friday June 1st.**
- We are looking for any type wildland engine you may want to send with a minimum of a 2 person crew. Your engine may be staffed by members of other departments if you wish and must be fire ready and have full PPE.
- Red cards are not required for engine staff and operators.
- Red Cards ARE REQUIRED if you are a Trainee (T) and/or requesting a task Book to be evaluated in a position in Operations.
- You may send any Single Resource Types that need specific training such as;

Strike Team, Task Force Leaders, Dozer Bosses, Division Supervisors, Helicopter Managers, Ground Support Unit Leaders, Time Recorders, Dispatchers, Facility Unit Leaders, Resource Unit Leaders, FOBS, Safety Officers, PIO's, Status Check In Recorders, Demob Unit Leaders, etc.

- We are always in need of individuals to work as Trainees as well as Coaches in the Ops, Plans, Logistics and Finance Sections. These positions are critical to the overall success and support of this exercise. Please consider signing up as one and make a difference this fire season.

WYOFIRE 2012

- **WYOFIRE will be operated from the Camp Guernsey Military Post in Guernsey, Wyoming.**
- **This is a secured facility and attendees will be expected to remain on post as long as they are assigned to the exercise.**
- **You will need your Resource Order to get on post and Check-In.**
- **All equipment and personnel must be fire ready. No PPE will be available.**
- **Attendees will be housed in the Barracks with shower accommodations. All meals will be served from the Mess Hall on post and sack lunches will be provided.**
- **You are expected to bring your own sleeping and shower items.**
- **Plan for inclement weather.**
- **You are asked to remain on post when in camp. No freelancing!**

You may register any number of engines, equipment and/or individuals to participate at WYOFIRE. It is your responsibility to ensure that engines, equipment and individuals are staffed properly, including full PPE for a wildland fire assignment with an operator approved by your department. Engines do not have to have a Red-Carded Engine Boss to participate. It is the responsibility of the sending department or agency to ensure the individuals meet their own standards to operate equipment. You may send as many crew members with the engine as may be seated safely. We do not need the names of the crew members until check-in at the incident. Transportation costs are the responsibility of the sending department or agency.
