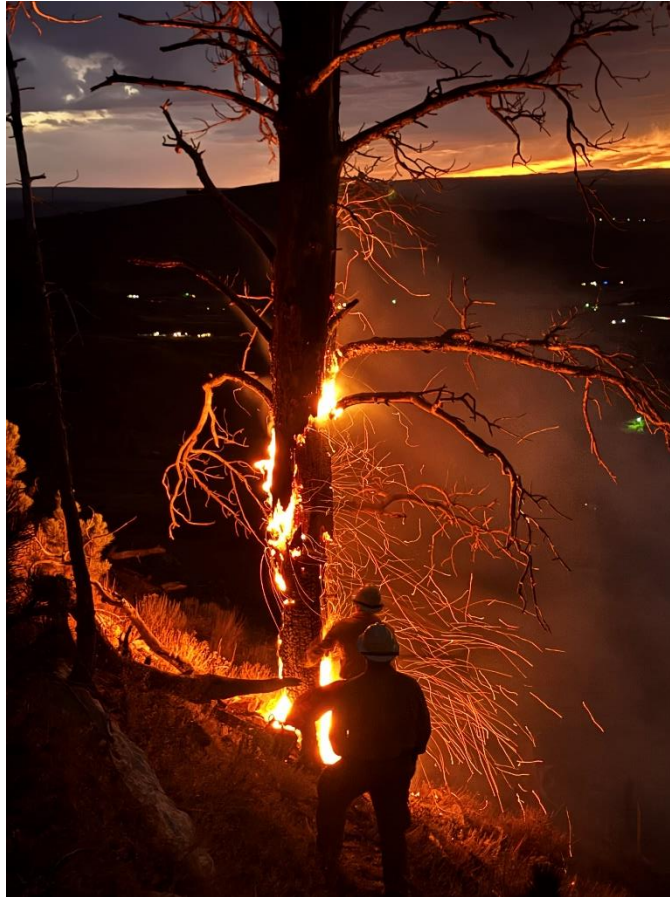

Summary:

Casper Dispatch experienced an average fire season having 321 fires for 14,771 acres. This was slightly above our 10-year average of 306 starts, and well below 92,625 acres. Our first fire occurred February 1st and our last fire occurred December 31st. The dispatch center supported 4 Type 3 incidents.

The High Plains District experienced an average fire season overall. Frequent moisture throughout the season led to increased fuel loading, but each time fuels began to dry out, additional precipitation would arrive. While there were occasional periods of critical fire weather, they were typically short-lived.

In contrast, the High Desert District saw above-average fire danger, with Energy Release Components (ERCs) frequently reaching maximums. Despite the elevated fire danger, new fire starts were limited, resulting in an overall average fire load for the district.

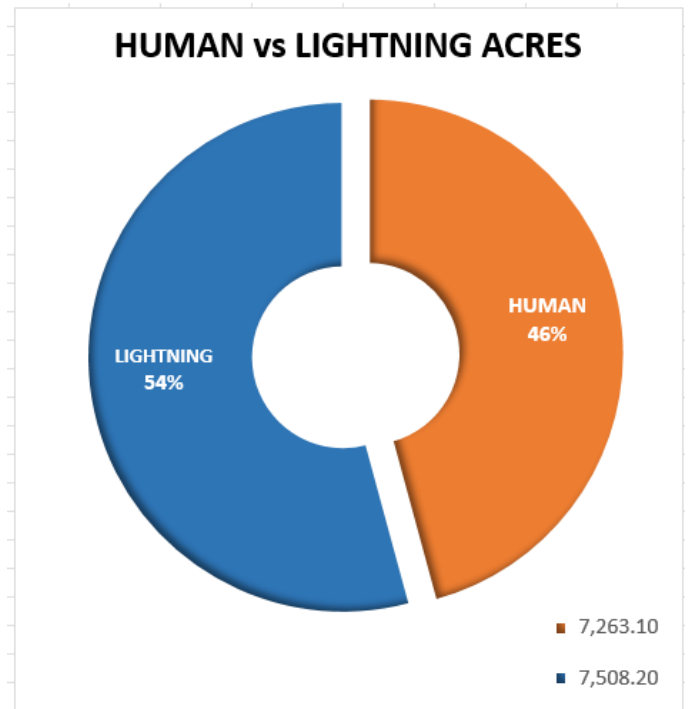
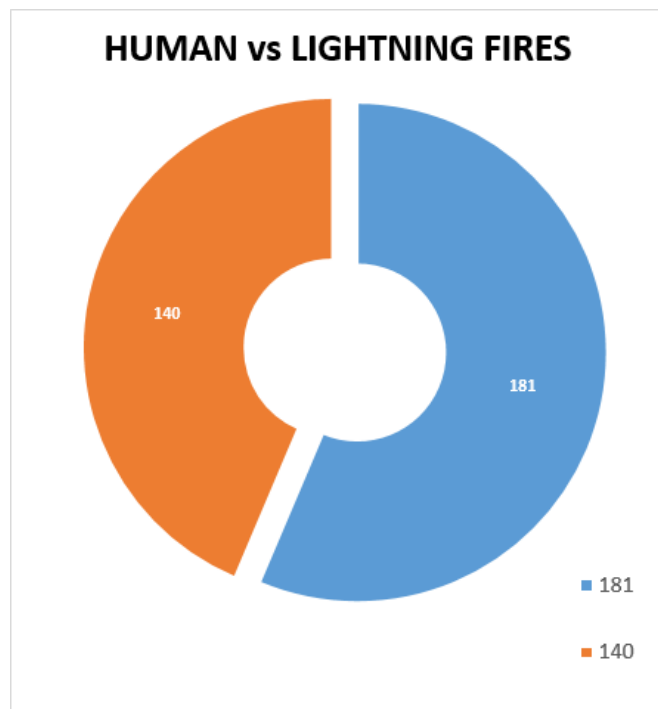
The Medicine Bow National Forest and Thunder Basin National Grasslands saw an average winter, with a dry spring and summer which brought about severe to extreme drought conditions. This led to record lows in the 1,000-hour fuel moistures and record ERC's. Couple storms in the summer did slow down fire activity.

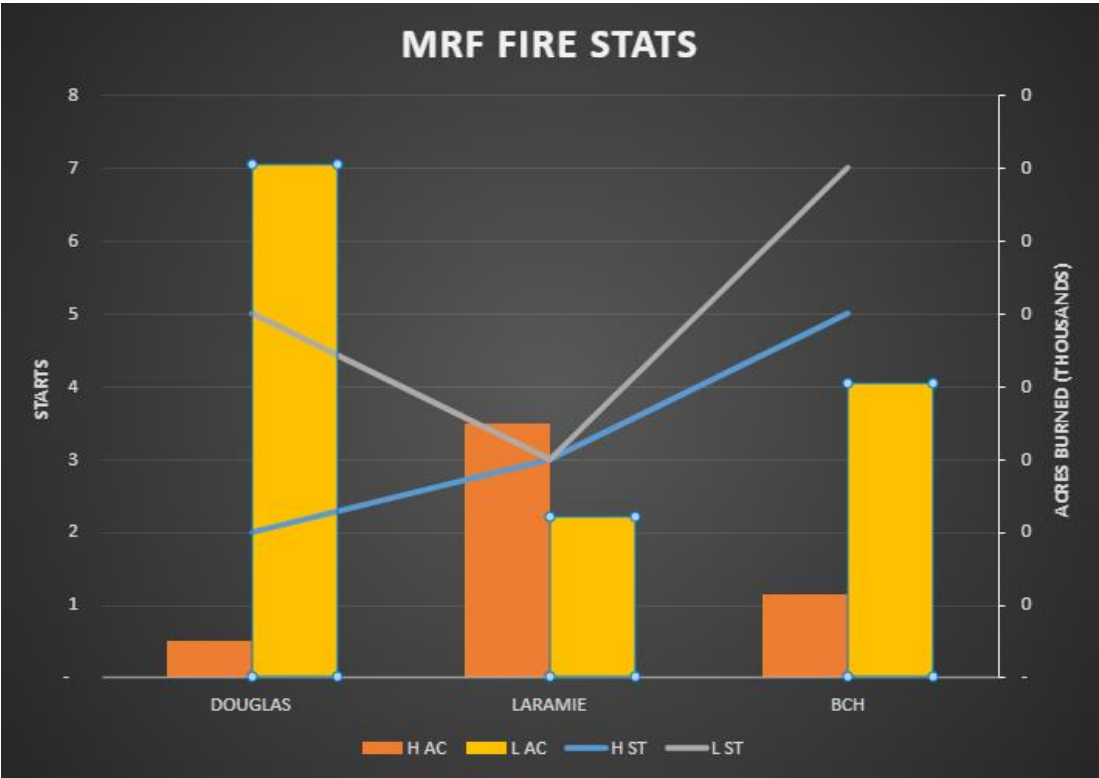
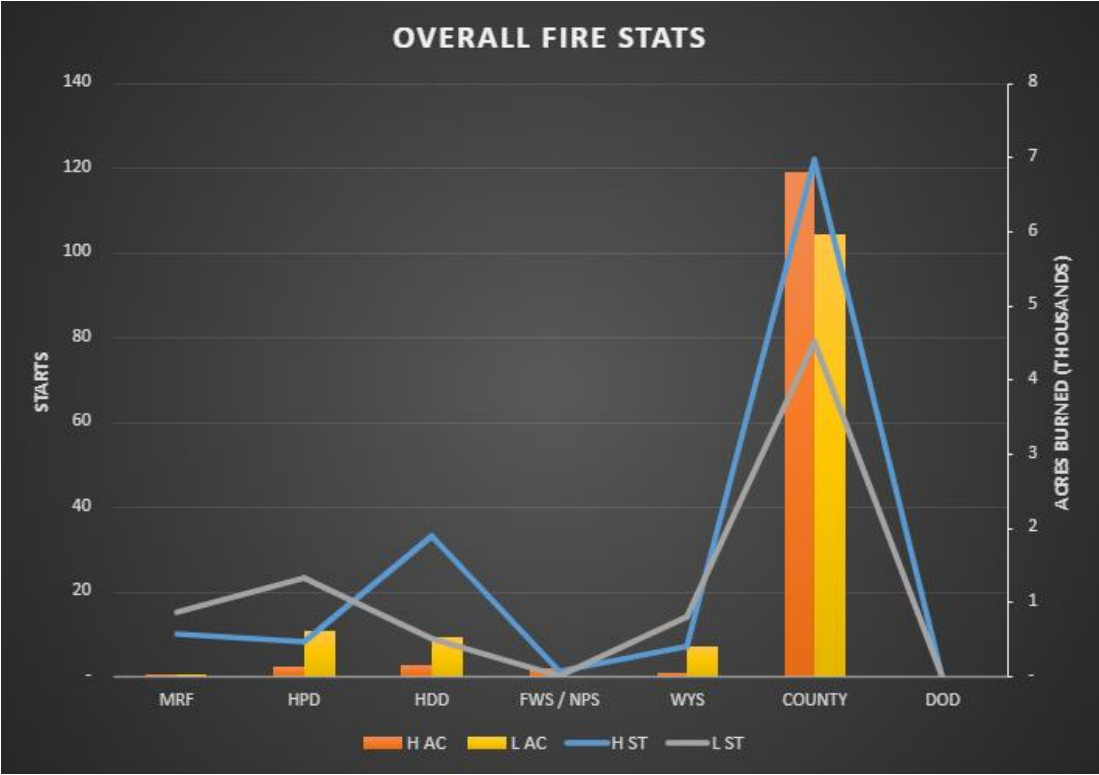
Casper Dispatch mobilized firefighting resources to support out-of-area incidents starting in January and continued to do that into December. In February, the dispatch zone was regularly sending firefighters to the Southern Area for prescribed burning. By April and May we sent firefighting resources to the Southwest, southern Rocky Mountain areas. In June and into the rest of summer we started mobilizing resources within the Rocky Mountain area, while still sending suppression and support resources to wildfires throughout the nation.

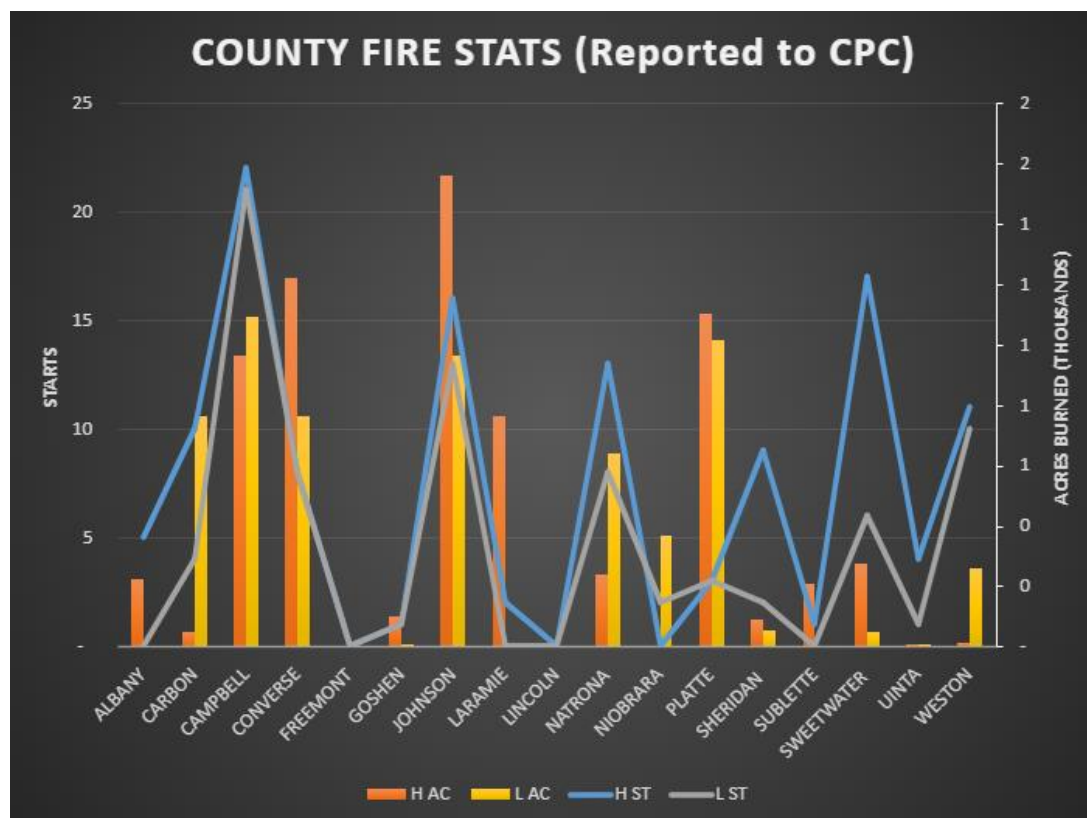
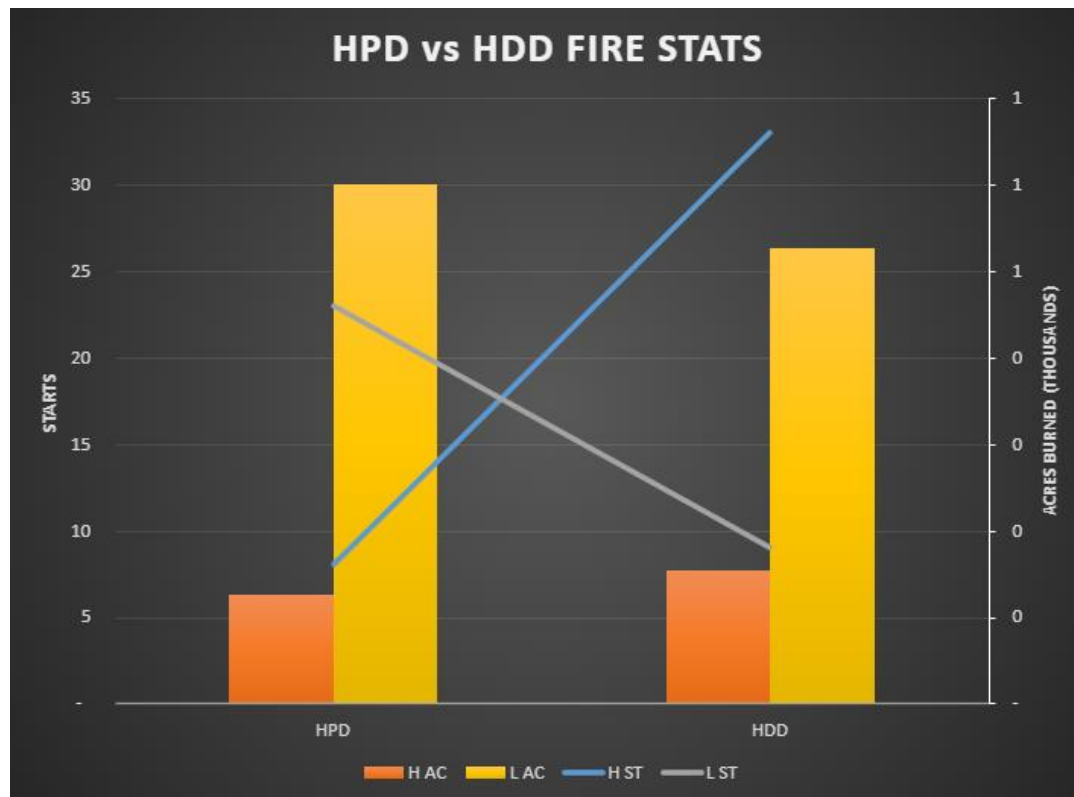
We have one Initial Attack position that has been vacant since April 2024, we are hoping to fill it this winter.

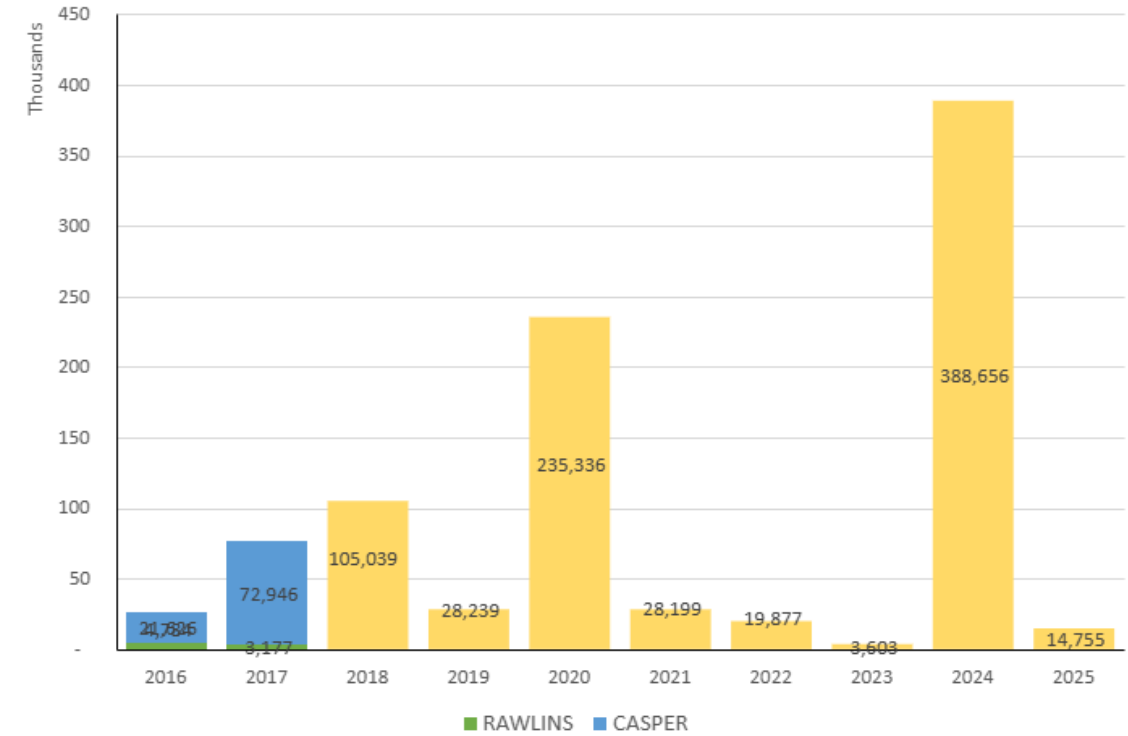




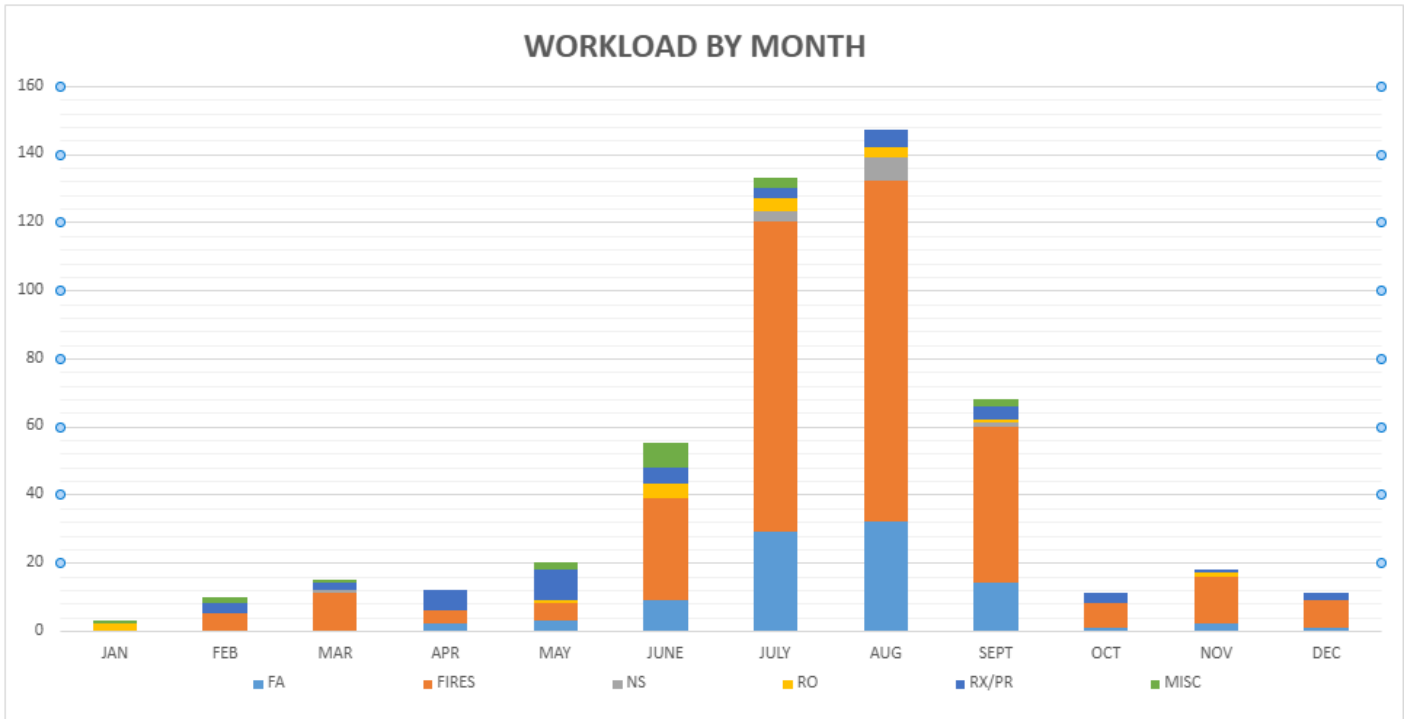
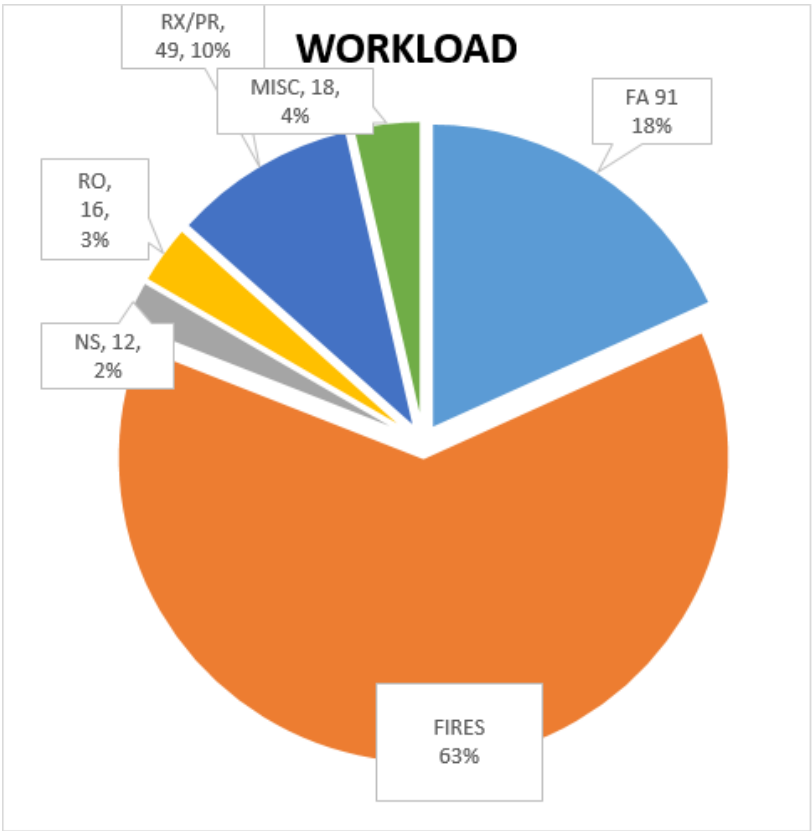
OVERALL STARTS - HISTORICAL



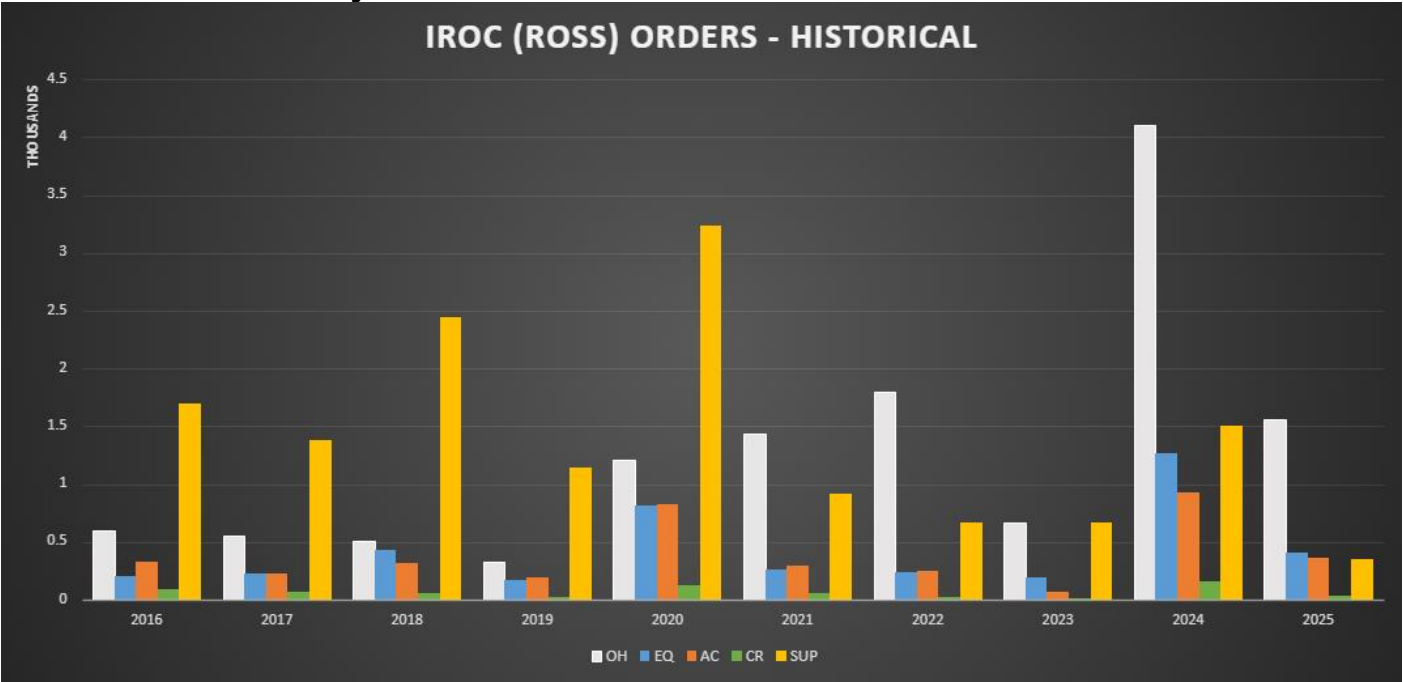
OVERALL ACRES - HISTORICAL

With the limited amount of precipitation and snowfall we got this past year, our fire units couldn't burn as much as they anticipated.

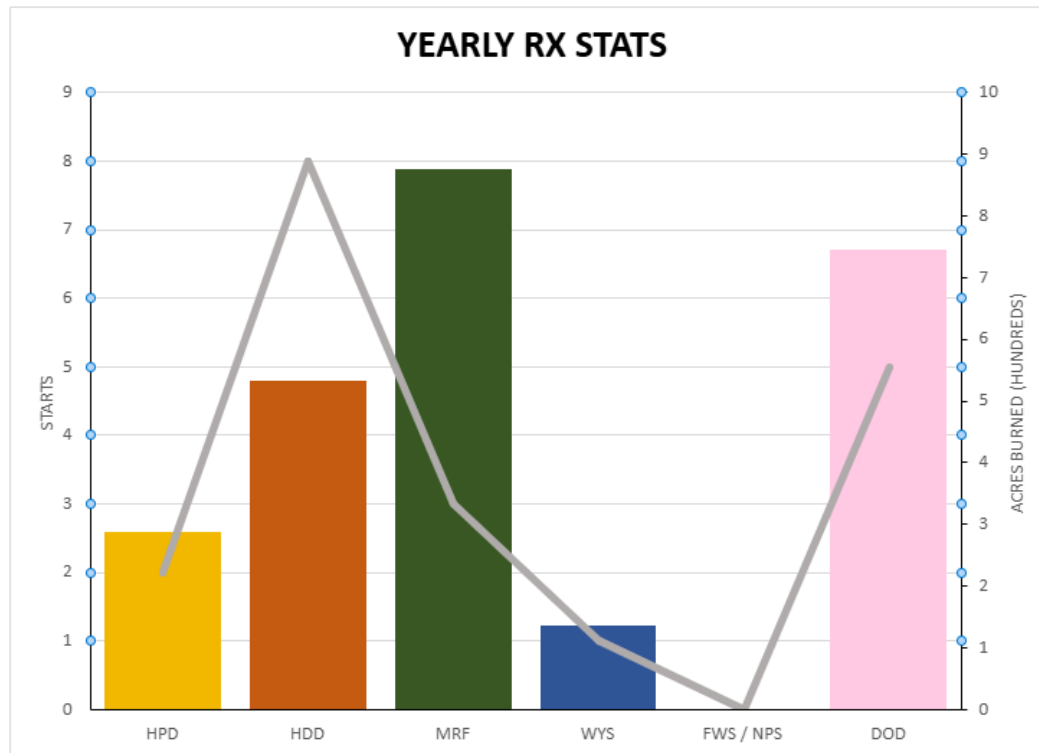

Helicopter 8BH came on contract June 16th in Rawlins, WY. Their contract ended September 13th, but they were extended until September 30th. Their first fire was Horse Draw in Craig, CO, which was also their first assignment. They spent most of the summer in the Cody Dispatch Zone (49 days). They ended their contract in Rawlins, WY. H-8BH transported 451 passengers, and 31,779 gallons of water.

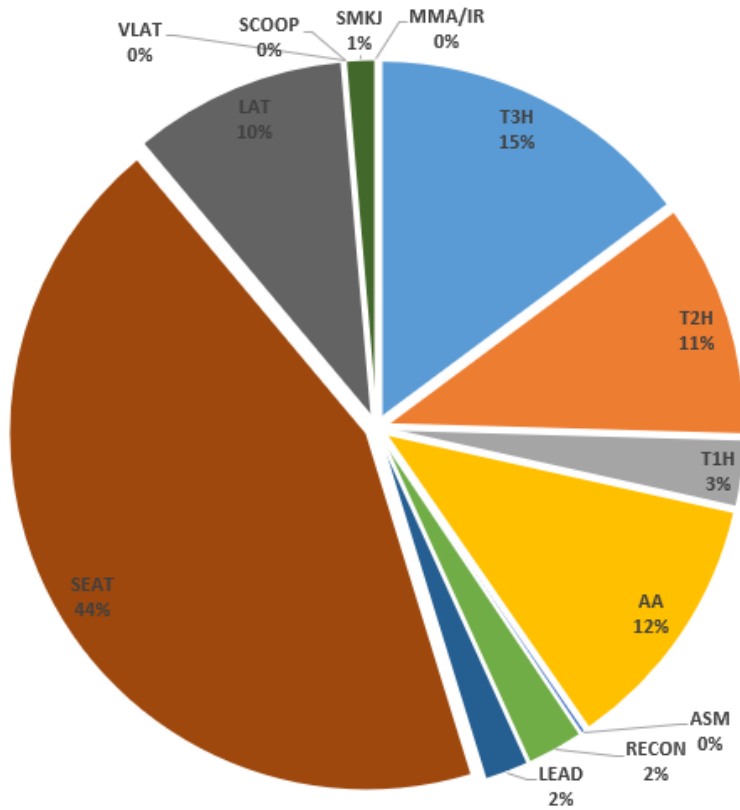
This year Wyoming State Forestry contracted a Type 2 Helicopter, H-5FS. Their contract started July 1st at the Casper Airport, and it ended September 28th but was extended until September 30th. They supported firefighters in the Cody and Casper Dispatch zones. They had a total of 32 missions with 14 of those missions being extended attack. H-5FS delivered 102,048 gallons of water this season.

Rock Springs SEAT Base opened July 1st and it closed on September 30th. T-882 and T-839 were housed there for the remainder of the SEAT Base operation for 2025. They flew on 26 fires and delivered 51,517 gallons of retardant and supported Wyoming, Colorado, and Utah.

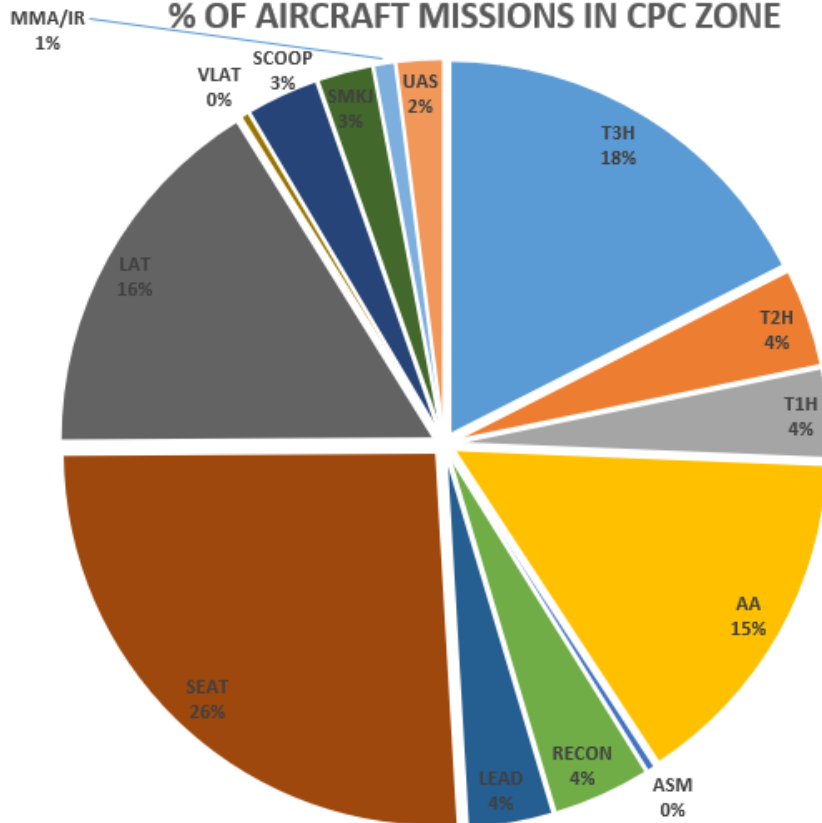
Thunder Basin SEAT Base opened August 17th and closed September 30th, which was home to T-834 and T-831 for the remainder of the season. They flew 17 fires and delivered 18,181 gallons of retardant and 16,801 gallons of water. They supported fires in Wyoming, South Dakota and Montana.

Casper Dispatch Center Improvements:

This year the airport came and made some improvements to the dispatch center, which has improved the look and feel of the building. These efforts were not at our requests; the airport initiated these significant improvements as a result of the relationship we have built with them as a Board and the Dispatch Staff. Total value of the improvements was close to \$40,000.

This spring they came in and replaced all the lights within the building with energy efficient lights that are dimmable in Expanded and the IA floor. This has brightened the rooms up and has made it easier for our eyes!

They have just recently finished their most recent improvement project which was replacing all the rounded windows with newer square windows. The new ones have really brightened the rooms and brought in more light.
