NARRATIVE

The first recorded fire in the zone was on the 2nd of February on private land in Larimer County caused by a tree on a powerline near Estes Park for @ .1 ac.

Throughout February human starts from target shooting occurred on the Pawnee NG burning over 800 acres, by the end of March nearly 1,000 acres of grassland had been burned during 7 fires.

Warm and dry conditions were a concern for most of the month of March which included 13 Red Flag Warnings. On the 10th of March, Clear Creek County reported a grass fire near forest. Several AC were requested including SEAT, LP, Heavy AT and Helicopter to suppress the Santa Fe fire @ just over 3 acres. These conditions continued throughout March and prompted fire restrictions and Severity resources coming to assist the Forest and Park. By the end of March the zone reported 27 fires for 36,934 acres burned, 95% of the total acreage for the year. The majority of that came from a single fire in Logan County that burned over 32,000 acres on the 6th of March.

The first Lightning fire was reported as a single tree near Livermore, CO on April 25th.

FTC hosted no Incident management teams this summer and Expanded Dispatch was not mobilized. In July FTC implemented the COOP for a gas leak near the building. Even though this occurred during an IA on the forest with AC being flight followed and mobilized, minimal interruption was noticed in the field. Normal operations resumed later that day.


RX fire operations were accomplished by most all units supported by FTC with no escapes reported.

The last fire of the year was reported on December 21 on private land in Clear Creek County.
















ARF Fires by Cause / Acres










Overhead Requests in Zone by Agency












Engine/WT Requests in Zone by Agency




Engine/WT Requests Out of Zone by Agency



Crew Requests in Zone by Agency




Crew Requests Out of Zone by Agency




Aircraft Requests in Zone by Type






