NARRATIVE

Across the FTC Zone 2019 was a below average year for fire starts and acreage burned. Resources responded to the first fire on Jan. 25th in Clear Creek County and the last fire of the year on Dec. 22 on the North Zone of the Forest in Canyon Lakes RD.

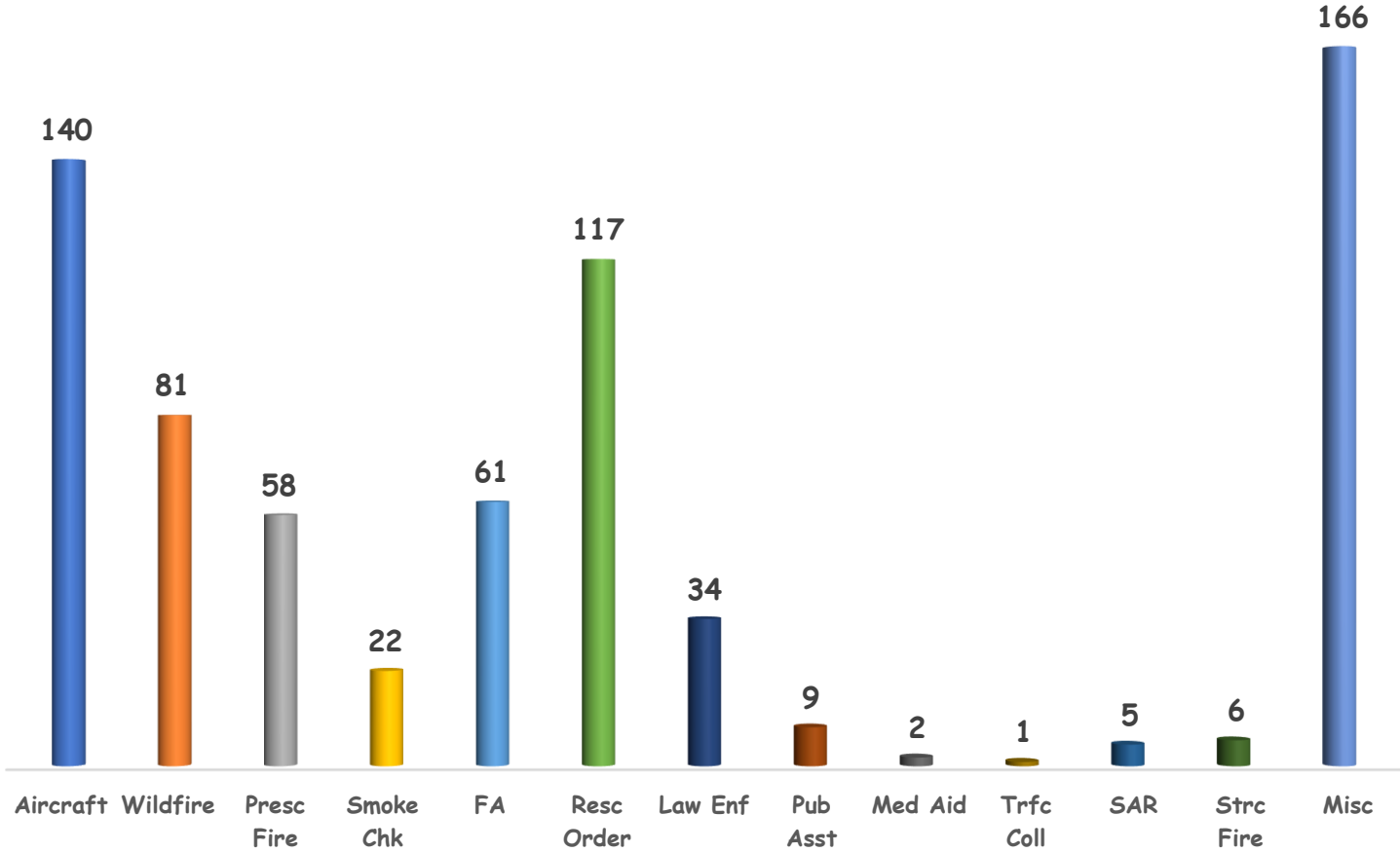
Fire activity across the entire RMA was below average, in fact Nationwide activity was less than normal, with the exception of Alaska. The Arapaho-Roosevelt NF utilized the down time to accomplish RX fire activity across the forest, including broadcast burning during every month with the exception of June.

Dispatch staffing was dynamic in the sense that 2 Assistant Center Manager detailers provided coverage while the ACM was detailed for 120 days from May-August. Three new temp. employees were hired and trained, while several injured firefighters also provided additional support to the center.

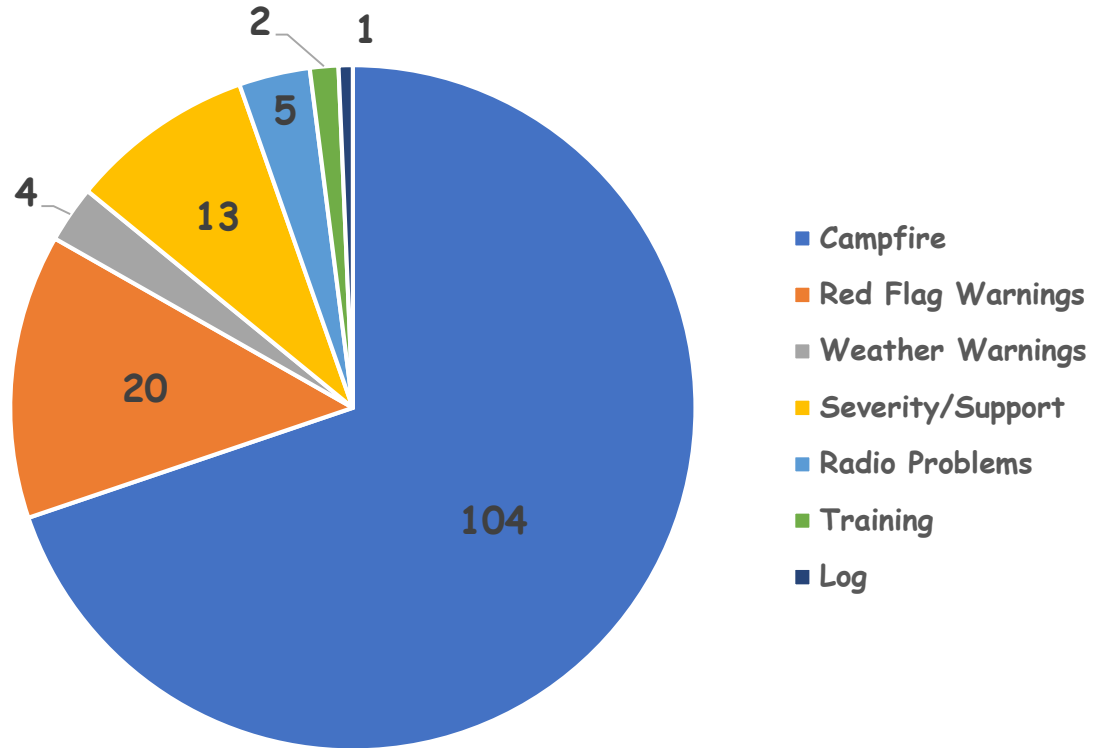
Fall saw an uptick in activity across the Zone and RMA, including prepositioned Crews and Aircraft on the zone, and multiple staffing extensions.

Fall was also the beginning of the Dispatch Centers' move from the 1st floor of the Forest Supervisors office to the garden Level of the same building. Now mostly complete, this move more than doubles our footprint and allows for a dedicated expanded dispatch area as well as a separate office and meeting space for the Center Manager, and Assistant.

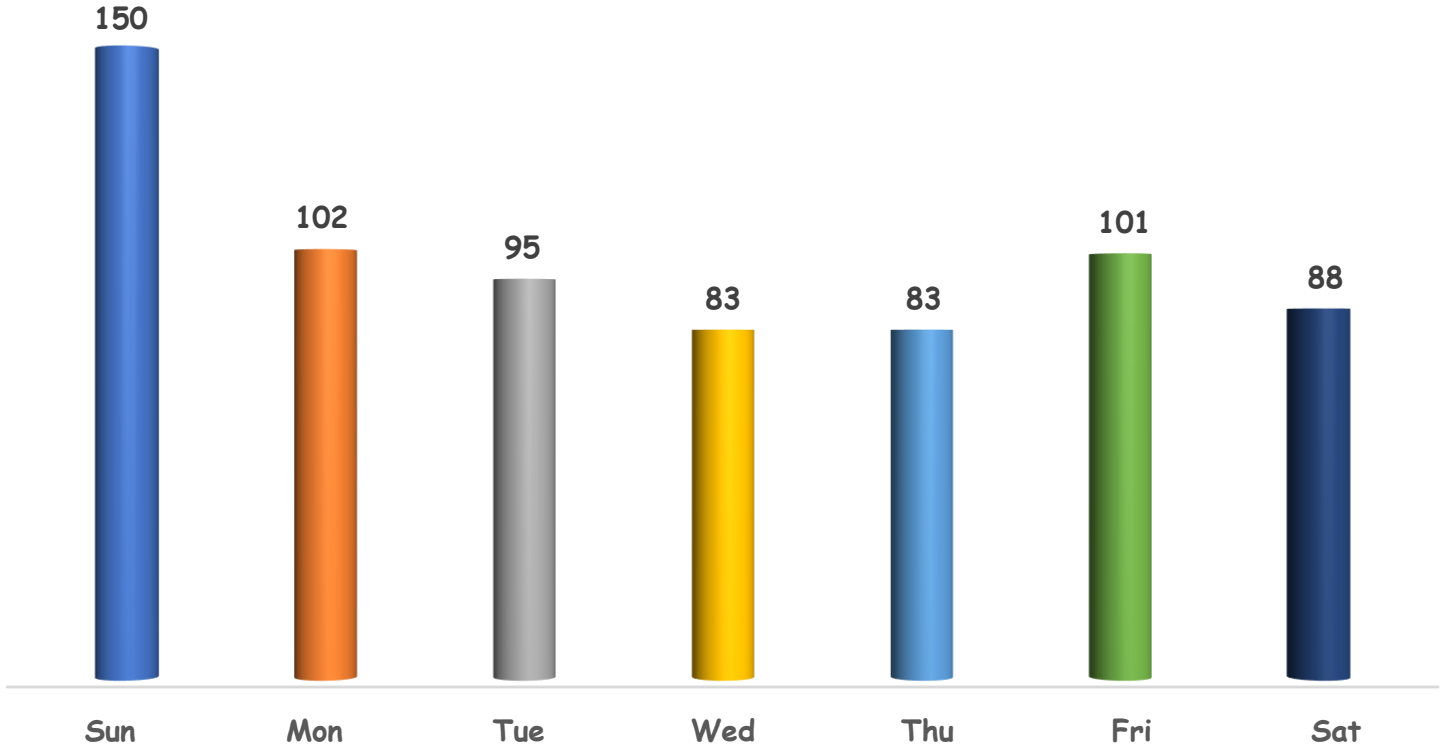
2019 ALL INCIDENTS BY TYPE



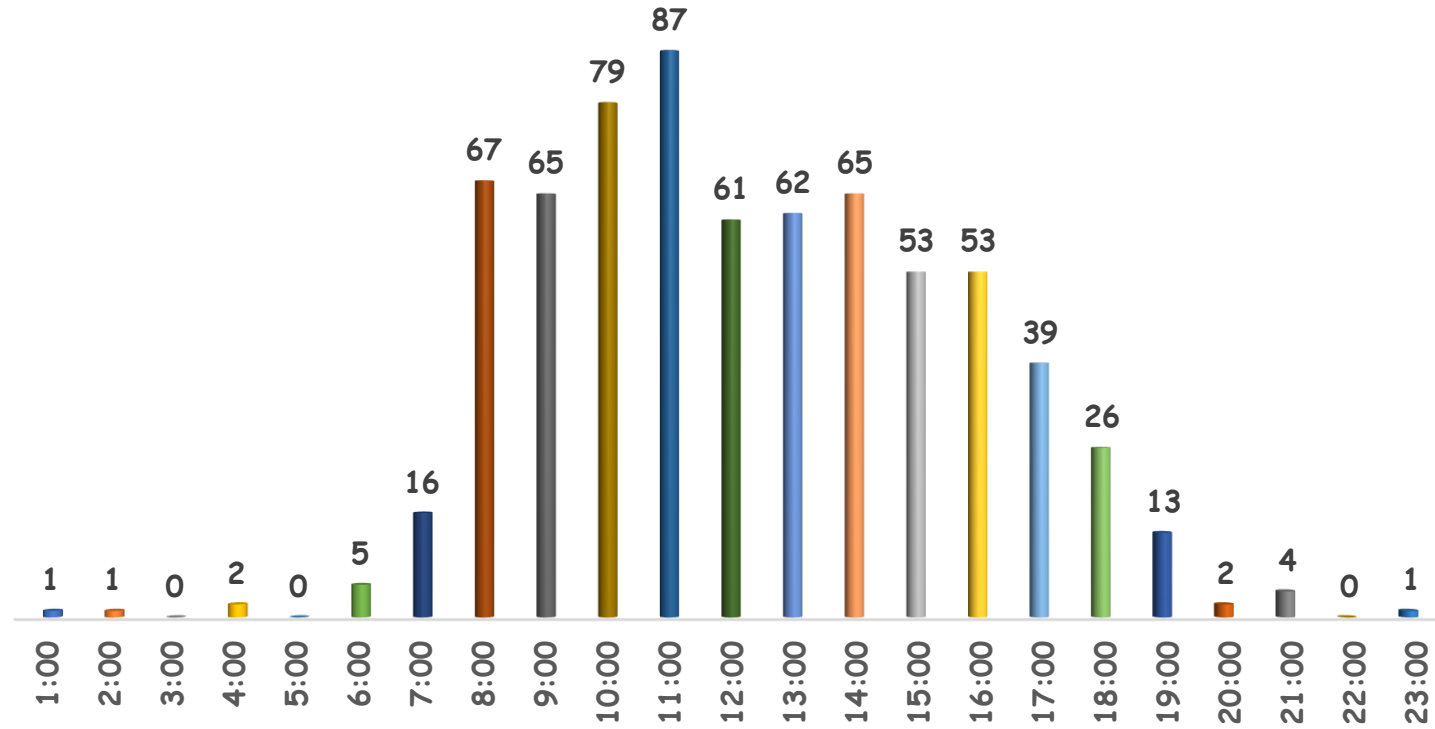
MISCELLANEOUS INCIDENT BREAKDOWN



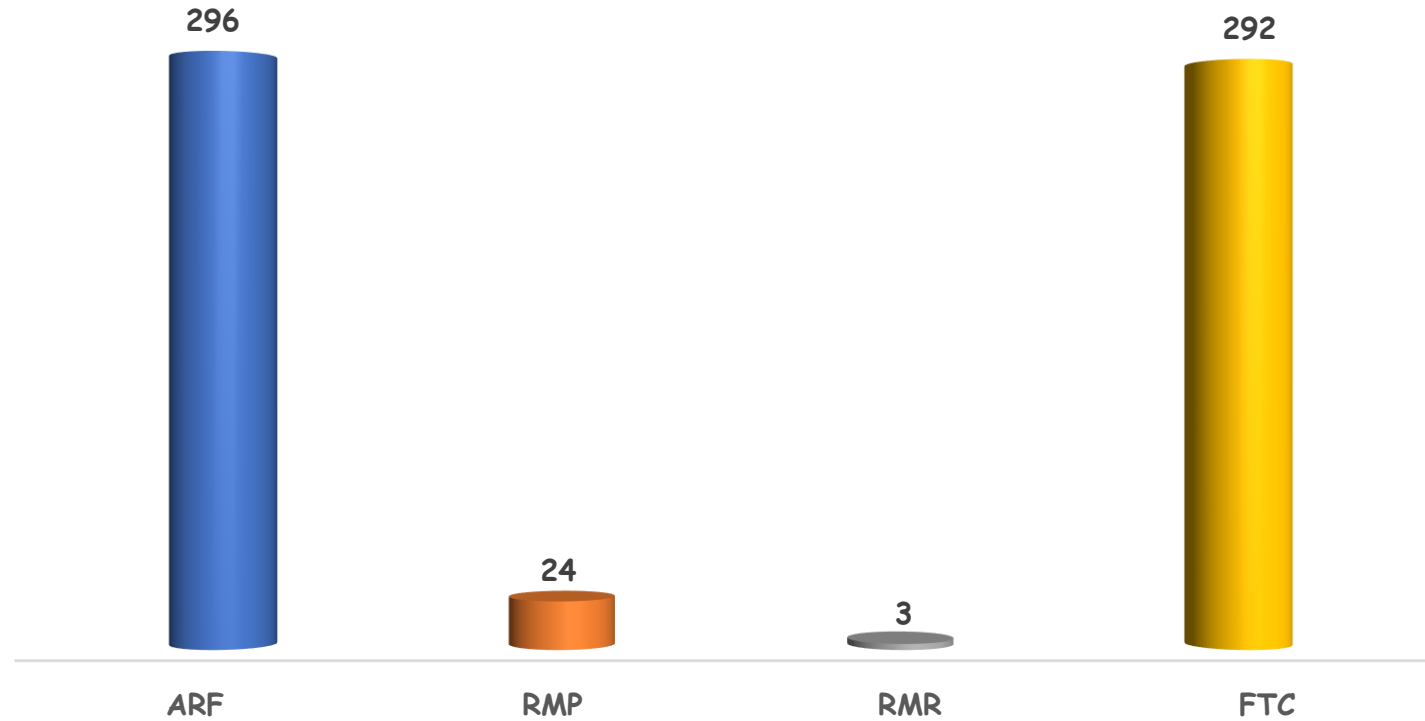
OF INCIDENTS BY DAY OF WEEK



TOTAL # OF INCIDENTS BY TIME OF DAY

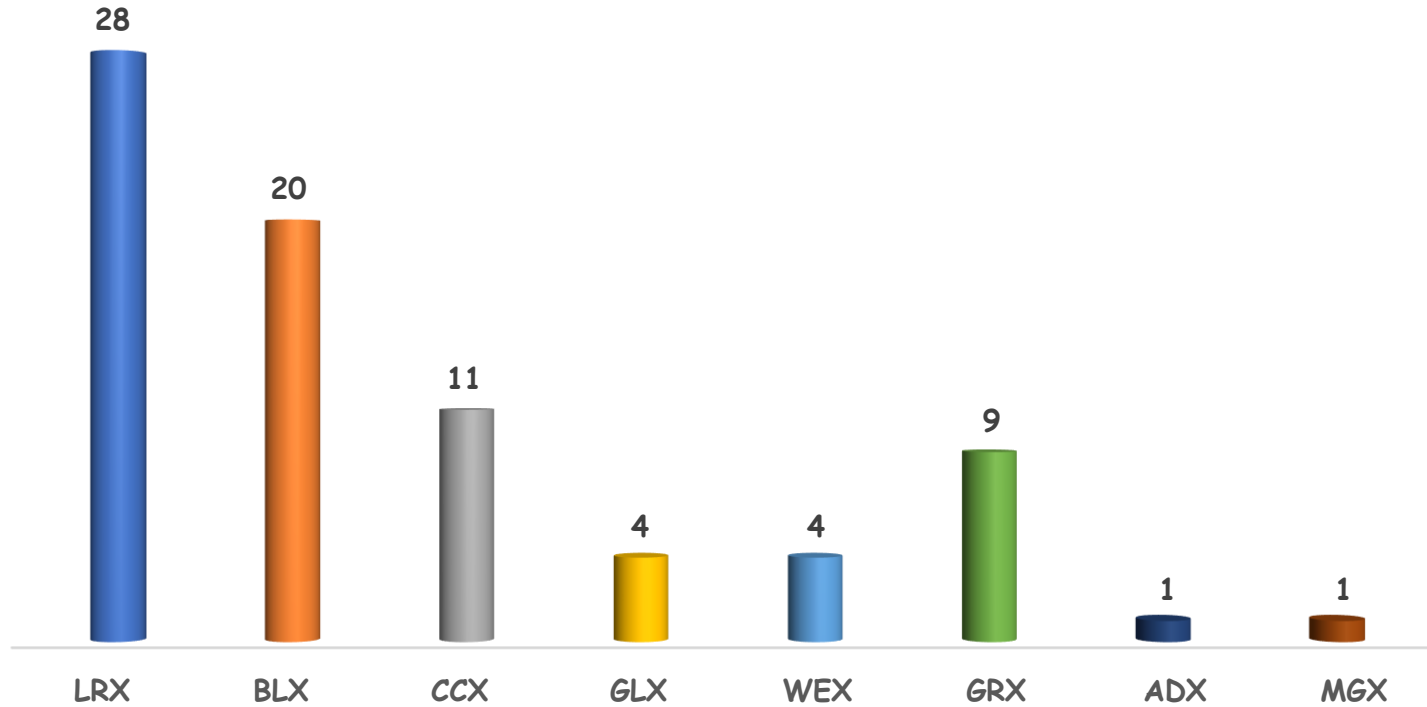


TOTAL # OF INCIDENTS BY FEDERAL AGENCY



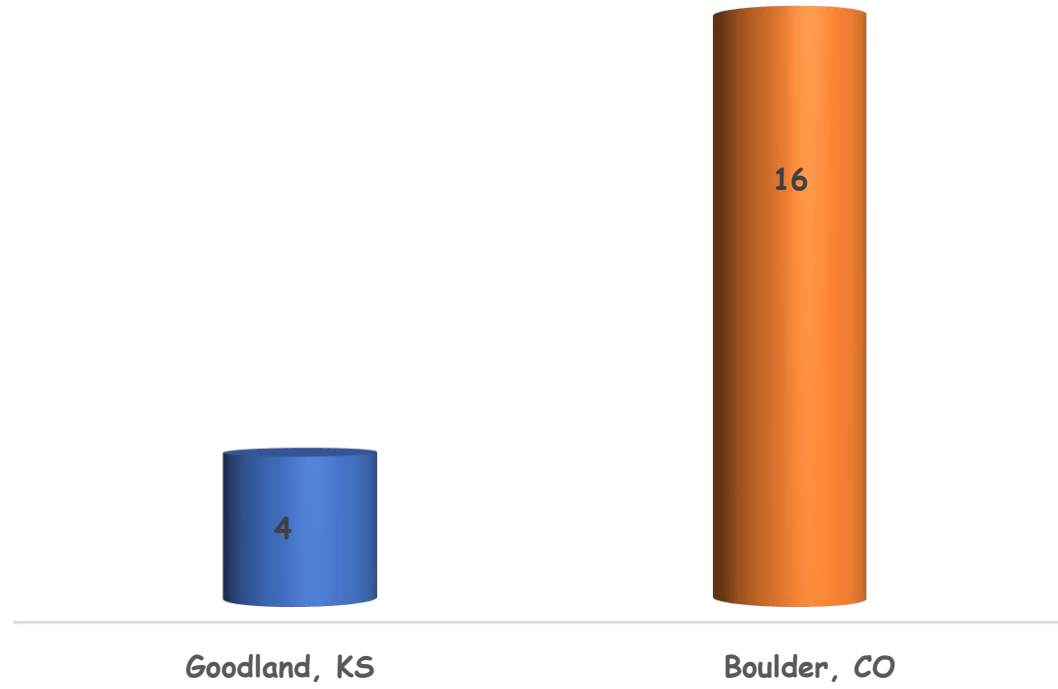

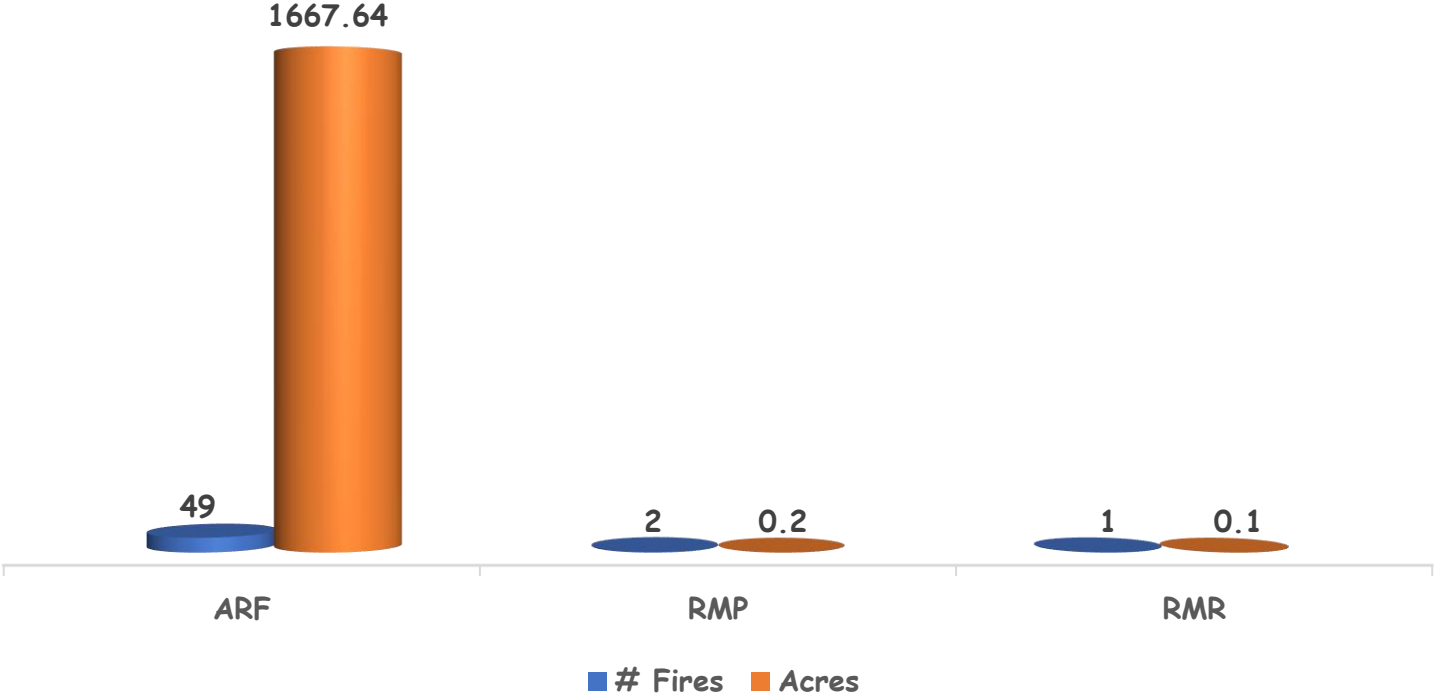

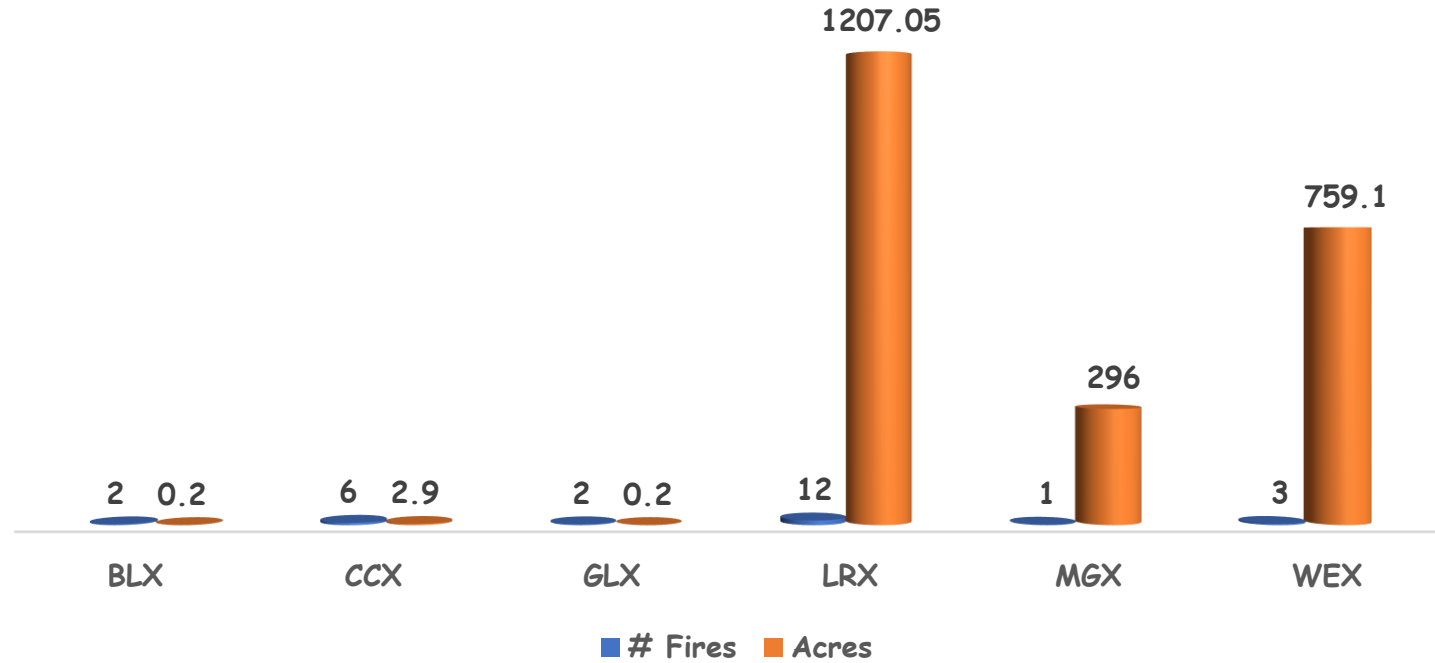

FIRES AND ACRES BY FEDERAL AGENCY



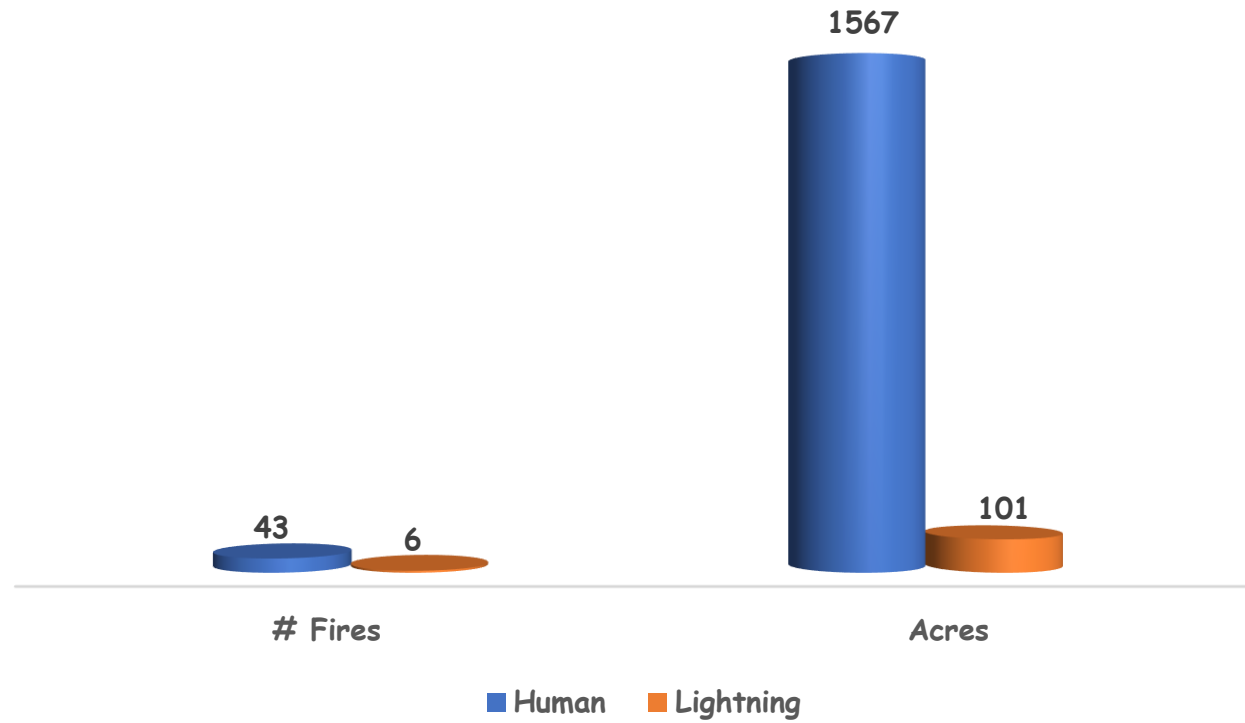

FIRES AND ACRES BY COUNTY



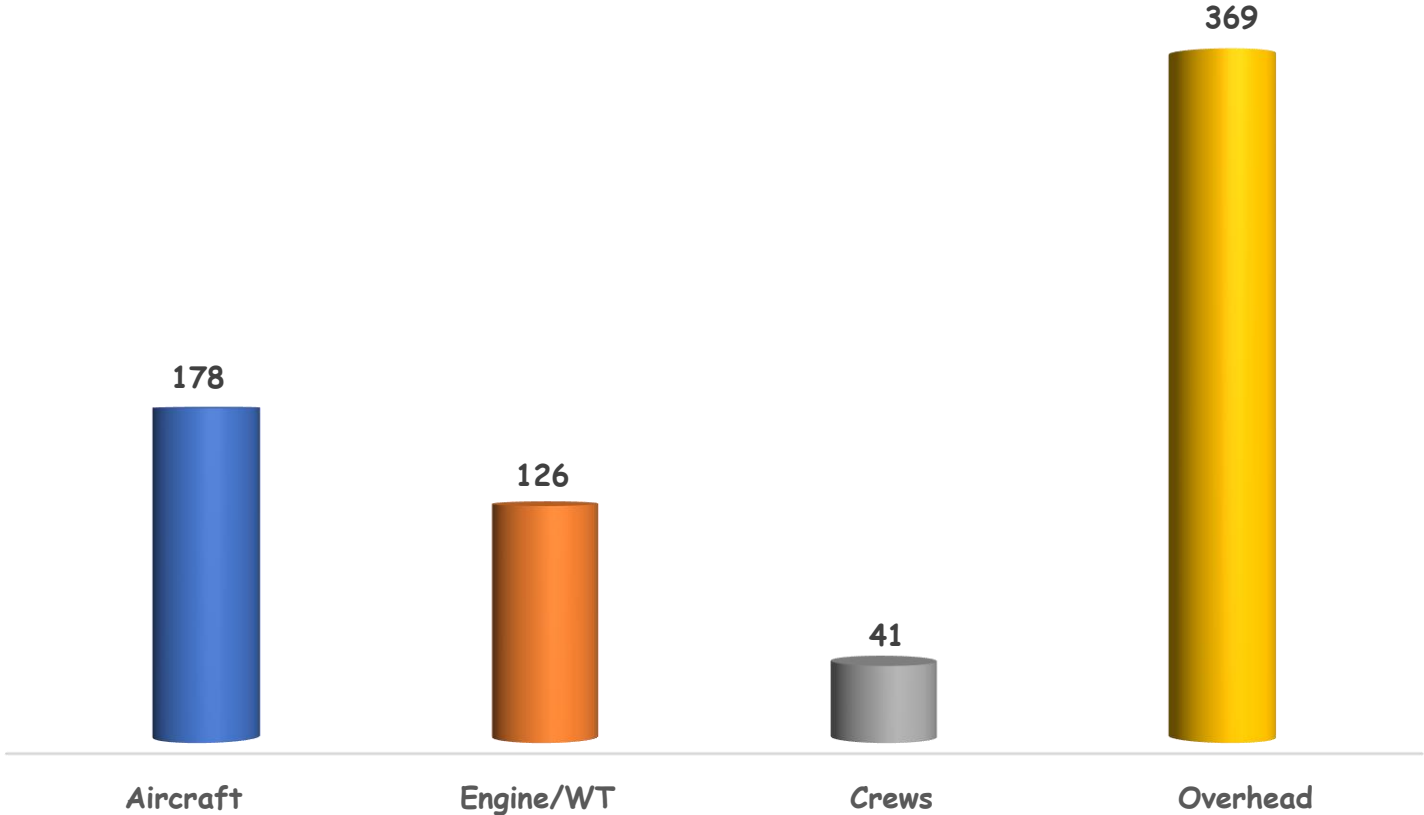

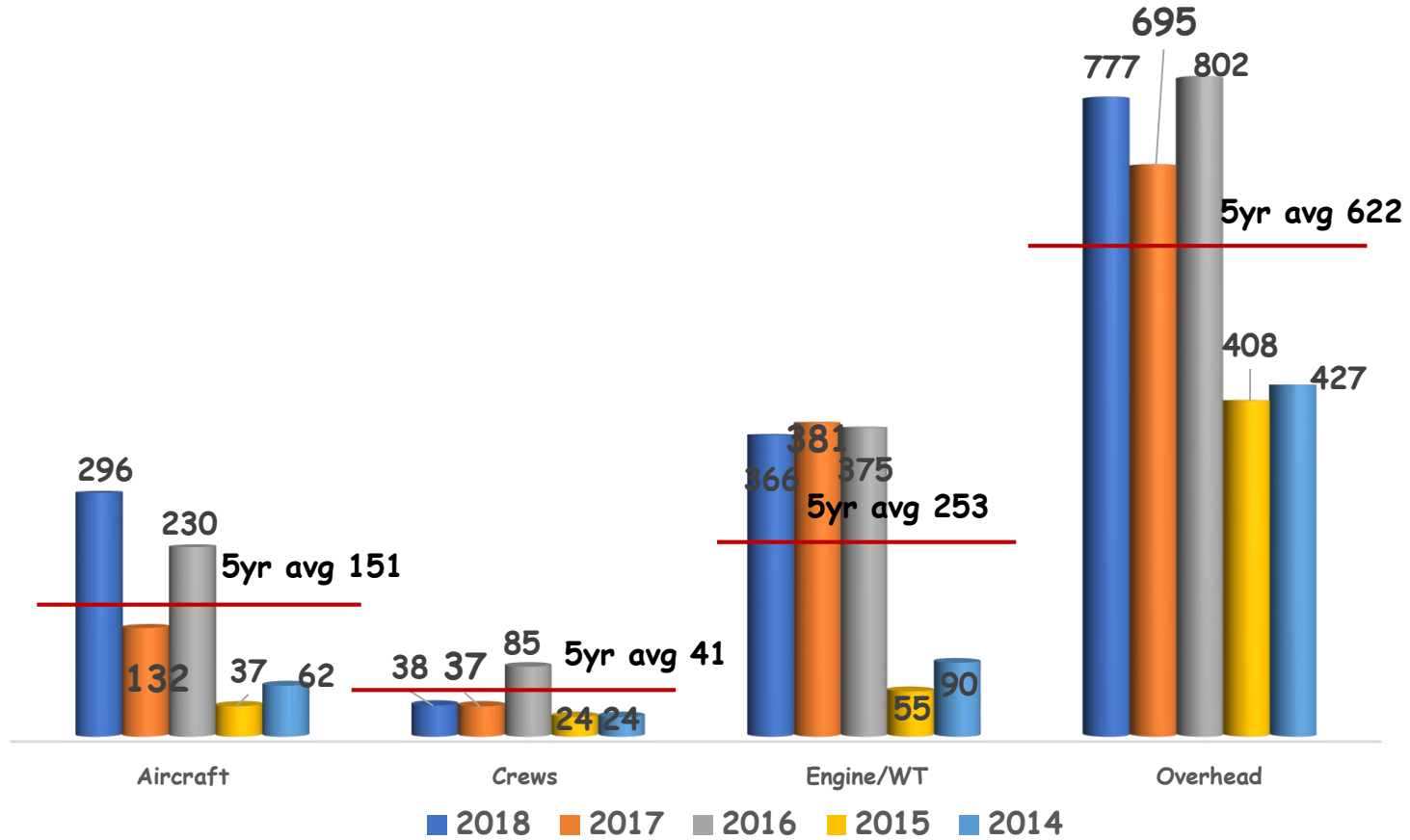

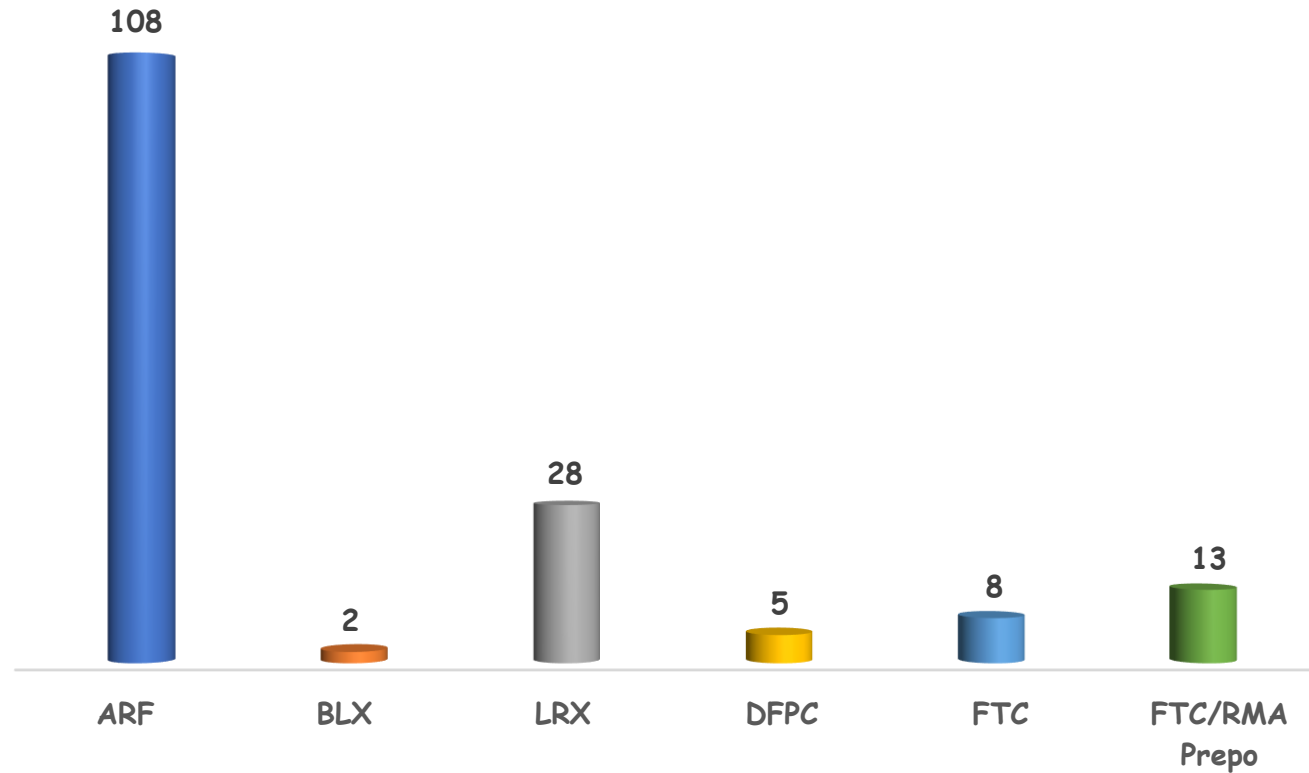
TOTAL REQUEST BY CATALOG 2019



5 YEAR REQUEST AVERAGE BY CATALOG

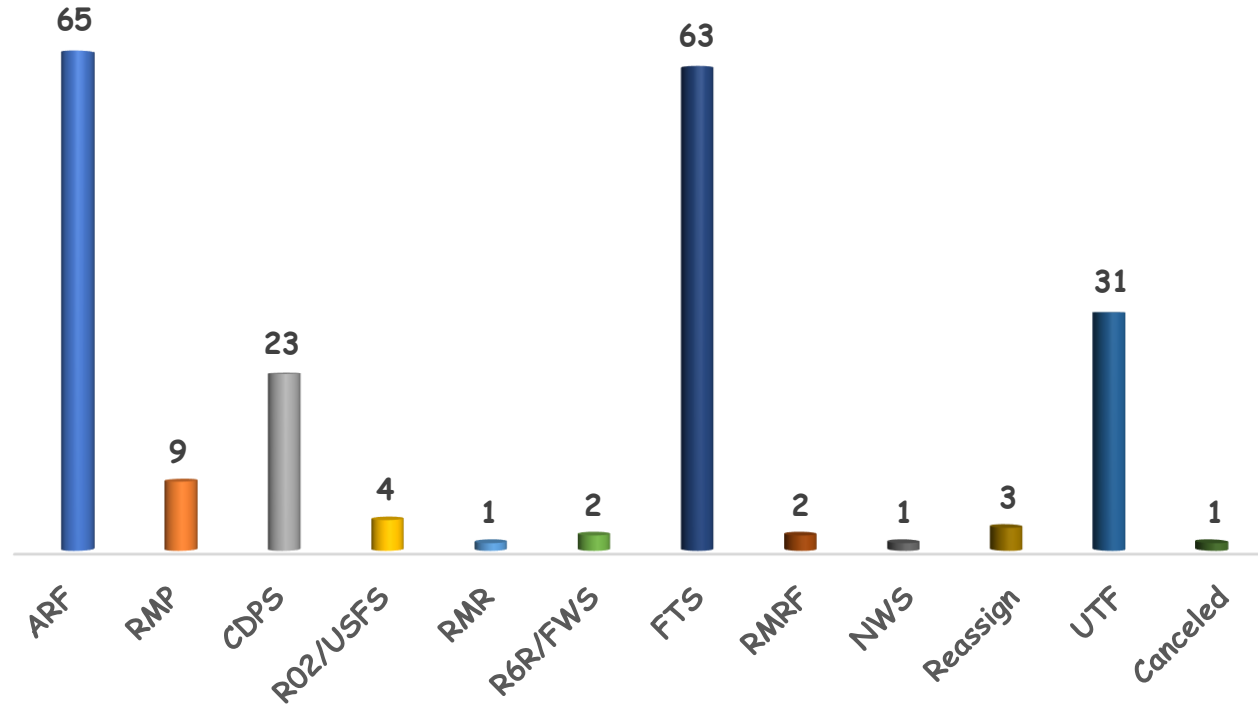


OVERHEAD REQUEST IN ZONE BY AGENCY



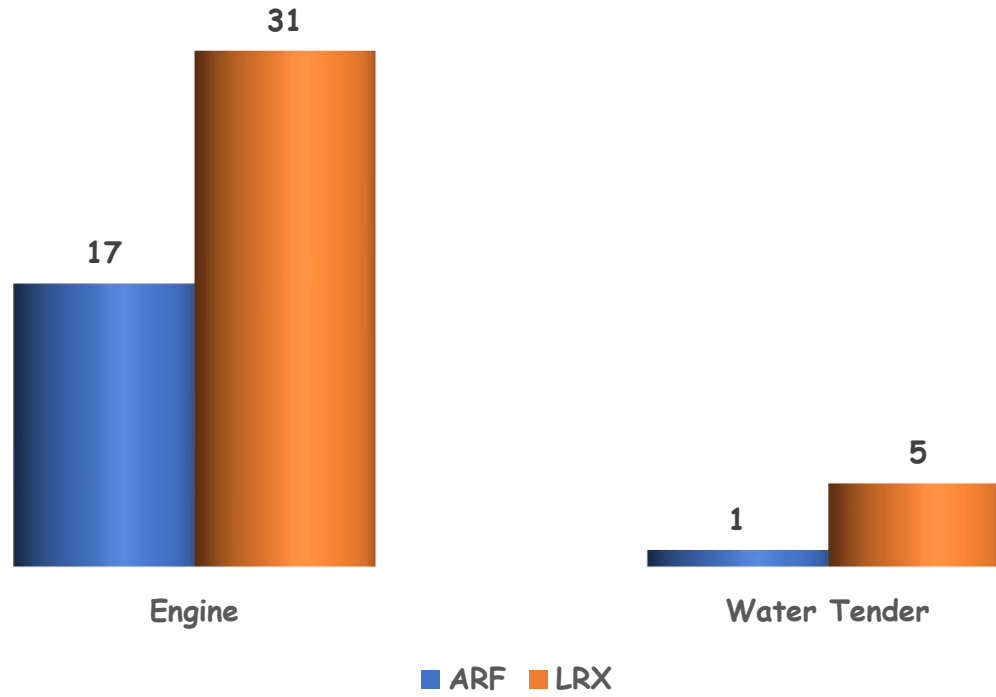

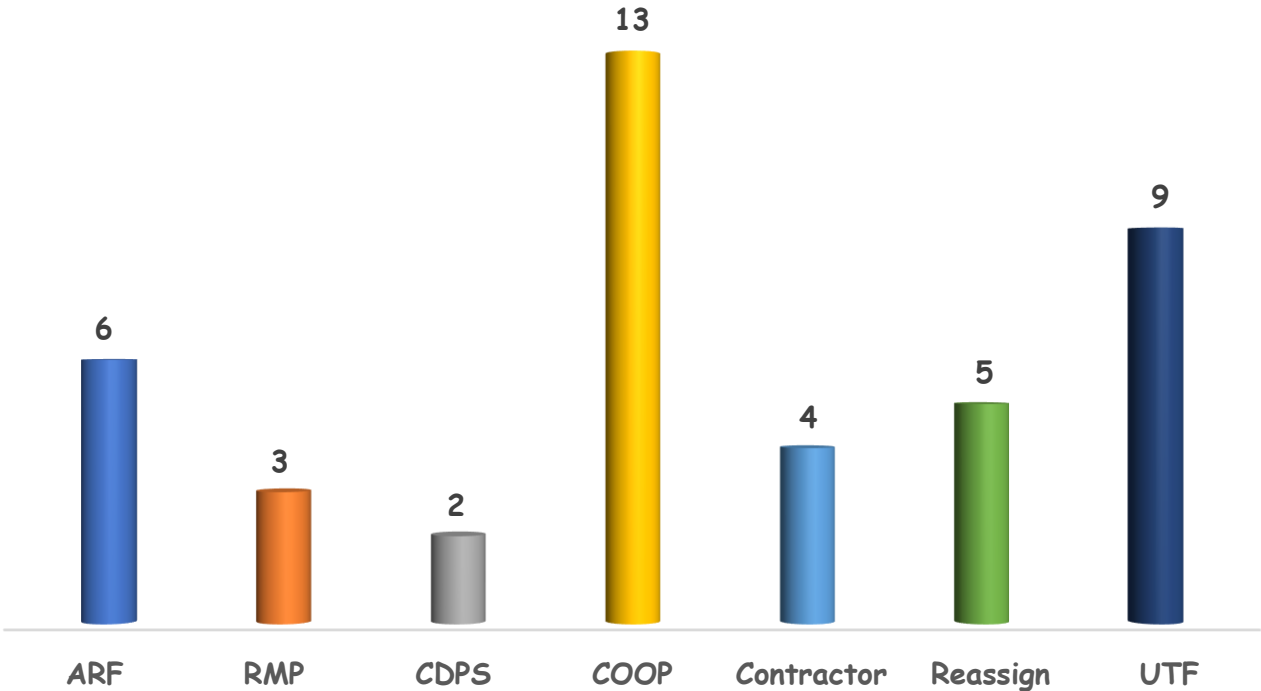

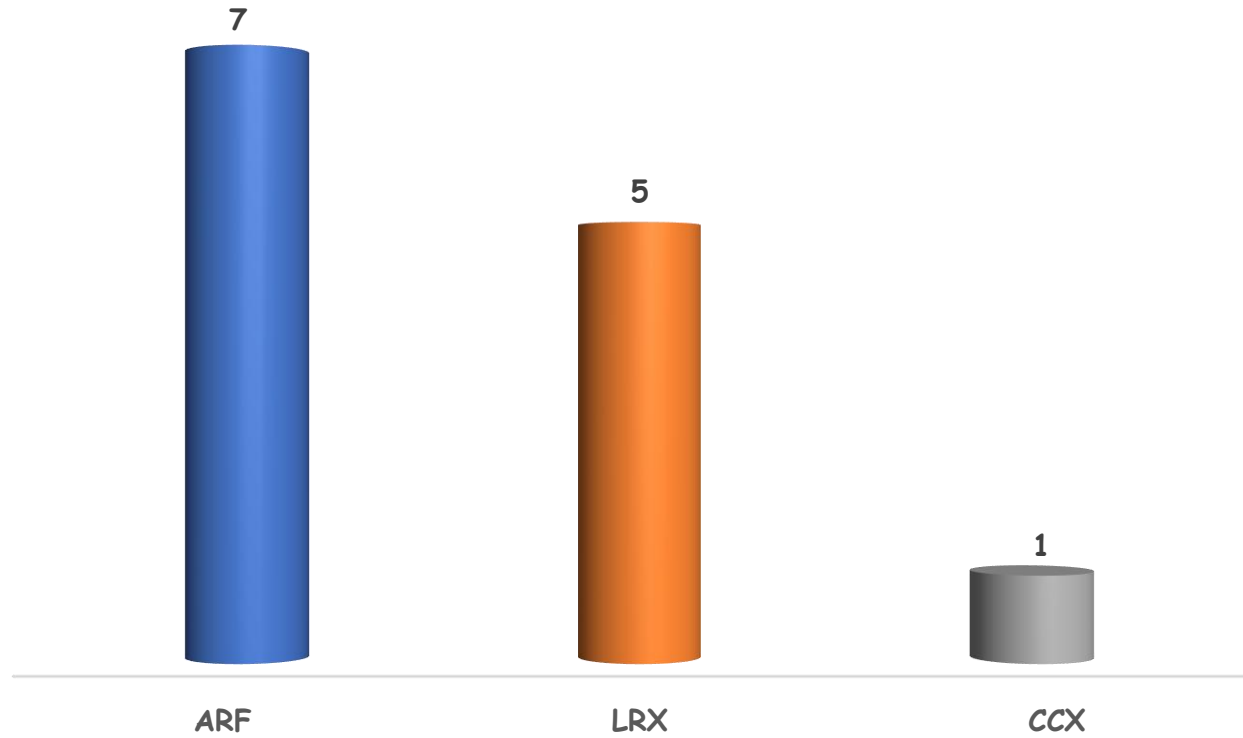


ENGINE / WT REQUESTS OUT OF ZONE BY AGENCY



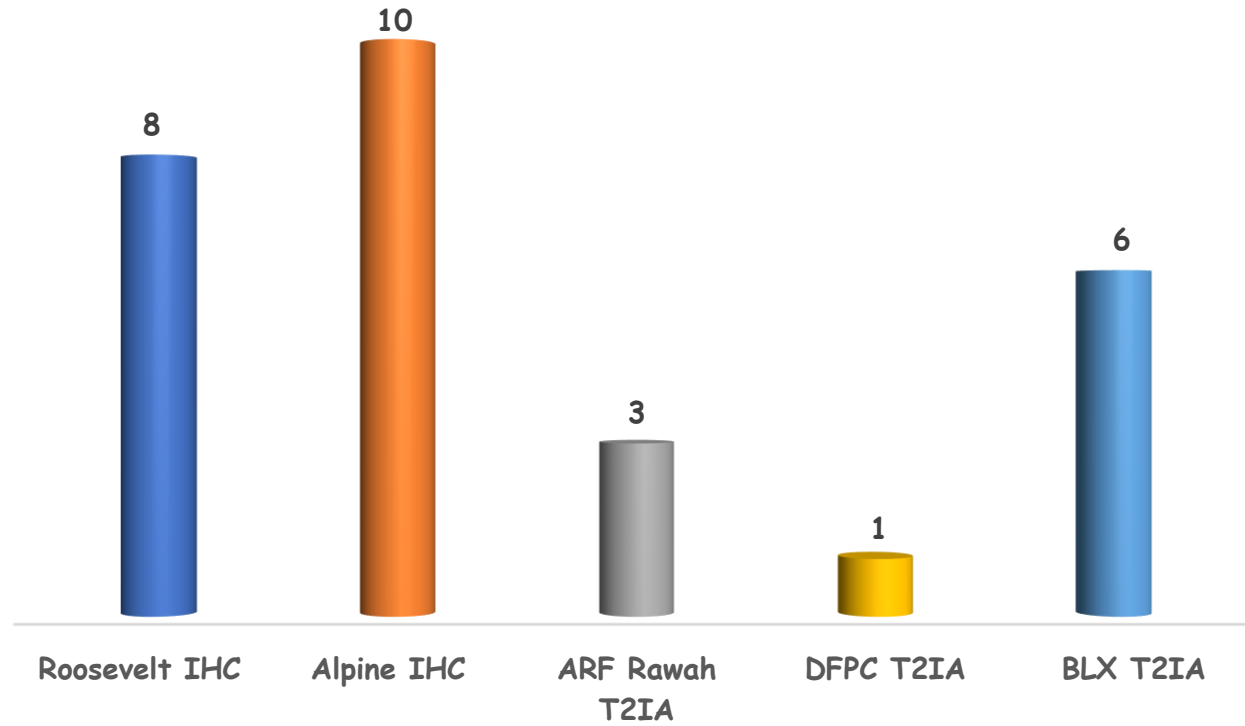

CREW REQUESTS IN ZONE BY AGENCY

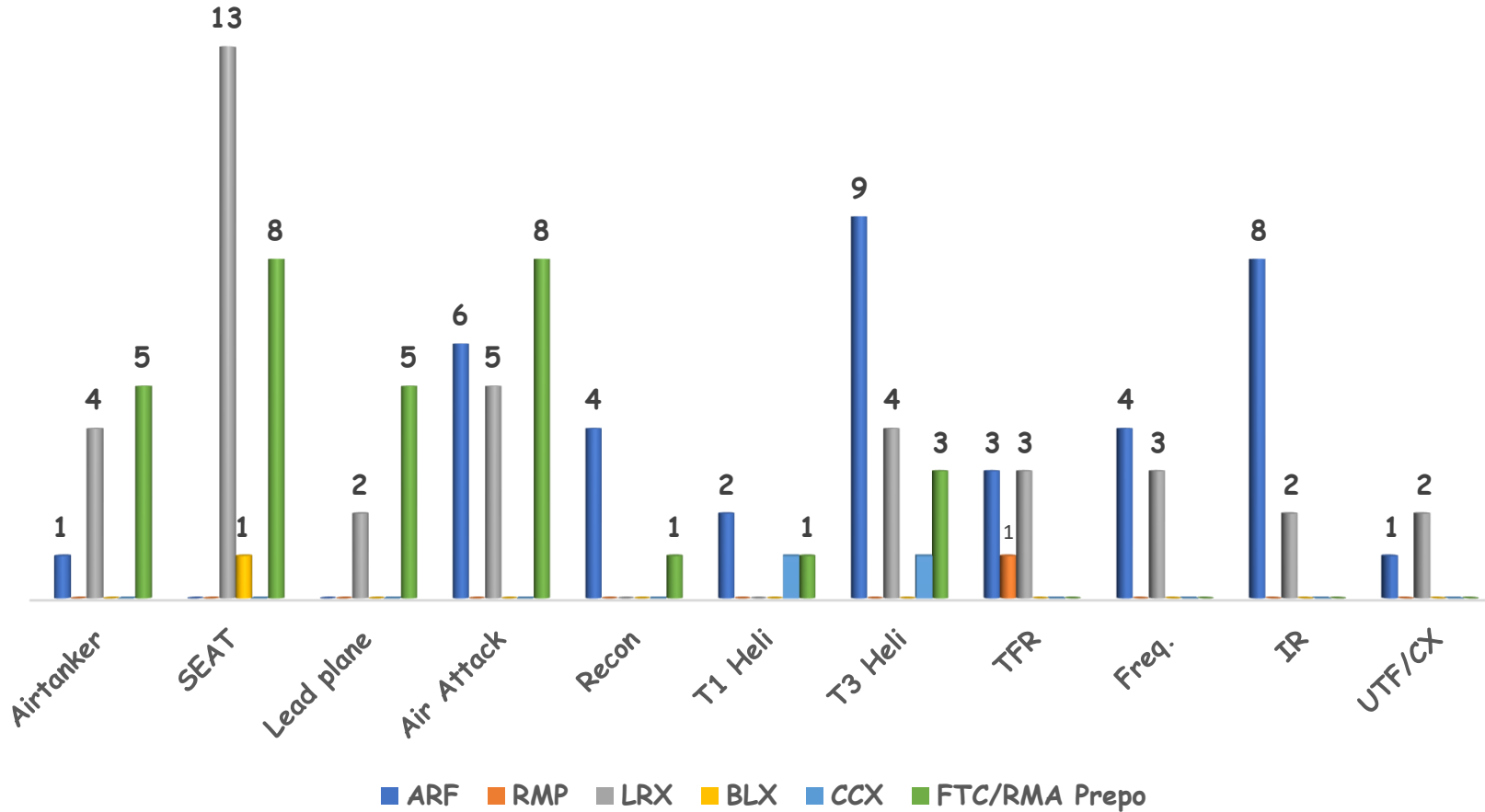

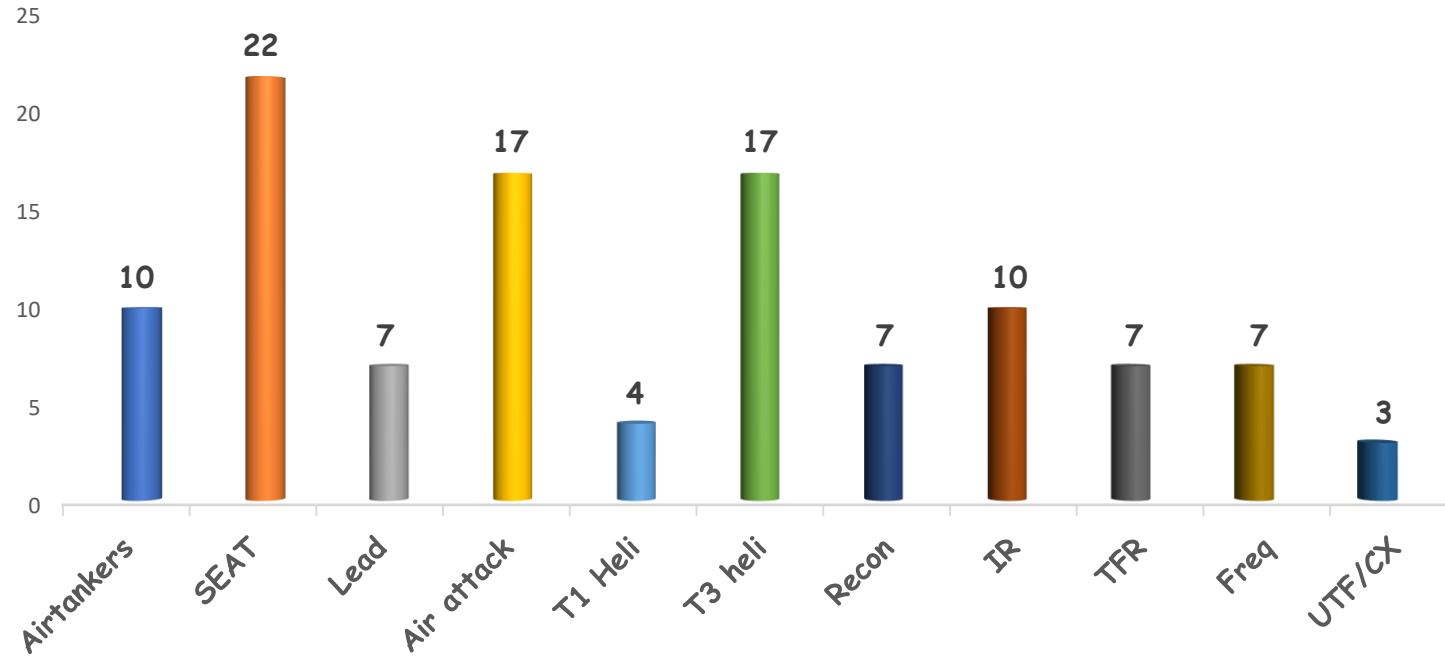
CREW REQUESTS OUT OF ZONE BY AGENCY



AIRCRAFT REQUESTS IN ZONE BY AGENCY

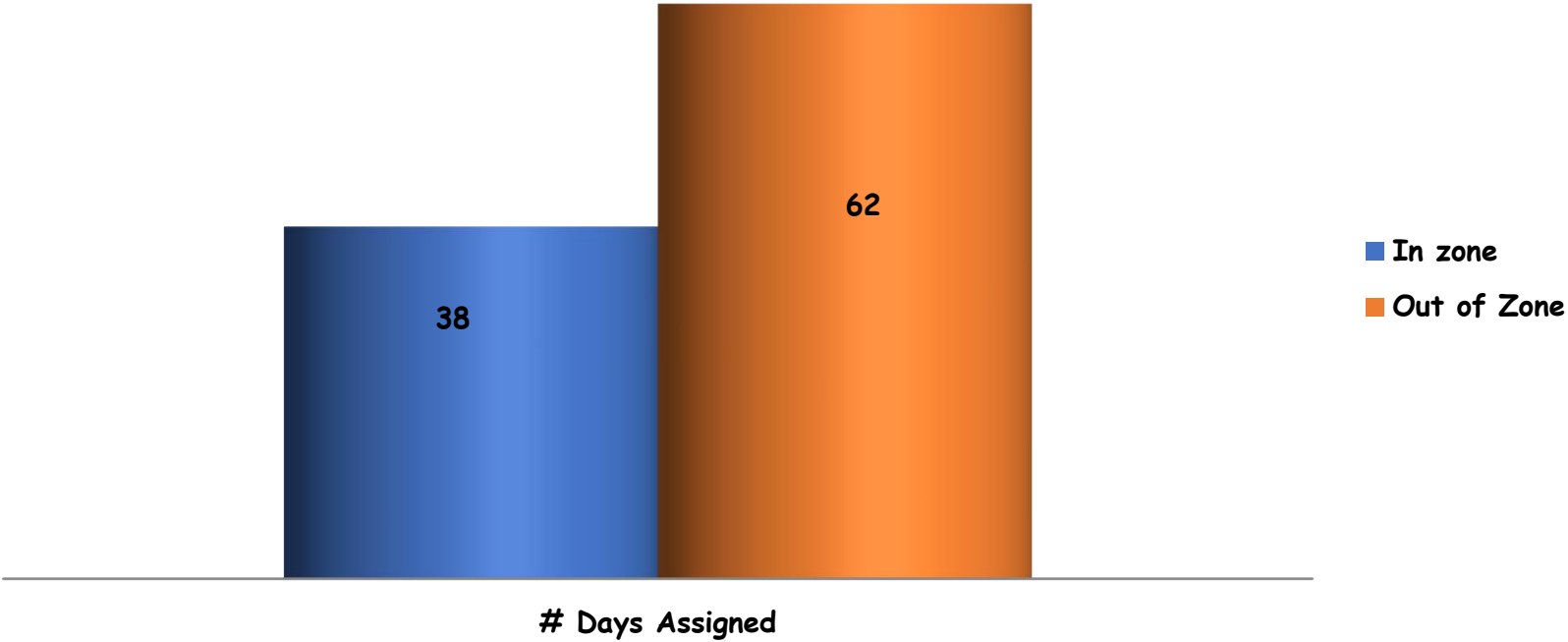


AIRCRAFT REQUESTS IN ZONE BY TYPE



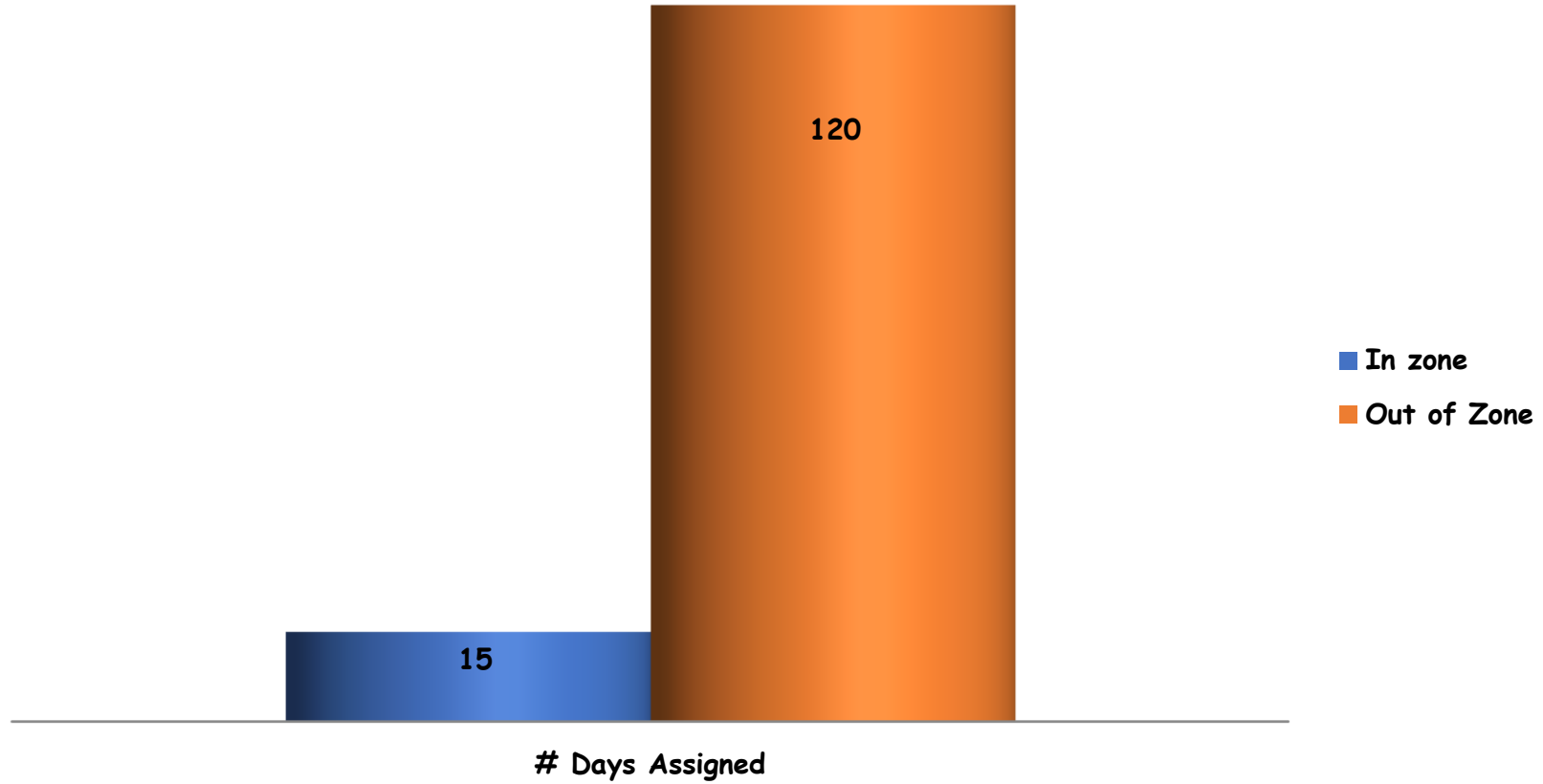
HELICOPTER 2BH

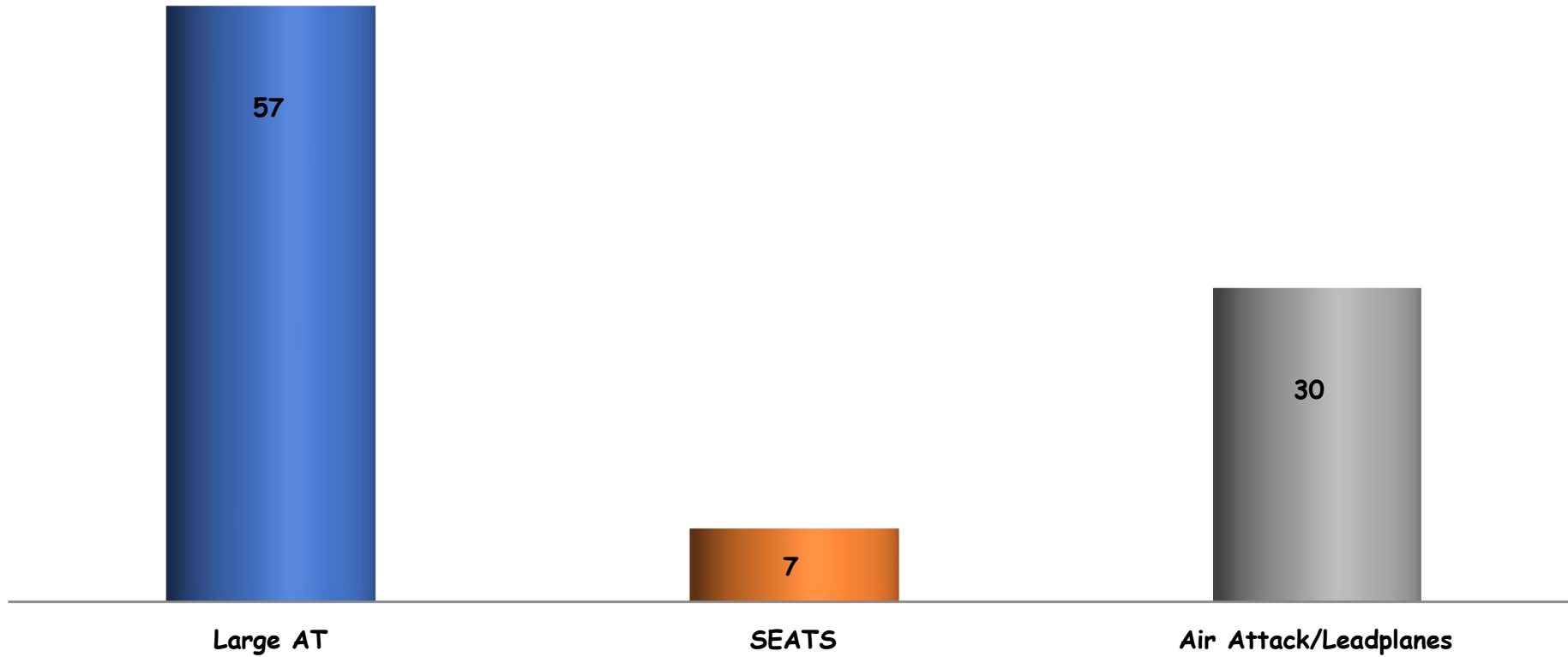
