FTC 2011 report

We begin the 2011 year with very little snow on the Northern Front Range low elevation areas through the winter. By mid February the zone started seeing fire activity on the PNG and In March activity picked up the lower elevations in the foothills of the ARF and private lands within the Counties. On April 1, the Crystal Fire started on private land in LRX with Summerfelts' Type 1 team being ordered for the fire where they remained for 1 ½ weeks before transitioning back to a local T3 organization.


Spring into summer the zone saw more normal conditions and resource mobilization became active with Texas being the most active recipient which continued through the summer into fall. In the spring the Center Manager took a new job in training and the center saw detailers for most of the summer with the position being filled in October. Staffing remain the same with all returning seasonal and permanent staff which help with the transition of the Center Manager.











The charts below represent The Total Overhead requests for Off Zone assignments by Req. catalog and resource Provider.







The Charts below represent the Total # Of Engines and Water Tenders sent off Zone broken down by type and by provider. COS refers to state FS agency resources while FTS refers to








The Chart below shows the total FTC resource mobilization for out of area




The charts below represent total crew use within the FTC Zone and total crew requests processed which includes reassigning non FTC resources to Incidents outside of the FTC Zone.







The chart below represents where our FTC crews were mobilized for Incidents either within the Rocky Mountain Area or National area.
