Authorization for Resource Orders

Aviation resource orders within Gilpin County that are not covered by the WERF *may obligate the jurisdictional agency for the cost incurred* for use of that resource, unless a designated county official approves the resource order for county payment. Prior to county use, designated county officials will approve the resource order for county payment. Reference **Section 9.G.1**, above, for persons authorized to obligate County funds.

After receiving approval for aircraft use from said authorized people, the Gilpin County Communication Center may place the aircraft order through FTC on behalf of that person
