### **Clear Creek County**

Interagency wildland fire resource orders within Clear Creek County that are not covered by prior agreements may obligate the Clear Creek County Sheriff for the resources' costs under the Interagency Fire Suppression agreement between DFPC and the Sheriff. All county or local orders for interagency wildland fire resources may be at the requesting agency's expense, unless the designated County officials approve the resource orders for county payment. In order for Clear Creek County to approve county payment of a resource order, the Clear Creek County Sheriff's Office must have been delegated command for an incident from the Clear Creek Fire Authority or Evergreen FPD. In Clear Creek County, the following people (**in order of priority and availability**) have authority to approve county payment for interagency wildland fire resource orders:
