2004 YEAR END REPORT

The early winter months of 2003/2004 produced near normal precipitation for the Black Hills region while the remainder of the areas in South Dakota and Nebraska received slightly below normal precipitation. However, by the end of March, snowfall amounts were less than fifty percent of normal in the western portion of South Dakota. Between five and ten inches of additional moisture was needed to bring the region out of the five year drought. Spring (March – May) precipitation was as much as three to six inches below normal in the western areas of South Dakota and Nebraska while eastern areas received slightly above normal precipitation for the period. Below normal temperatures throughout the summer (June – August) resulted in an average to below normal fire season for the zone.

The zone did host eight large fires, ranging from 75 to 4700 acres in size. The Northern Great Plains Interagency Type III team was mobilized twice, once for the Basin Draw fire in Crook County, which was the largest at 4700 acres, and the second time for the Bennett Canyon fire on the Black Hills National Forest. However, the majority of the incidents were handled locally with minimal resource ordering through the Great Plains Dispatch Center.

Nationally, fire activity was low, resulting in fewer than average out of area assignments for Overhead, Crews and Equipment. Although, we did support the Southwest Area in June, Alaska in July and the hurricane season in the Southern Area the months of August and September bringing resource mobilization up to approximately 75% of normal.

The 2004 fire season was the first to implement the "Neighborhood" concept with the Northern Rockies Geographical area. Agreements were written and agreed upon prior to the season, with the decision to implement the process, more on a trial basis. Primarily, Great Plains dealt with Miles City, but the North Dakota Center also used us to fill several orders for their grassland fires. The concept worked well, allowing us to mobilize resources in a quicker and more efficient manor. Since then, the Coordinating groups from the two Geographical areas have signed the agreements to make it an official document and process to be used in the future. Great Plains is currently exploring the opportunity to create a similar agreement with Region 8 and the Minnesota Dispatch Center.

Due to minimal snowfall amounts throughout the latter part of winter, the spring prescribed fire season was in full swing by mid March, especially through the month of April as precipitation remained normal to below normal. It appears the area had a productive and successful prescribed fire season, with 6 crew orders, 88 equipment orders and 124 Overhead orders being processed through GPC in support of prescribed fire.

2004 Air Operations Information

Rapid City Tanker Base for year 2004 flew one mission and pumped 2450 gallons.

Custer State Park SEAT Base for the State of South Dakota flew 2 SEATS this summer for a total of 127 missions and dropped 24,590 gallons of mixed retardant and 5,470 gallons of water and foam.

Standing Rock Agency for the Bureau of Indian Affairs flew 2 SEATS this summer for a total of 11 missions dropping 4,000 gallons of retardant and 1,400 gallons of water.

South Dakota National Guard flew 2 type 1 helicopters for 56 missions, dropping a total of 36,960 gallons.

The Black Hills Interagency Exclusive Use type 3 helicopter had 130.10 flight hours and dropped 34,695 gallons of retardant.

Pine Ridge Agency for the Bureau of Indian Affairs had air operations in 2004, however GPC has not received any information.

2004 Bureau of Land Management Information

As part of the annual operating plan between the Bureau of Land Management and the State of South Dakota, which covers the western half of South Dakota, all fire information and statistics for the Bureau of Land management is included in the State of South Dakota statistics.




