Grand Mesa, Uncompahgre and Gunnison NF Fire Refresher Schedule

Updated: 03/01/2022

Purpose: Complete the annual Wildland Fire Safety Training Annual Refresher (RT130) for every Red Carded individual on the forest, in a timely and consistent manner. RT-130 training focuses line-going personnel on fireline operations and decision-making issues in order to recognize and mitigate risk, maintain safe and effective practices, and reduce accidents.

Like last year these refreshers are open to everyone across the forest, you can attend any refresher. At the conclusion of each refresher the afternoon is reserved for the administration of the Work Capacity Test (WCT), these will be completed in person at each zone for each refresher. A practice fire shelter deployment will be conducted during each WCT.

****You must pre-register for both the RT130 and WCT, by contacting the P.O.C.**

****You need to have completed your HSQ prior to taking the WCT.**
