



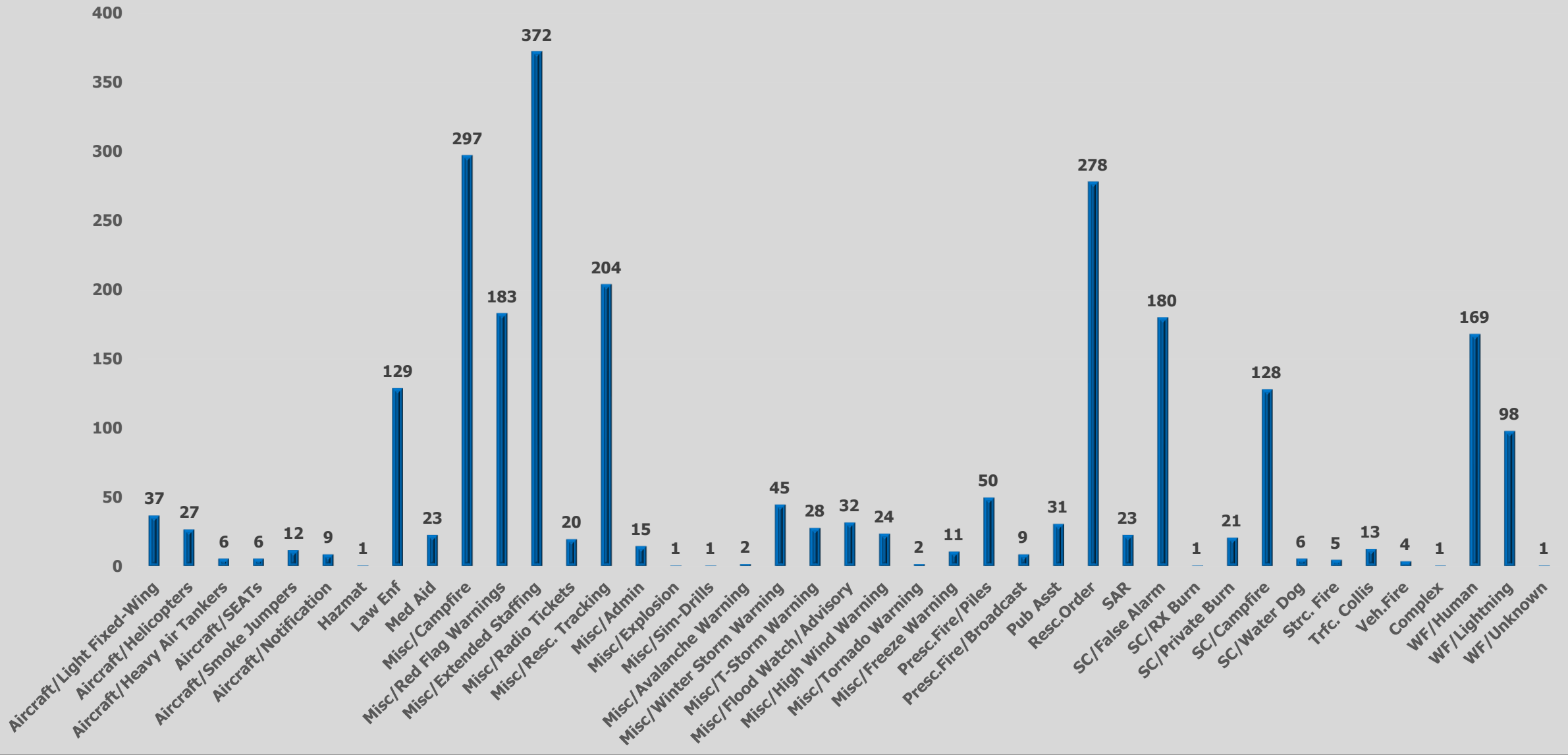

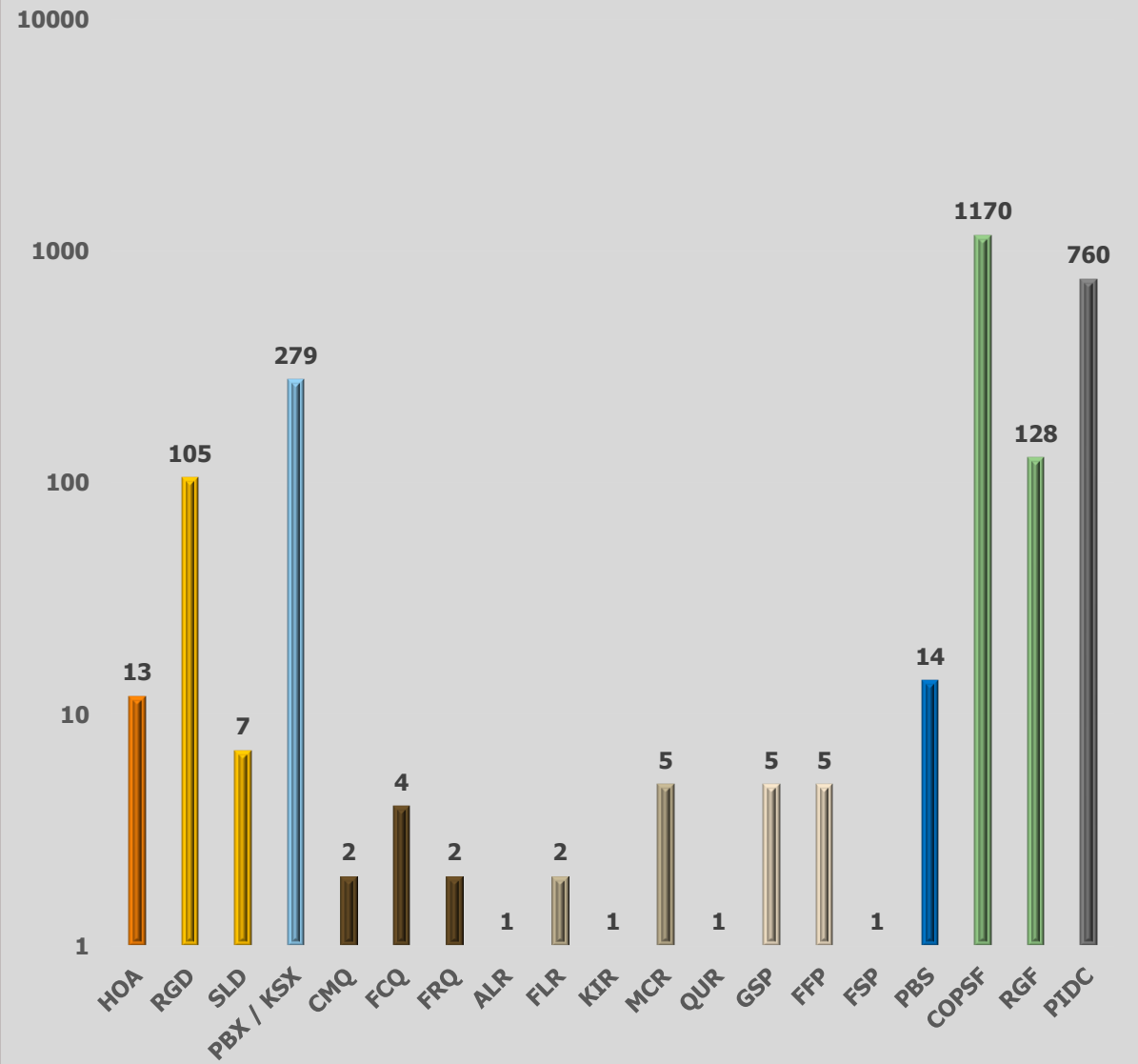
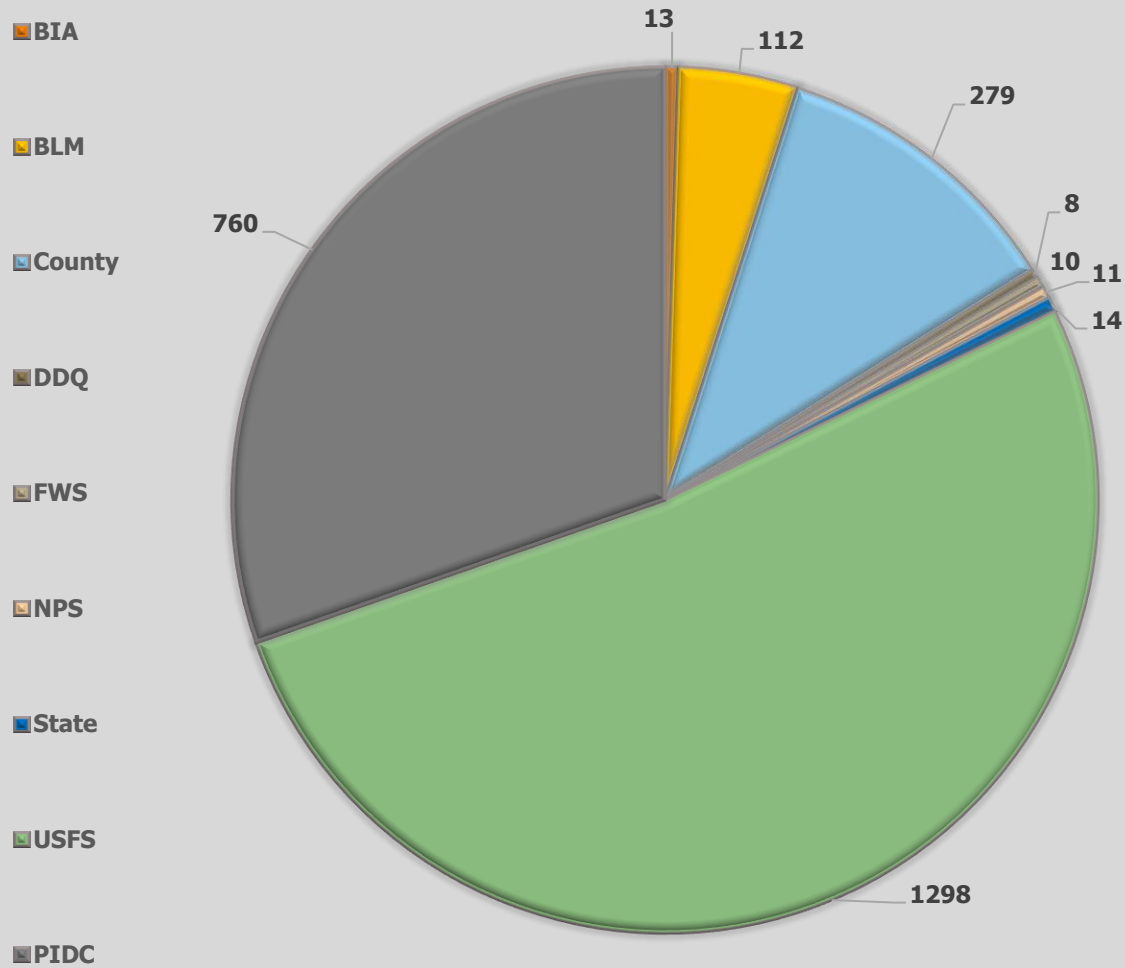
Narrative

- 2020 a year of resilience, adaptation and organization. With the outbreak of COVID 19 fire organizations were tasks to develop and implement new safe business practices in Wildland Fire Response, in order to safely and effectively combat wildland fires, with the management of incidents and the mobilization of resources. In addition, dispatch centers were challenged with several new national programs that were pushed out before ready causing additional work and frustration.
- Continual drought conditions were experienced throughout the zone and high elevation A typical drought conditions were seen in Colorado. Aggressive initial attack and request for additional resources attributed to the success of keeping wildland fires to type 3 organizations. The zone hosted 11 Type 3 Teams and 39 incidents requiring ICS 209. A total of 264 fires occurred within the zone for 70,323 acres. Burrows Draw the year's first fire was discovered Jan 8th, on the Comanche National Grasslands (924 acres). The largest fire, Cherry Canyon discovered in Las Animas County May 20th (11,818 acres).
- Pueblo Interagency Dispatch brought in a total of 73 dispatchers throughout the season to support activity. The Center processed a total of process a total of 2,747 resource orders supporting in zone and out of area incidents. Due to COVID an inhouse expanded dispatch was not considered. In April, the starting of a Virtual Expanded Dispatch program was developed. The plan was to keep people on long term to support the zone and additional centers within the Region with large fire pre-orders if requested. PIDC Dispatch ordered a total of 7 dispatchers for 6 months along with providing successful support to agencies within the zone, they successfully assisted two centers and three IMT mobilization's pre-orders and numerous. The center was recognized having one of the first virtual expanded dispatches in the natation.
- This was the first year that PIDC was fully staffed with permanent positions. Claire Brown was hired as an initial attack dispatcher - 13/13 (GS 5,6,7) and Whitney Wallet a 13/13 (GS 5,6,7) was hired as an initial attack dispatcher and lead dispatcher in a Job Corp Dispatch Program hosted at Pueblo Dispatch Center. Students enrolled in a dispatch program through Job Corp will train at PIDC working towards their IADP and EDRC qualifications

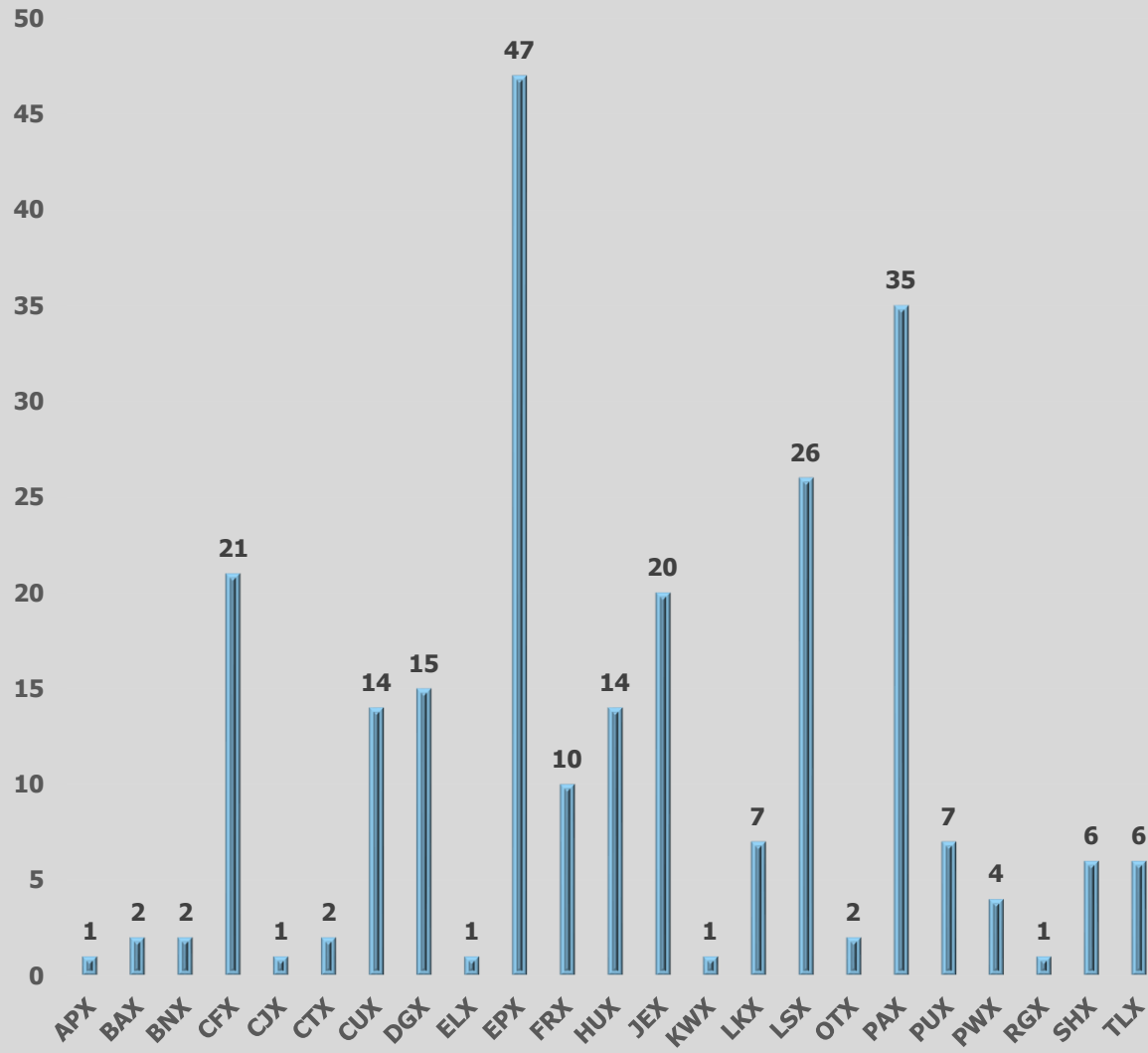


Incidents by Agency

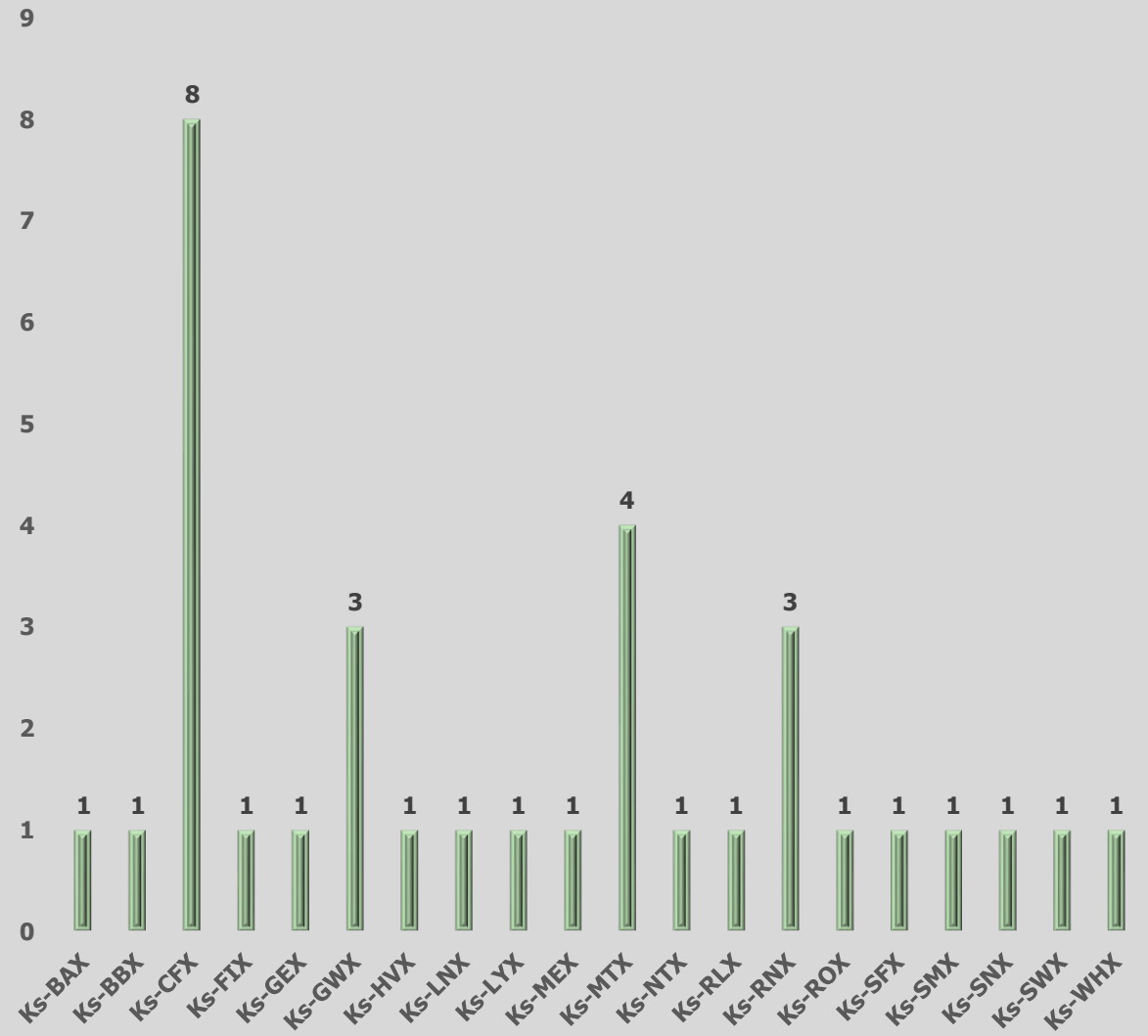


Incidents by County: 279

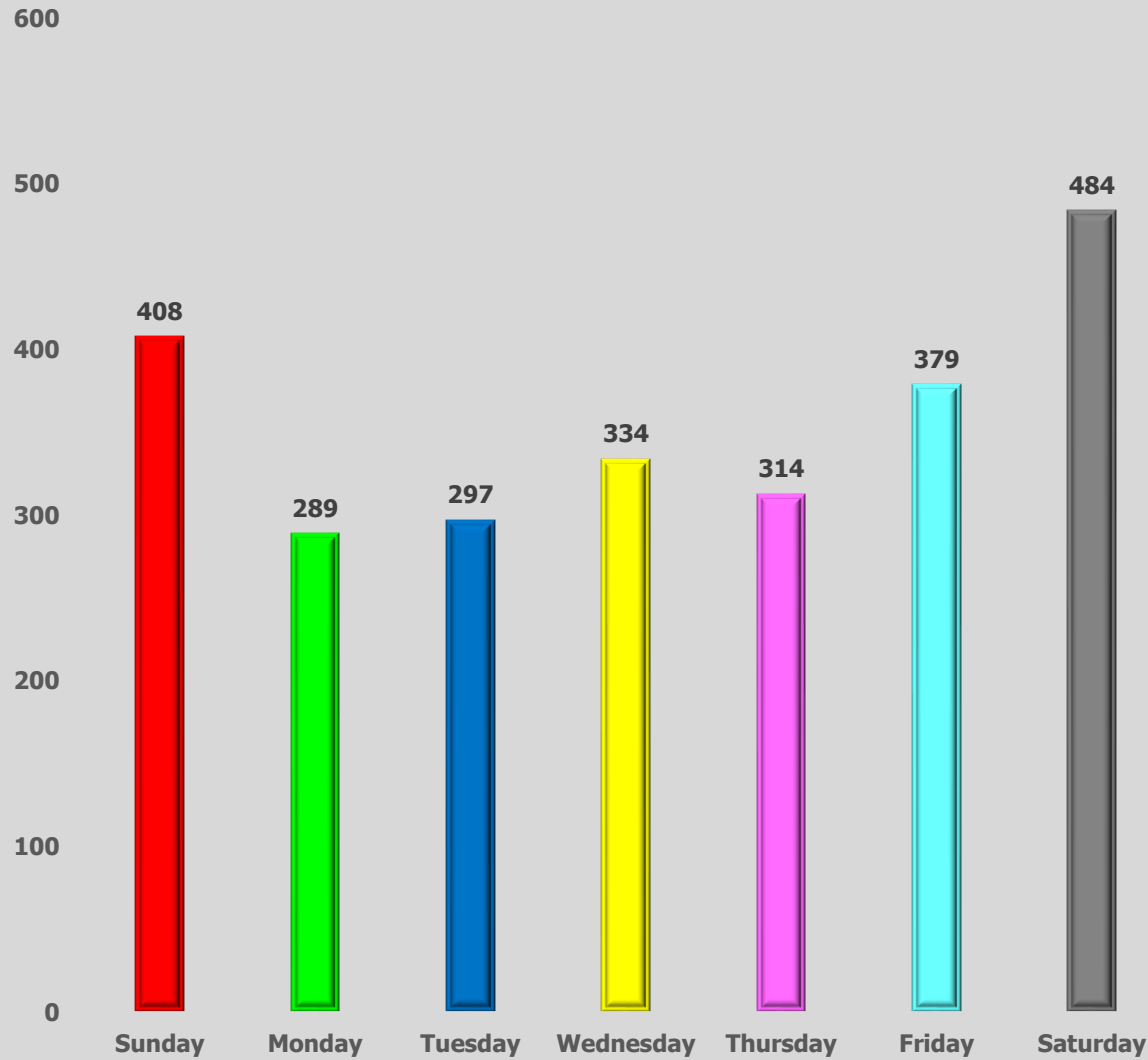

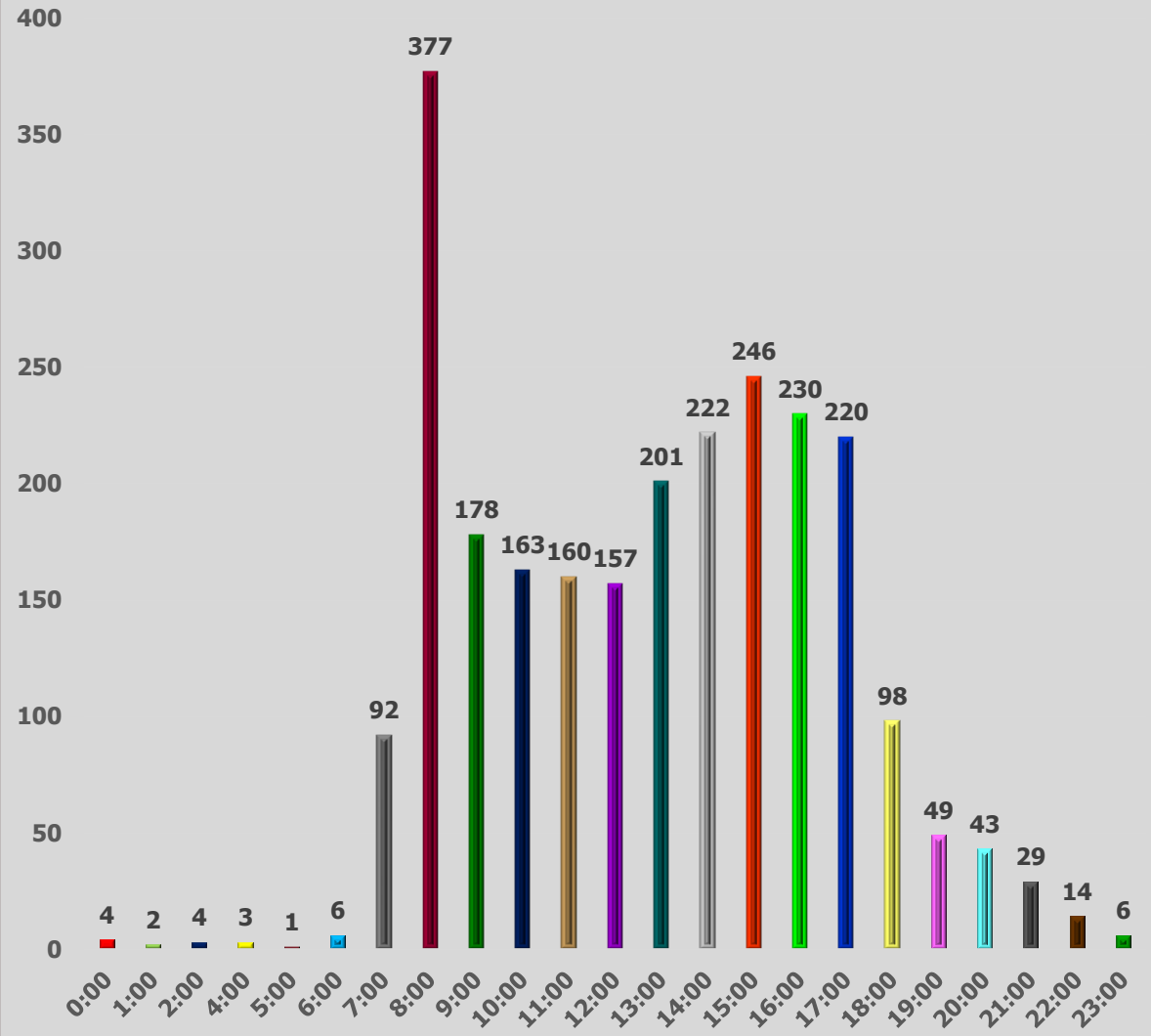


Incidents by Day / Hours

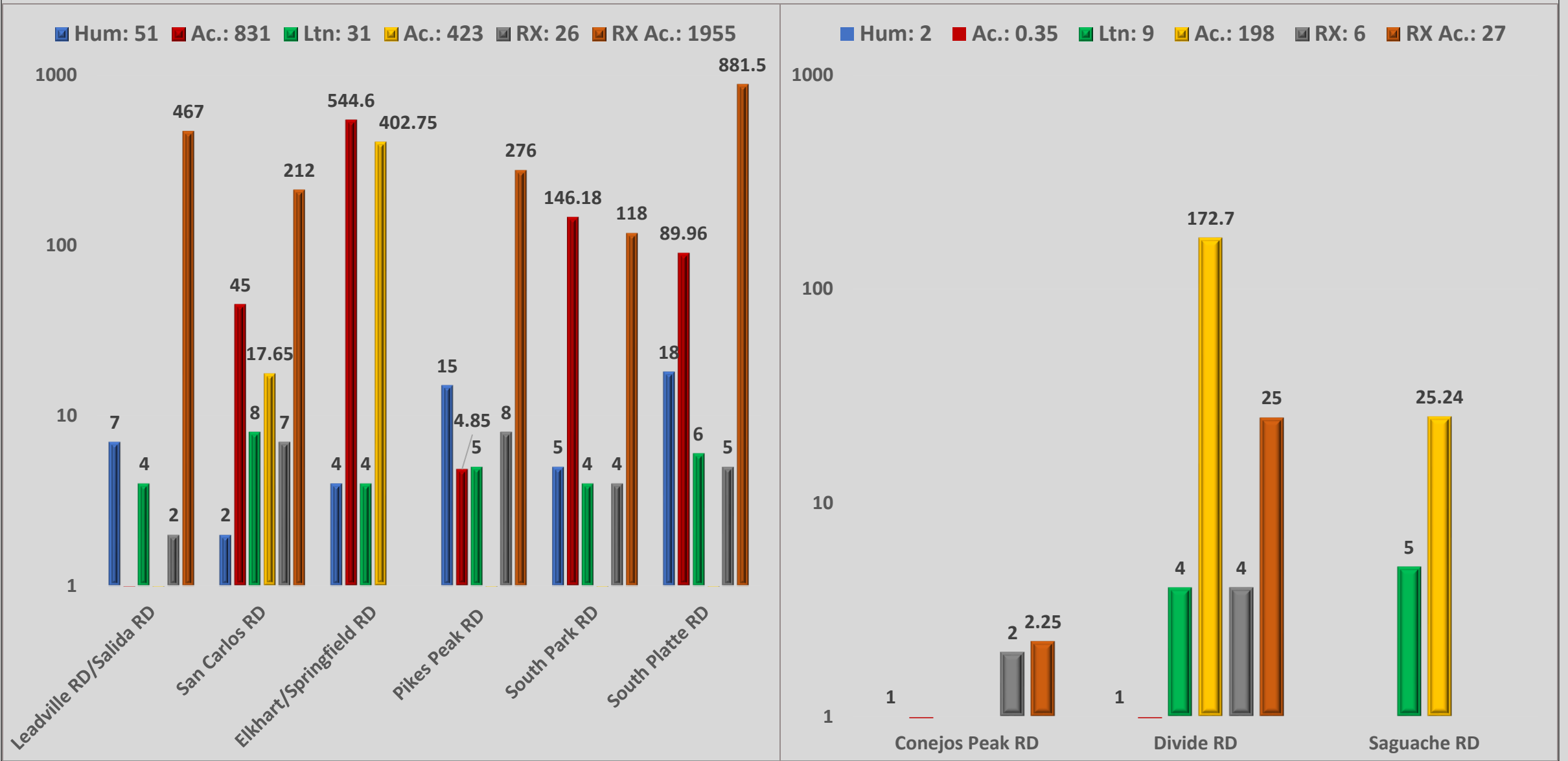


Fire and Acres by Agency

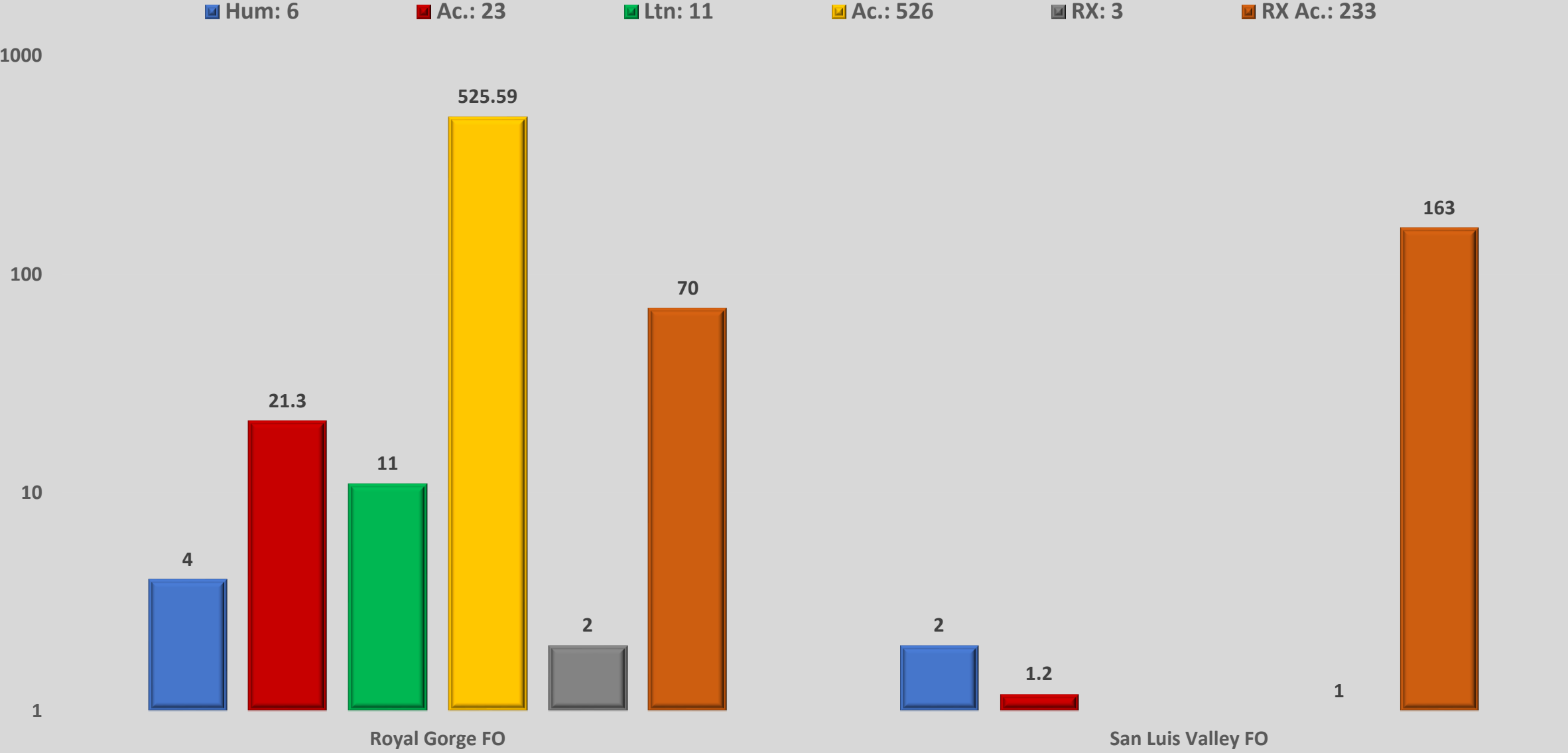

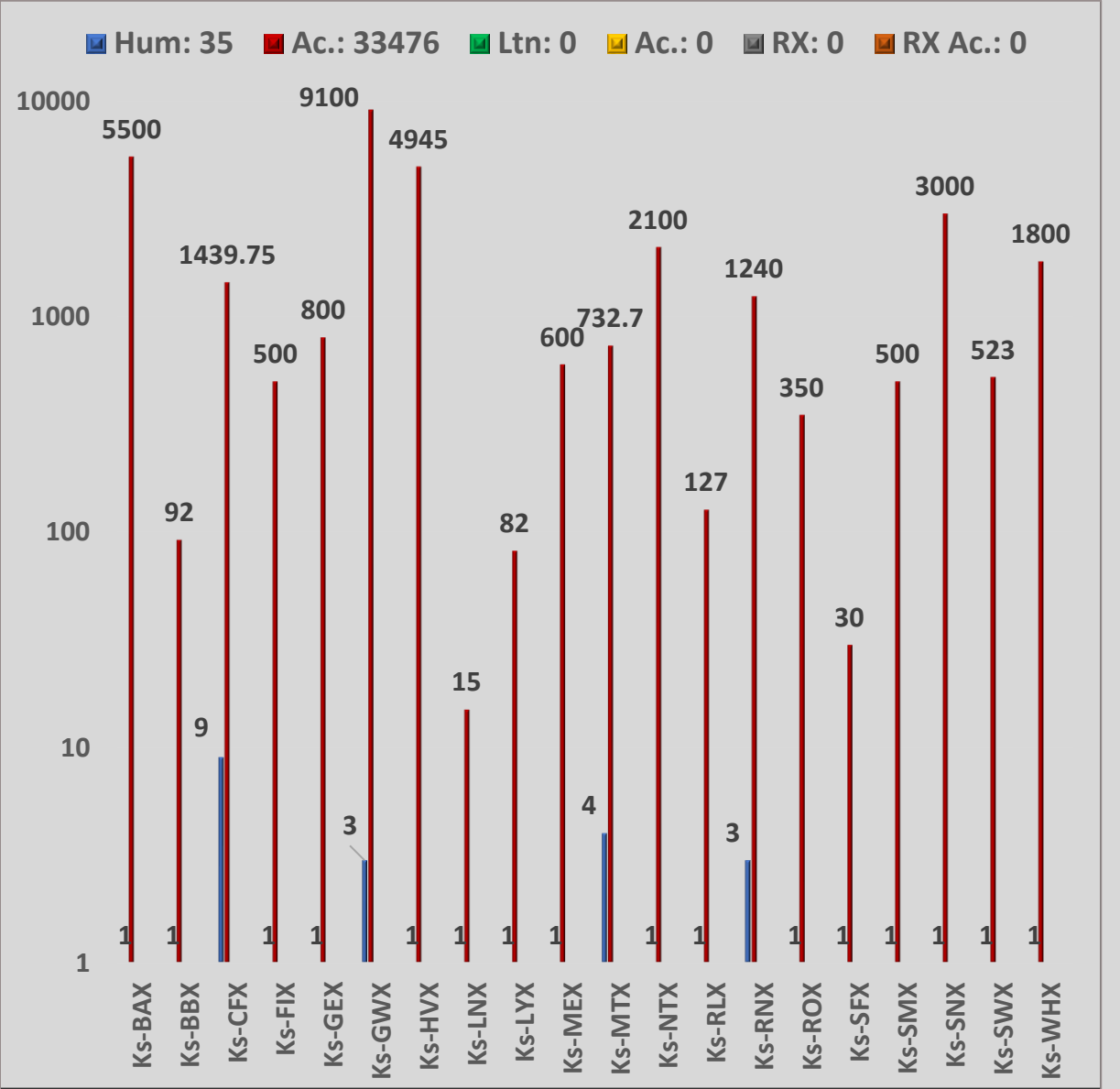
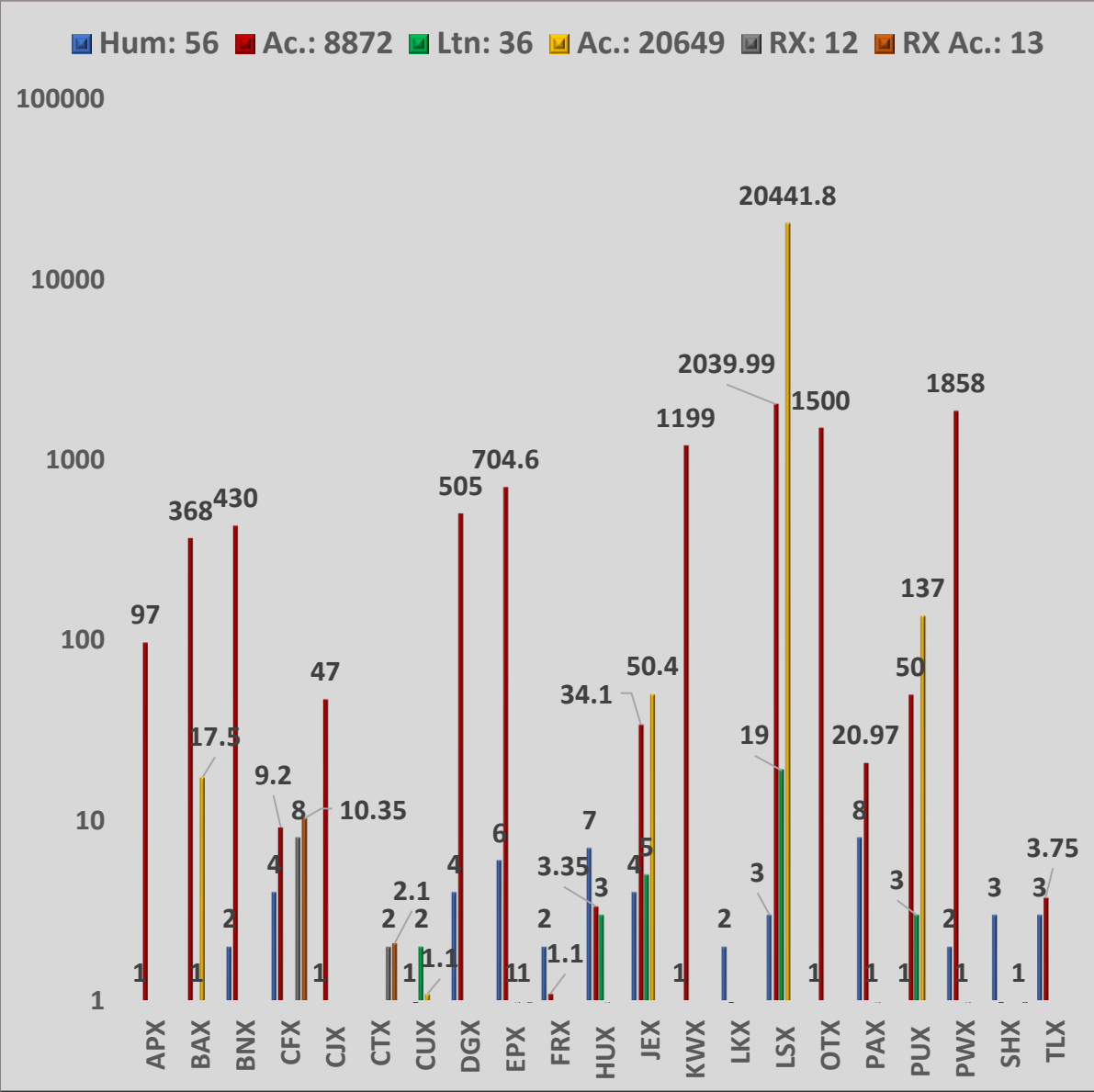
PSICC / RGF Fire & Acres

Colorado / Kansas Counties Fire & Acres

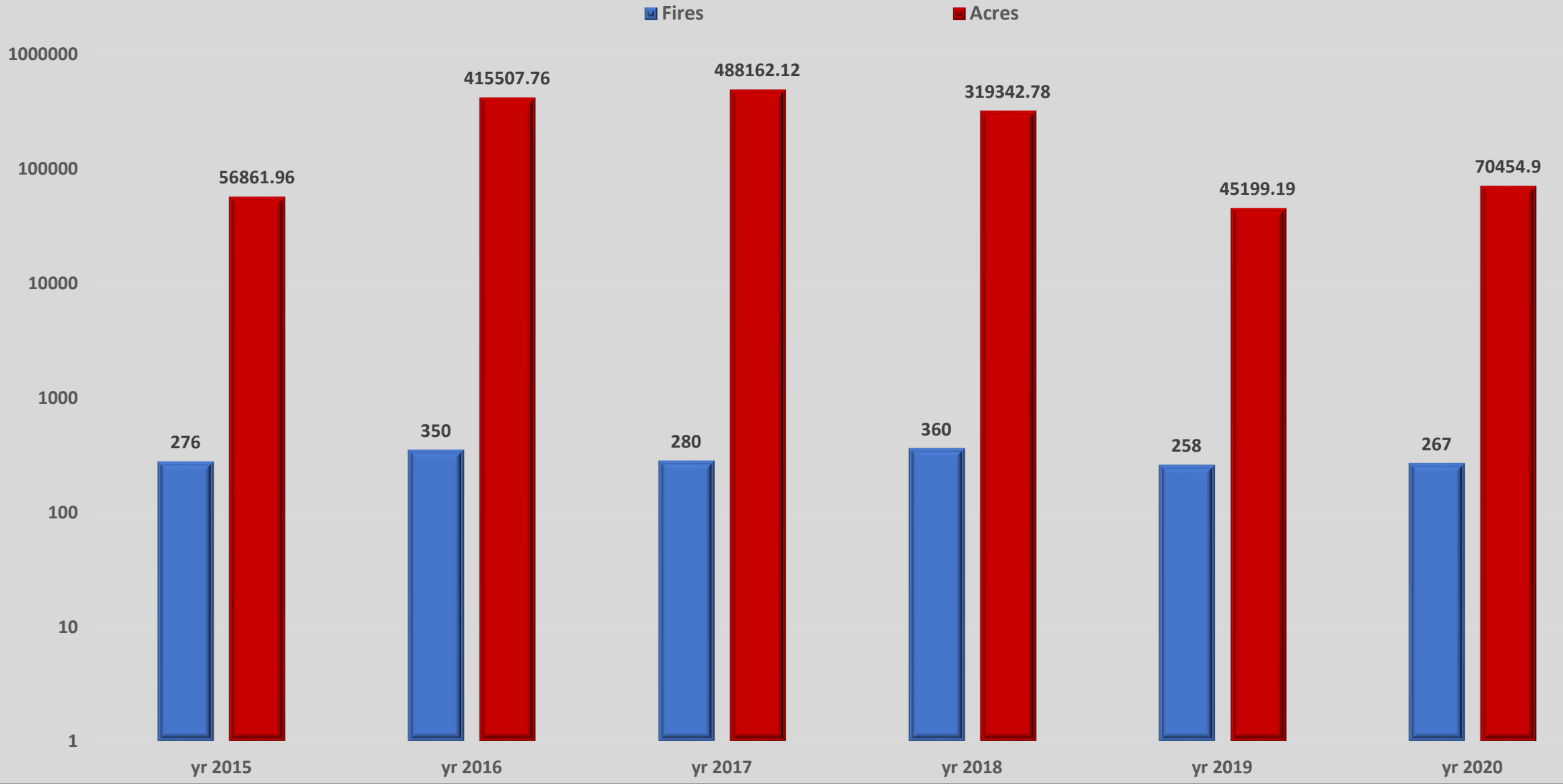


Fire & Acres by Month

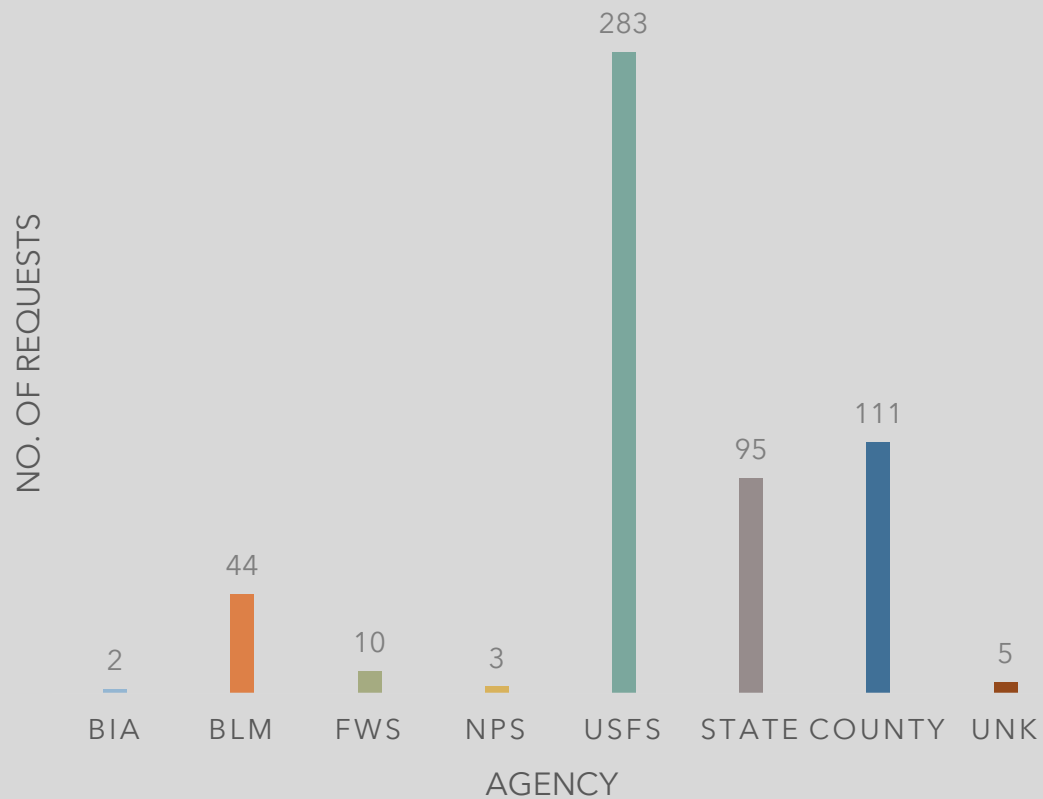

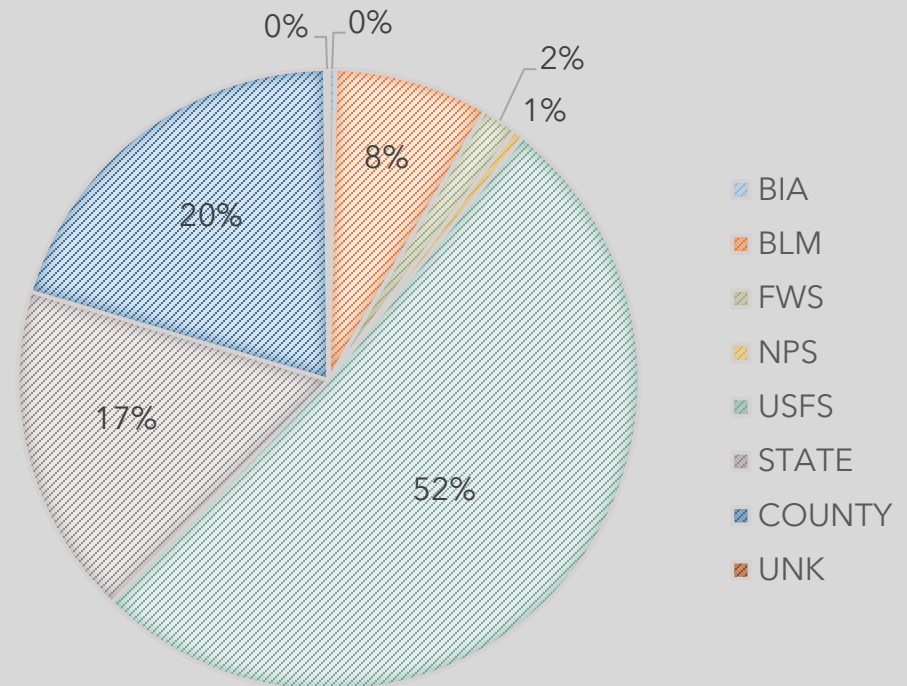


Overhead In-Zone: 50 Incidents, 572 Total Requests

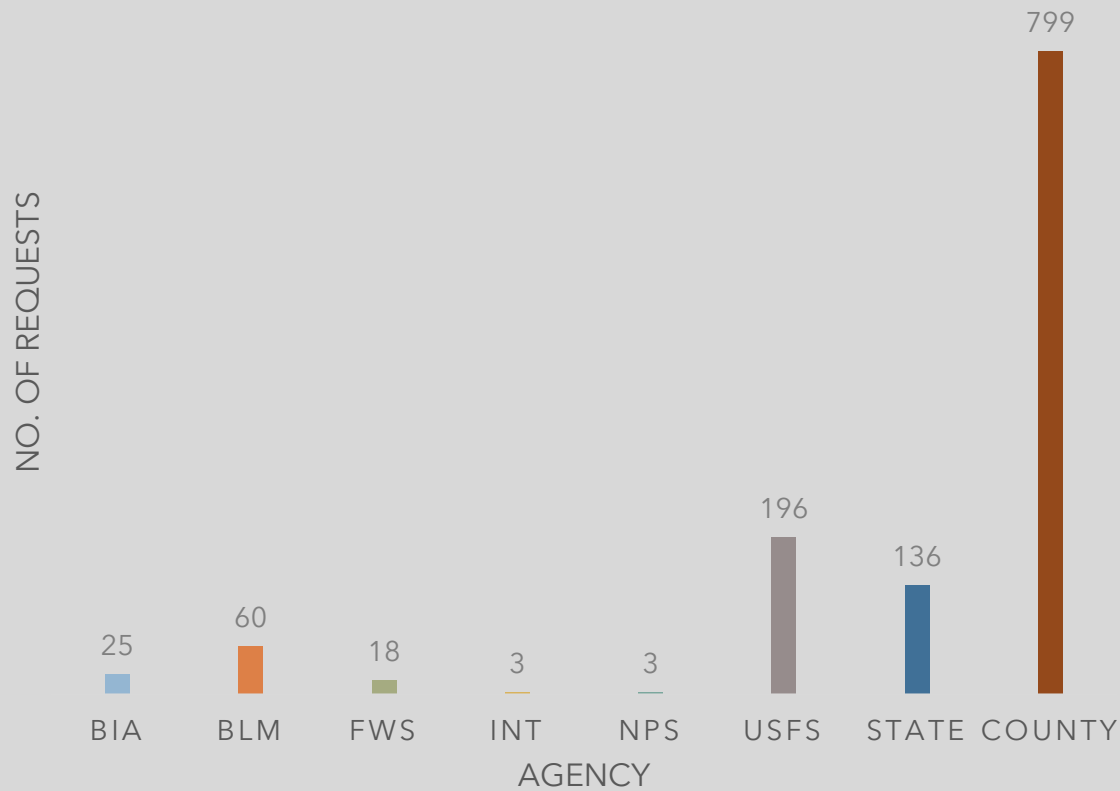

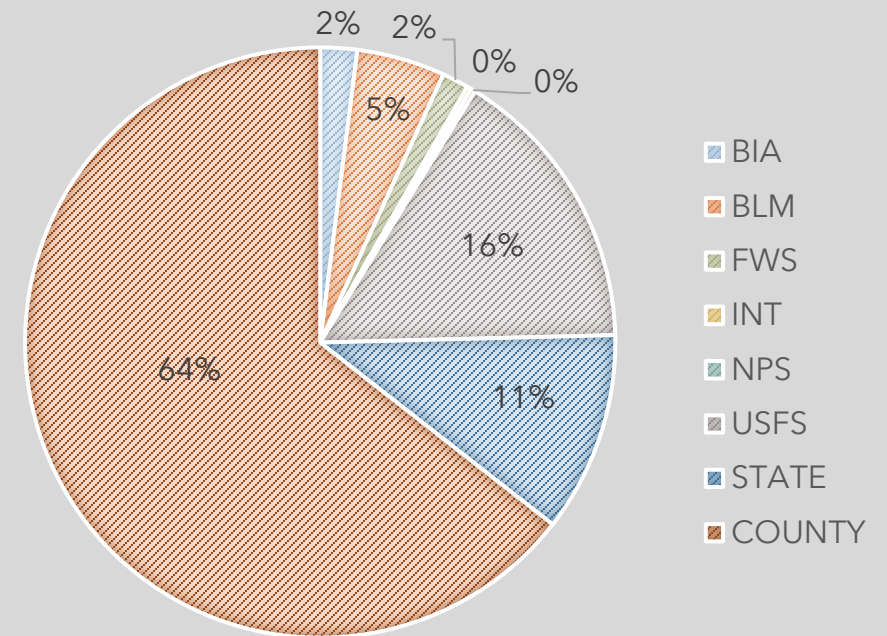


Overhead Out-of-Zone: 244 Incidents, 1,240 Total Requests

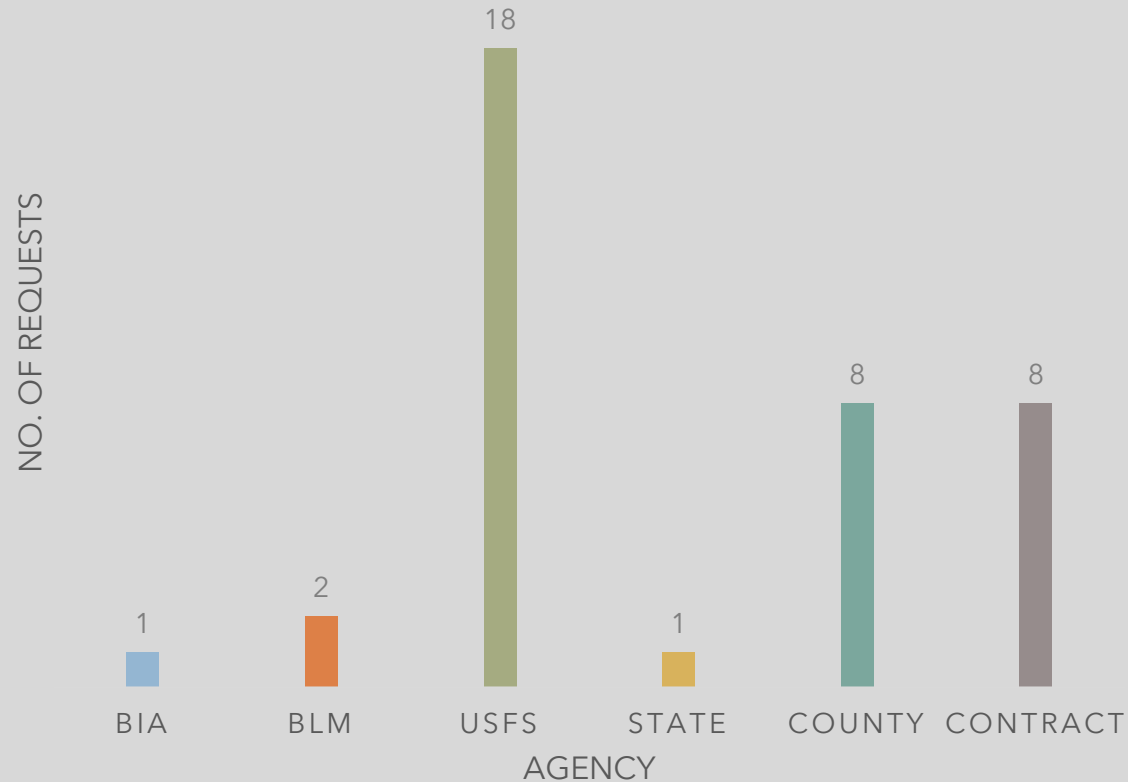

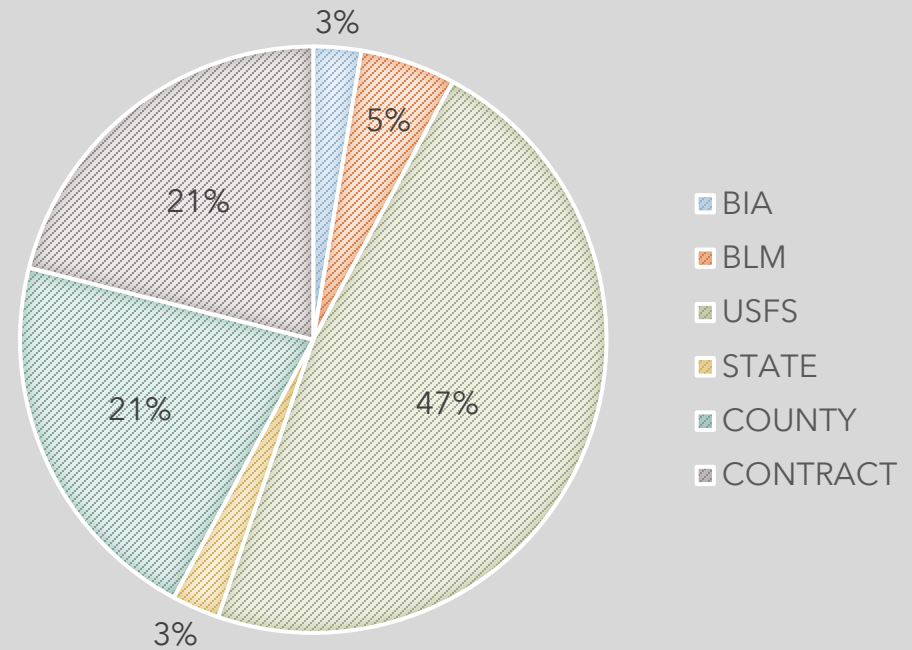


Crews In-Zone: 19 Incidents, 38 Total Requests

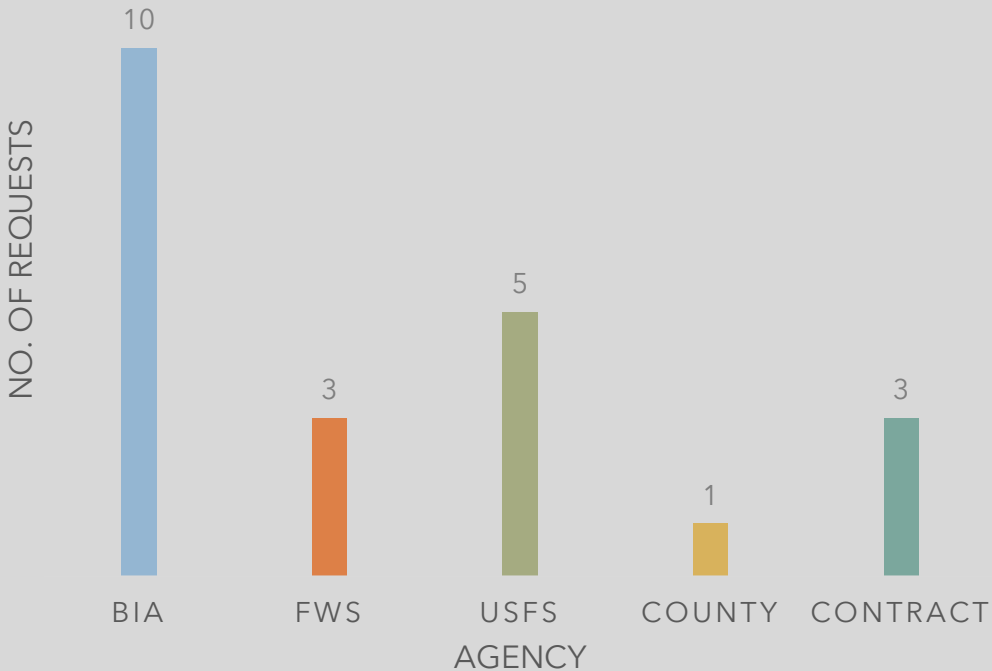

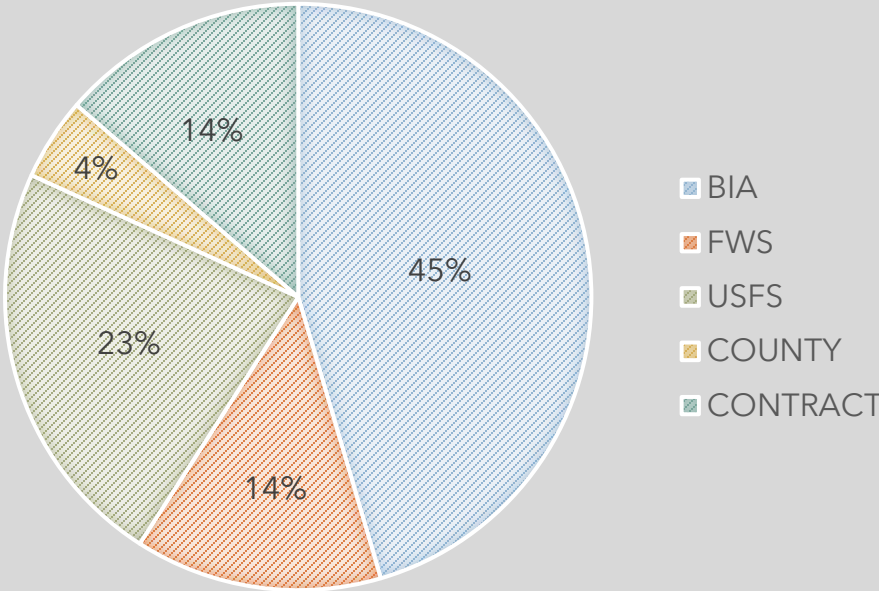


Crews Out-of-Zone: 9 Incidents, 22 Requests

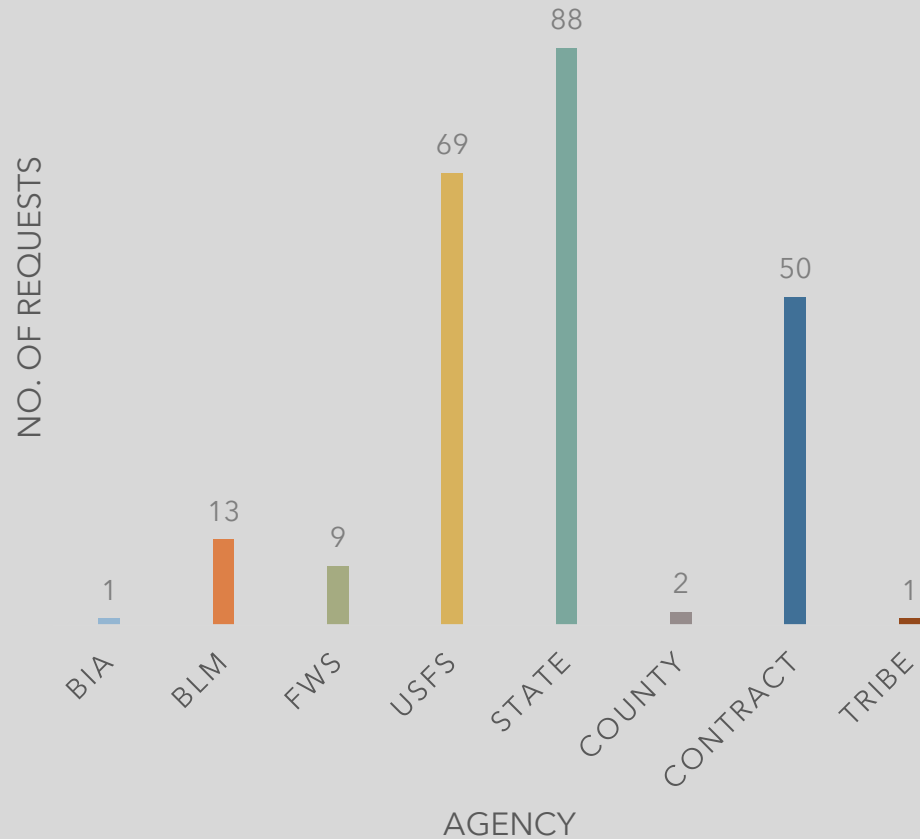

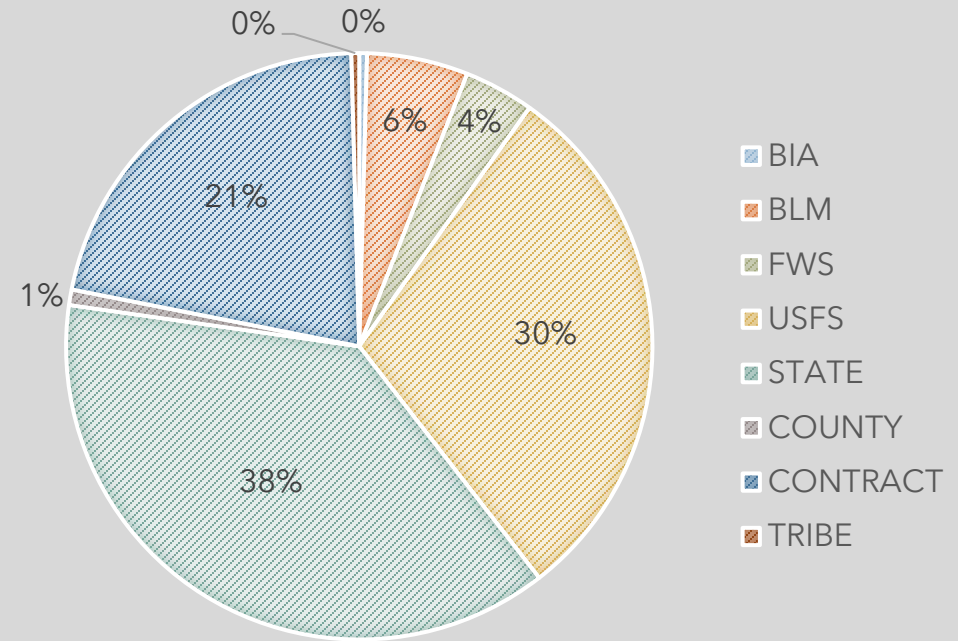


Equipment In-Zone: 33 Incidents, 231 Total Requests

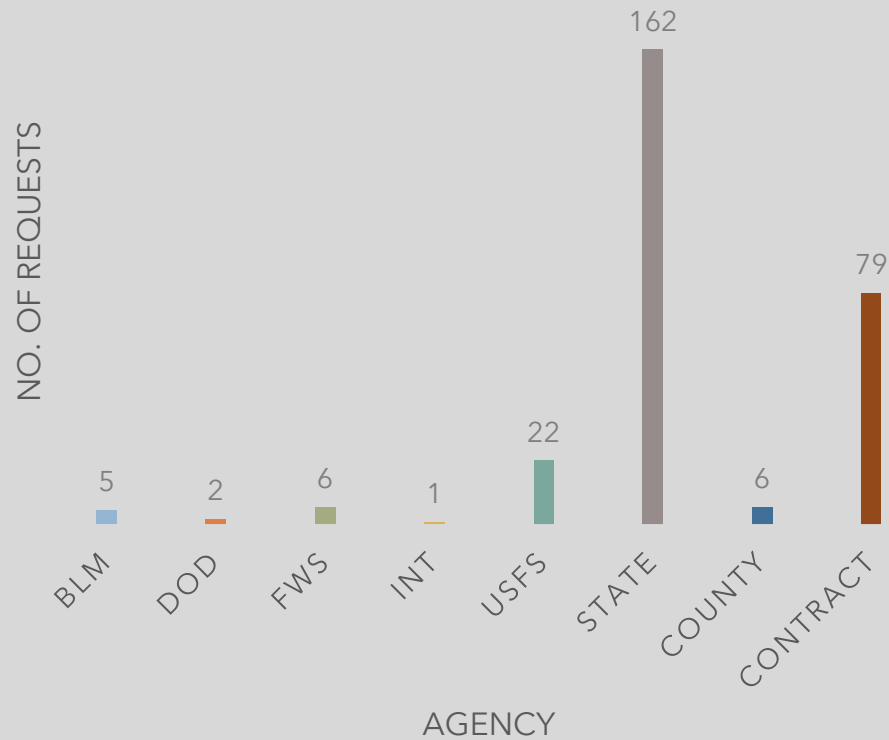

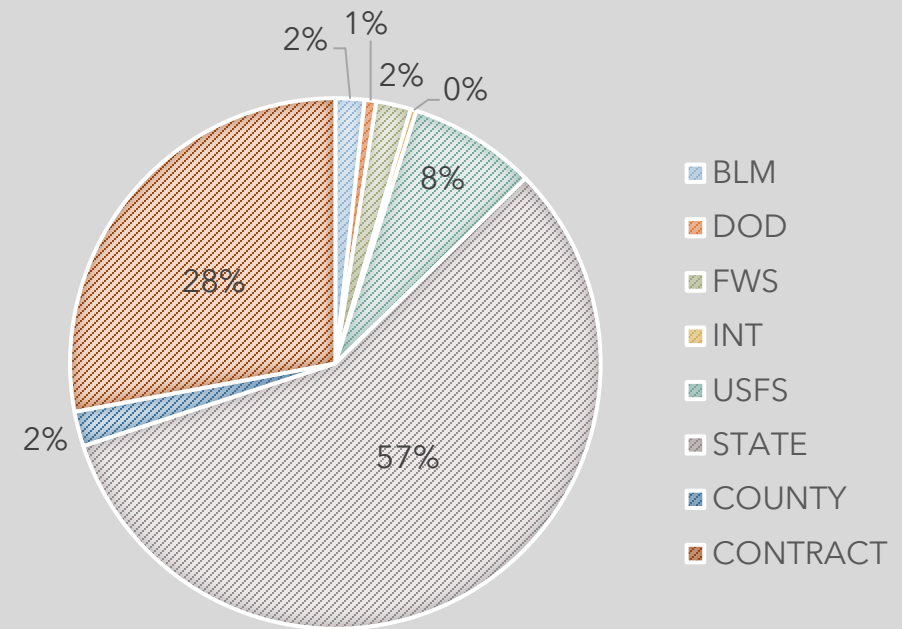


Equipment Out-of-Zone: 131 Incidents, 283 Total Requests

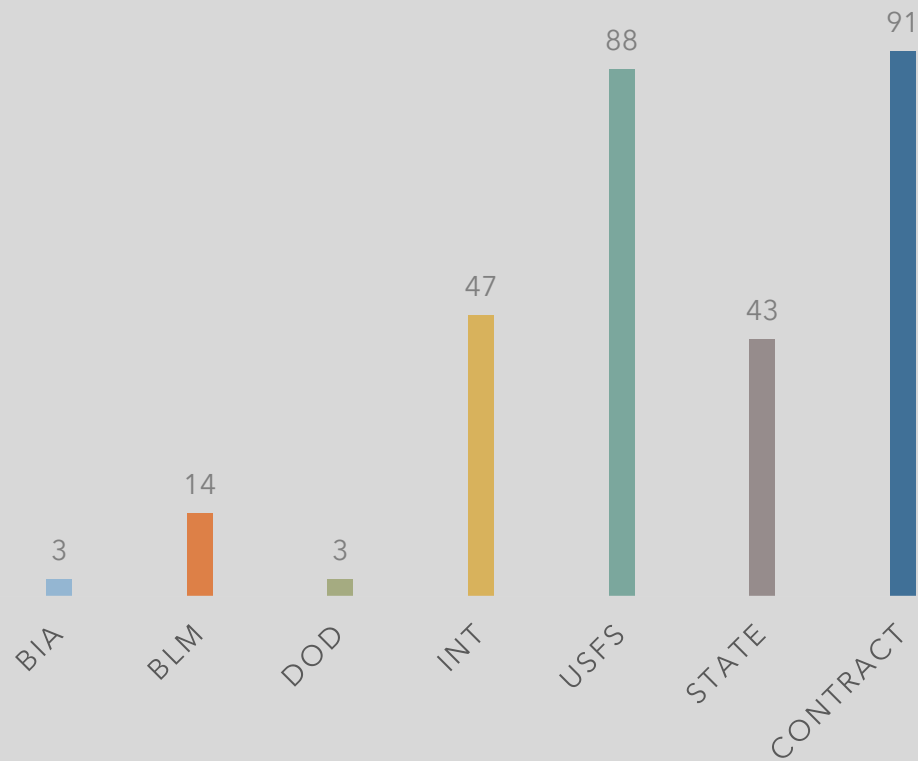

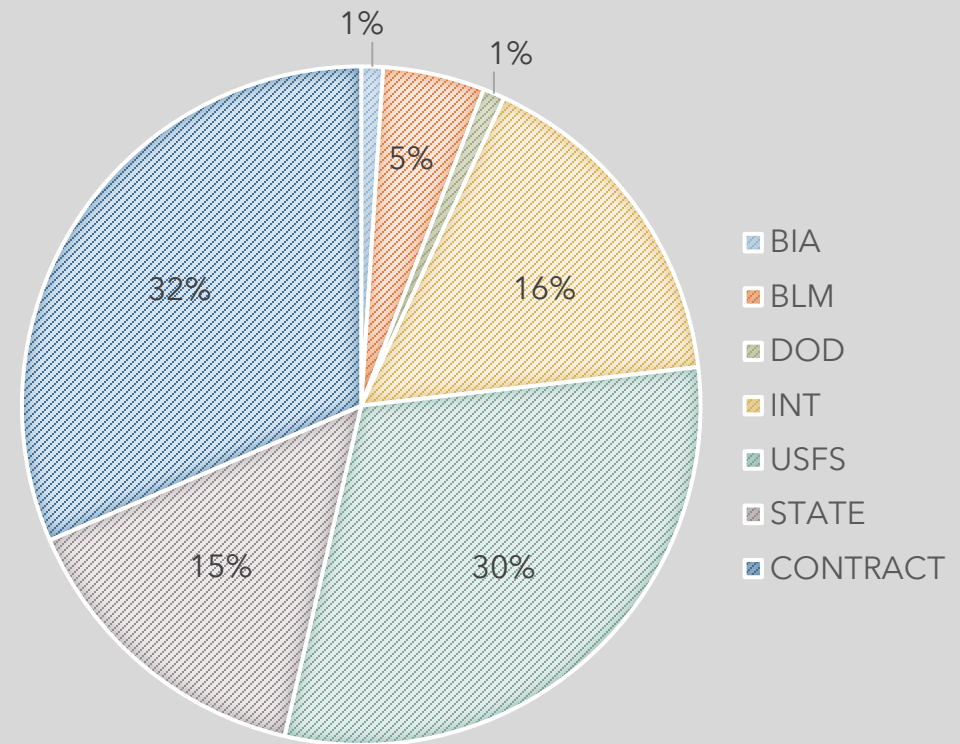


Aircraft In Zone: 40 Incidents, 289 Total Requests

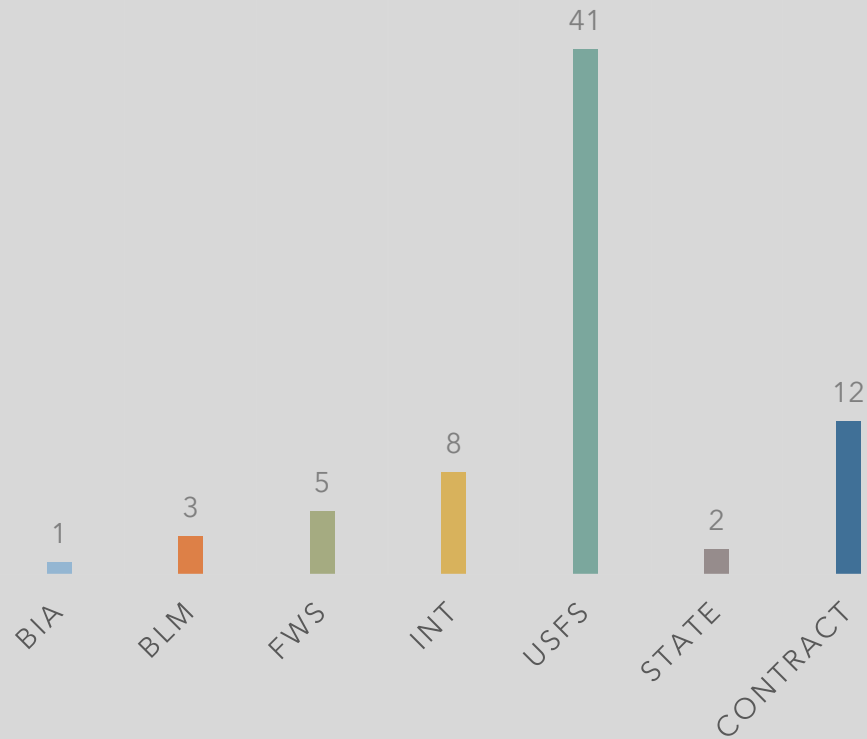

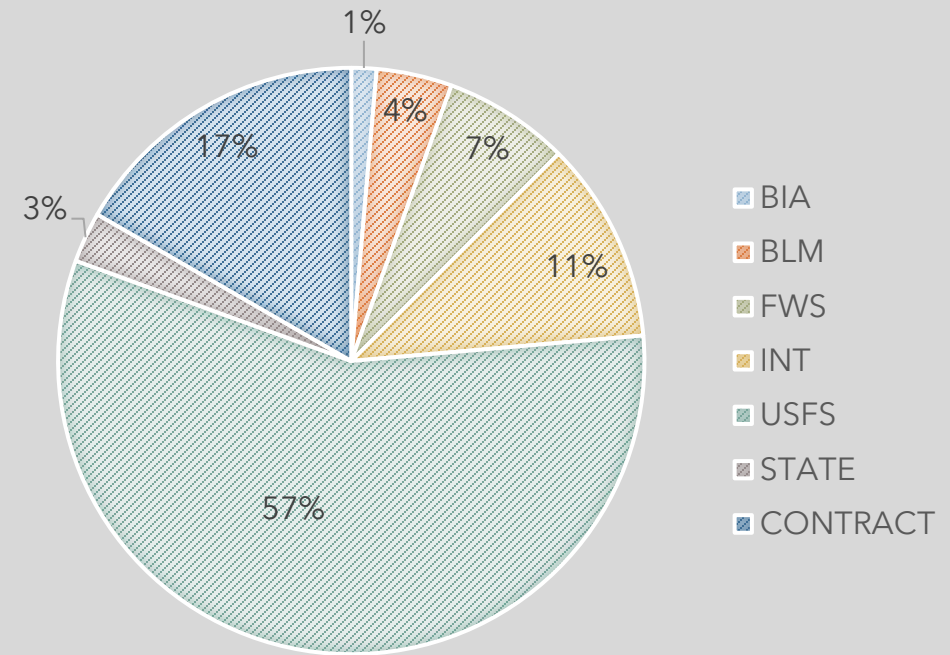


Aircraft Out of Zone: 48 Incidents, 72 Total Requests

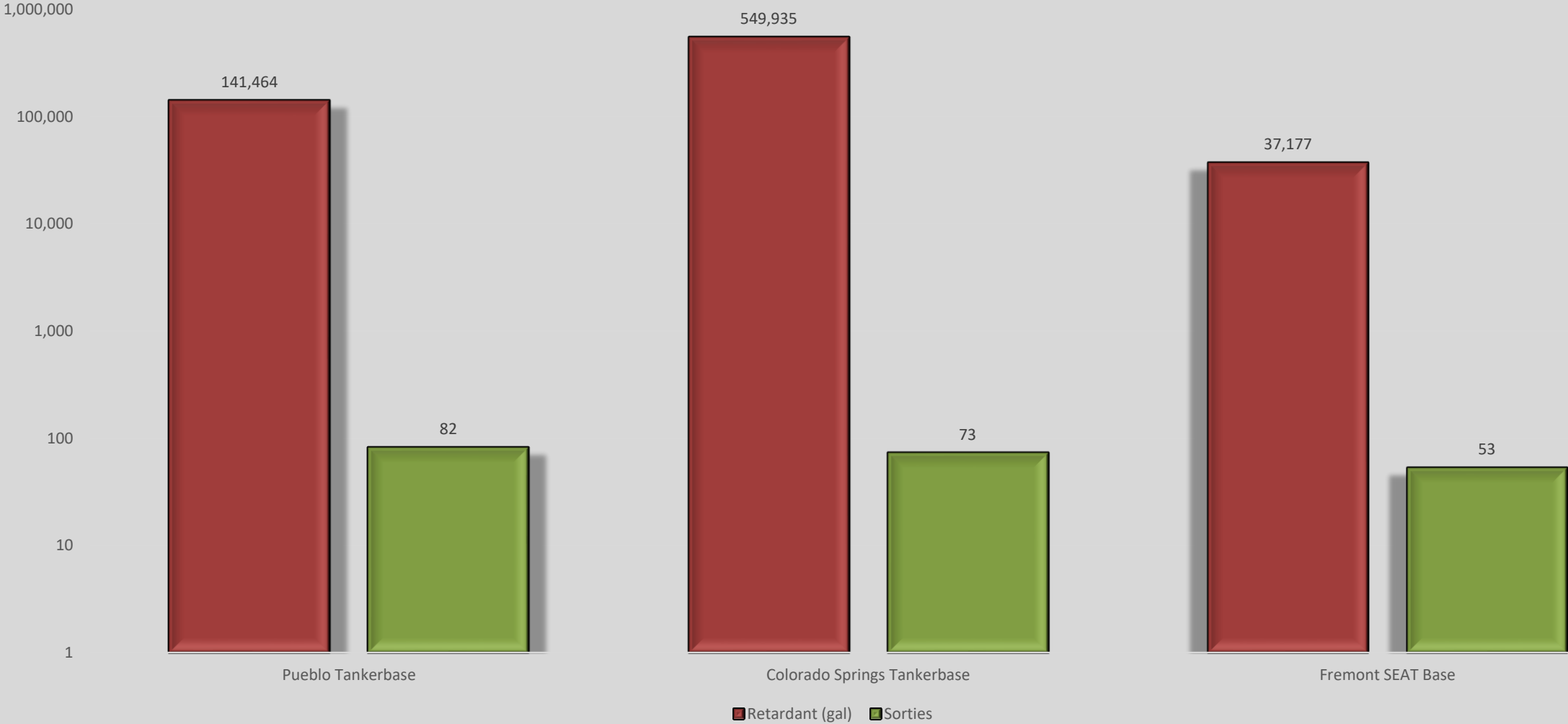

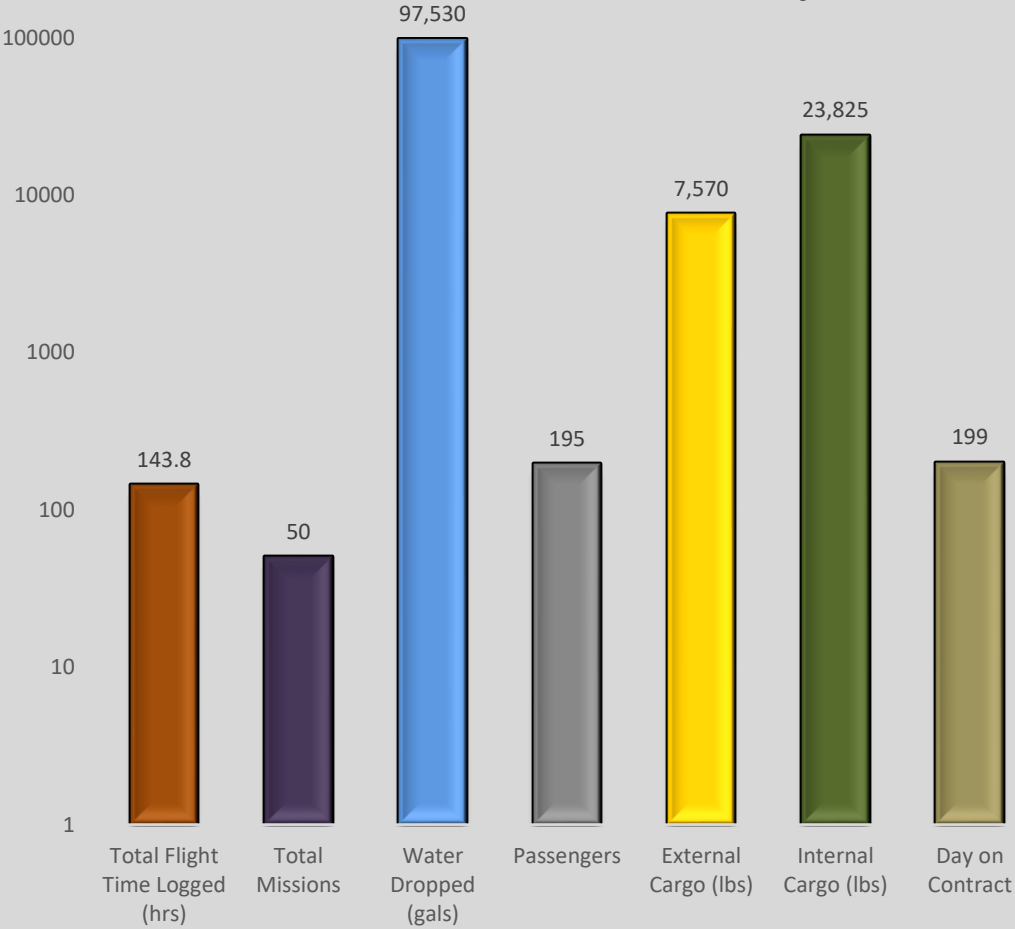


Tanker / SEAT Base Totals

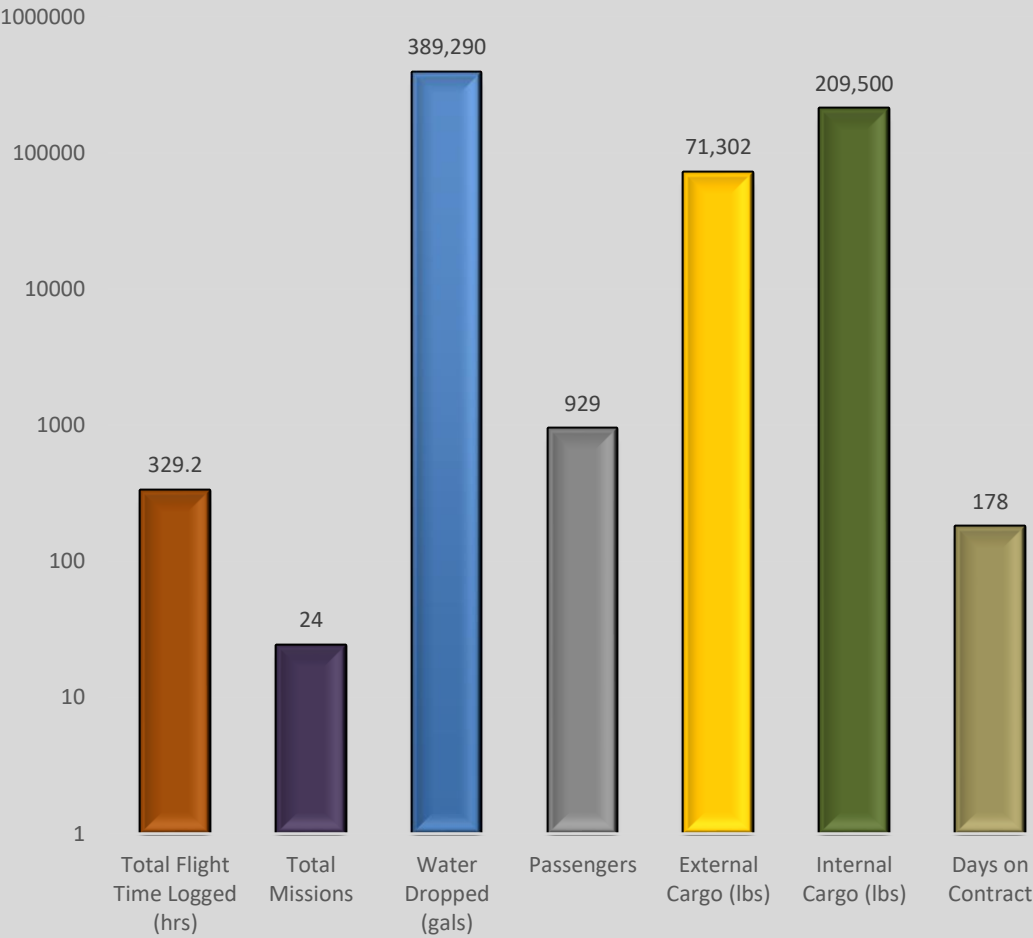


EU Contracted Helicopters

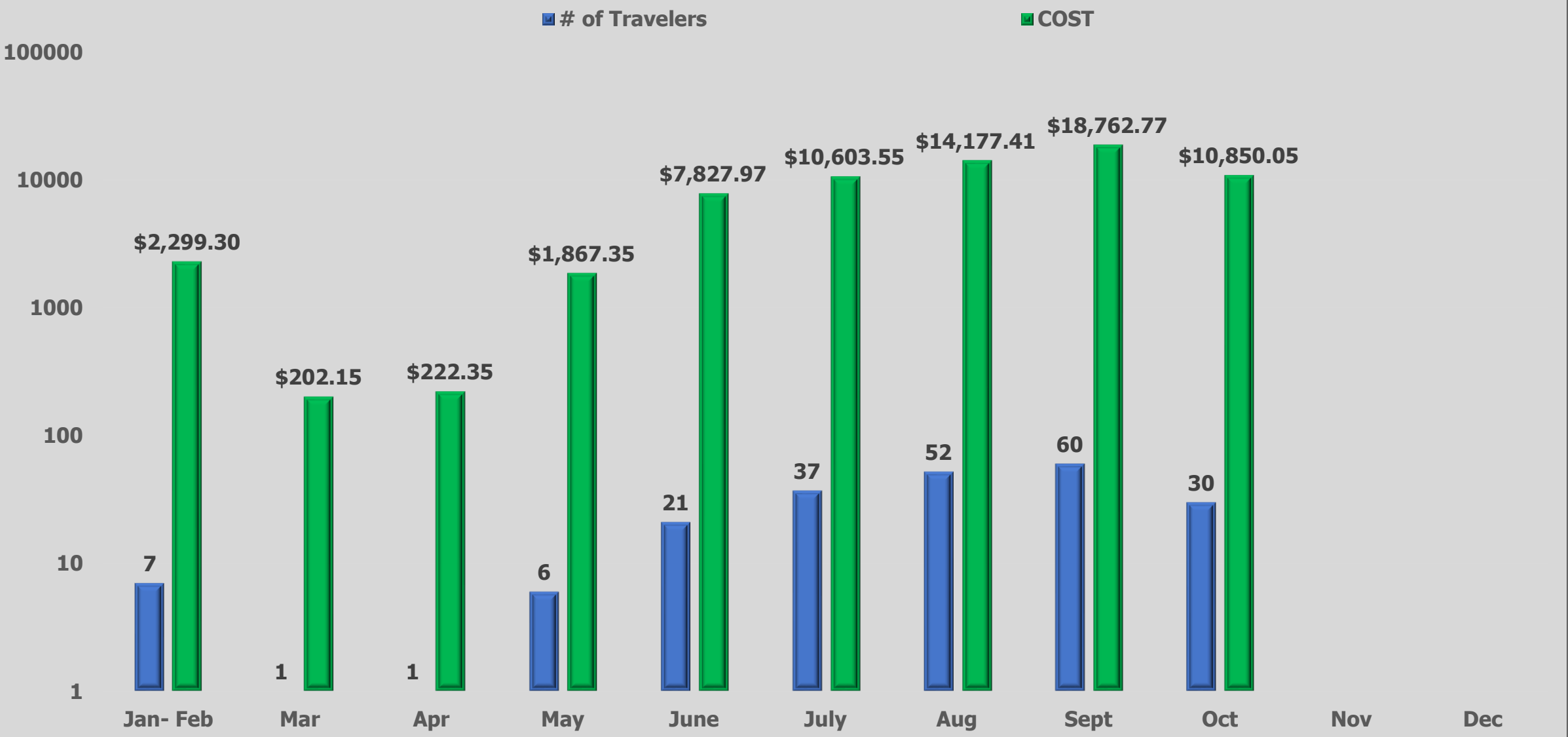
