


Narrative

- The 2023 season for Pueblo Interagency Dispatch Center saw 197 fires for 29,678.16 acres this was the second lowest season in the past five season of fires within the zone. The first large fire was in the state of Kansas on March 4th of 2023 for 350 acres. The zone saw 2 CIMT (Complex Incident Management Teams) this past season. The first CIMT was in late June of 2023 on the Titan fire in Las Animas County, CO. This fire was contained at 928 acres had the CIMT #1 on it for seven to eight days. The second CIMT was in mid-October of 2023 the Saint Charles fire in Pueblo County. This fire was contained to 492 acres on the San Carlos Ranger District. The fire was a lightning caused that was found approx. two weeks after the tree was struck. It was still showing heat after an October snowstorm and is still currently open moving into the 2024 season.
- This past year the dispatch center saw some changes with staff. The center is happy to announce the integration of three Colorado Division of Fire Prevention and Control employees: two Dispatchers and one Resource Specialist. DFPC Lead Dispatcher Brian Mockmore, DFPC Dispatcher Elizabeth Peterson and Resource Specialist Savannah Greasby. These three came on board in May of 2023 and have become an integral part of the Center. In addition to the staff from the State of Colorado, the Forest Service was able to also hire another IA dispatcher lan Keegan. The PSF also was able to fill Lyndsey Wolgram in behind the retired Assistant Center Manager. This brought the staff in the center from six to nine staff, and moving into 2024 we are looking at three more staff members being added to the org. This will include a Deputy Center Manager from the State of Colorado and two more Forest Service IA Dispatchers. In total the center will have 12-13 resources. PIDC has not been this fully staffed since the early part of the 2000's.


Incidents By Type: 1,860




Incidents By Agency:1,860




Incidents by Day / hours









5 Year Average of Incidents: 2,083




Fires & Acres by Agency








BLM Fires & Acres




County Fires and Acres







Fires & Acres by Month






Overhead In Zone: 2403 for 57 Incidents




Overhead Out of Zone: 2,116 for 264 Incidents





Crews In Zone: 61 for 22 Incidents







Crews Out of Zone: 31 for 18 Incidents







Equipment In Zone: 355 for 25 Incidents






Equipment Out of Zone: 151 for 52 Incidents







Aircraft In Zone: 208 for 32 Incidents




Aircraft Out of Zone: 49 for 18 Incidents




